REPORT BY THE DIRECTOR-GENERAL**ANNUAL REPORT ON THE COMPOSITION OF THE TECHNICAL SECRETARIAT****Introduction**

1. The Executive Council (hereinafter “the Council”) at its Sixty-Second Session (EC-62/DEC.4, dated 6 October 2010) decided to request the Director-General to provide an annual report on the composition of the Technical Secretariat (hereinafter “the Secretariat”), with the first such report to be submitted to the Council for consideration at its Sixty-Fifth Session (EC-65/DG.6, dated 22 June 2011 and Corr.1, dated 13 July 2011).
2. The twelfth annual report on the composition of the Secretariat is hereby submitted to the Council for its consideration. The information is broken down into five tables, as requested by the Council. The report on the composition of the Secretariat will be submitted annually to the Council, in accordance with EC-62/DEC.4.

General human resources and recruitment policy

3. As stated in paragraph 44 of Article VIII of the Chemical Weapons Convention (hereinafter “the Convention”):

“The Director-General shall be responsible to the Conference and the Executive Council for the appointment of the staff and the organization and functioning of the Technical Secretariat. The paramount consideration in the employment of the staff and in the determination of the conditions of service shall be the necessity of securing the highest standards of efficiency, competence and integrity. Only citizens of States Parties shall serve as the Director-General, as inspectors or as other members of the professional and clerical staff. Due regard shall be paid to the importance of recruiting the staff on as wide a geographical basis as possible. Recruitment shall be guided by the principle that the staff shall be kept to a minimum necessary for the proper discharge of the responsibilities of the Technical Secretariat.”

4. The appointment of staff through the OPCW recruitment and selection process in the Secretariat reflects the faithful implementation of paragraph 44 of Article VIII of the Convention, and the Staff Regulations. The Staff Regulations, as decided by the Conference of the States Parties, further stipulate the need to take into account considerations of gender balance in the OPCW recruitment process. Turnover of personnel in the Secretariat is



dynamic, as new vacancies are continuously generated through natural attrition, including resignations and retirements, and through the implementation of the OPCW tenure policy.

5. Vacancy notices open for recruitment are posted on the OPCW intranet and internet websites for internal and external recruitment, as well as proactively on various social media platforms. The purpose of the vacancy notice is to publicly and openly announce the availability of a post at the OPCW and to solicit applications from candidates. At its level and within its resources and mandate, the Secretariat consistently endeavours to increase the number of qualified applicants from OPCW Member States.
6. Interested applicants must respond to a specific vacancy notice by submitting an OPCW candidate application form online, duly completed in accordance with the information provided in the vacancy notice, to the OPCW before the deadline for the receipt of applications.
7. Applications that meet the minimum required criteria specified in the vacancy notice are reviewed and assessed by a diverse selection recommendation panel. The panel is comprised of Secretariat staff charged with providing to the appointing official a list of recommended candidates to be considered for appointment. The assessment and selection of candidates are made on a transparent and competitive basis.
8. Appointments for posts in the professional and higher categories are made by the Director-General. The authority to make appointments for posts in the general-service category is delegated to the Deputy Director-General.
