

**NOTE BY THE DIRECTOR-GENERAL****STATUS REPORT ON THE TIMELY SUBMISSION BY STATES PARTIES OF
DECLARATIONS UNDER ARTICLE VI OF THE CHEMICAL WEAPONS
CONVENTION FOR THE PERIOD FROM 1 JANUARY TO 31 DECEMBER 2022****1. INTRODUCTION**

- 1.1 This Note, which is being submitted to the Executive Council (hereinafter “the Council”) for consideration at its 102nd Session, provides an update on the information and analysis related to the implementation by the Technical Secretariat (hereinafter “the Secretariat”) and States Parties of the decision “Timely Submission by States Parties of Declarations Under Article VI of the Convention” (EC-51/DEC.1, dated 27 November 2007). It covers the period from 1 January to 31 December 2022.
- 1.2 In response to decision EC-51/DEC.1, which requests all States Parties to the Chemical Weapons Convention (hereinafter “the Convention”) to meet their obligations regarding annual declarations in a timely manner, the Secretariat sent a note verbale to all States Parties (NV/VER/DEB-17/22, dated 4 February 2022), reminding them of the requirements of the decision and of the deadline for submission of the annual declaration on past activities (ADPA) for 2021.
- 1.3 In the decision, the Council also requests the Secretariat “to make its requirements known at regional meetings and at any other venues that the Secretariat deems effective”. During the reporting period, the decision was highlighted at a number of events: four regional meetings of National Authorities (in Africa, Asia, Eastern Europe, and Latin America and the Caribbean); one training course for representatives of National Authorities on fulfilling Article VI obligations under the Convention (global); two regional training courses for National Authority representatives involved in fulfilling Article VI requirements (Eastern Europe, and Latin America and the Caribbean); two regional training courses on the Convention for representatives of National Authorities (Asia and Africa); and the Twenty-Fourth Annual Meeting of National Authorities. Furthermore, the Secretariat has emphasised the importance of the timely submission of declarations during several bilateral meetings with Permanent Representatives and National Authorities.

2. SUBMISSION OF INITIAL DECLARATIONS UNDER ARTICLE VI

During the reporting period, the Secretariat did not receive any initial declarations. As at 31 December 2022, only one State Party, Tonga, had yet to submit its initial declaration under Article VI. The Secretariat will continue to work with this State Party towards the submission of its outstanding initial declaration.



3. SUBMISSION OF ANNUAL DECLARATIONS UNDER ARTICLE VI

- 3.1 The deadline for the submission of ADPA 2021 was 31 March 2022. As at that date, the Secretariat had received ADPA 2021 from 79 States Parties, including 12 States Parties that notified the Secretariat that they had no declarable facilities or activities (“nil declarations”).¹ An additional 15 States Parties submitted information on declarable facilities or activities for ADPA 2021 after 31 March 2022, and one more State Party notified the Secretariat that they had no declarable facilities or activities as specified in the Verification Annex to the Convention (hereinafter “the Verification Annex”).
- 3.2 As at 31 December 2022, a total of 82 States Parties had submitted declarations for declarable facilities or activities for 2021. Of these, 67 States Parties (82%) were on time in submitting their declarations. The current status of submission of ADPA 2021 is detailed in Annexes 1 and 2 to this report.
- 3.3 The deadlines for the submission of the annual declaration on anticipated activities (ADAA) for 2023 were 2 October 2022 (for Schedule 1 facilities) and 1 November 2022 (for Schedule 2 and 3 plant sites).
- 3.4 As at the deadline of 2 October 2022, 22 out of 24 States Parties with previously declared Schedule 1 facilities had submitted their ADAA 2023 for Schedule 1 chemicals and related facilities. Accordingly, 92% of these declarations were on time.
- 3.5 As at the deadline of 1 November 2022, 37 out of 39 States Parties with declarable plant sites had submitted their ADAA 2023 for Schedule 2 and 3 chemicals. Two States Parties submitted their ADAAs after the deadline. Accordingly, 95% of these declarations were on time. In addition, six States Parties notified the Secretariat that they anticipated no declarable activities with regard to Schedule 2 or 3 facilities in 2023 (five States Parties within the deadline and one after the deadline).
- 3.6 A total of 42 States Parties declared activities and facilities for 2023 in relation to Schedule 1 and/or Schedule 2 and Schedule 3 chemicals, and five more States Parties notified the Secretariat that they anticipated no declarable activities. Of the States Parties with declarable activities, and in regard to their ADAA 2023, 39 (93%) were on time in submitting at least part of their declaration. The status of submission of ADAA 2023 is detailed in Annexes 3 and 4 to this report.
- 3.7 In paragraph 4 of EC-51/DEC.1, the Council requests “States Parties that anticipate difficulties in regard to the timely submission of their declarations in accordance with the deadlines in the Convention to inform the Secretariat at the earliest possible date of the circumstances of such difficulties”. As at the deadline for the submission of ADPA 2021, Cambodia and Denmark had submitted such information.

¹ Although the submission of nil declarations is not a requirement of the Convention, a number of States Parties choose to provide the Secretariat with such information voluntarily.

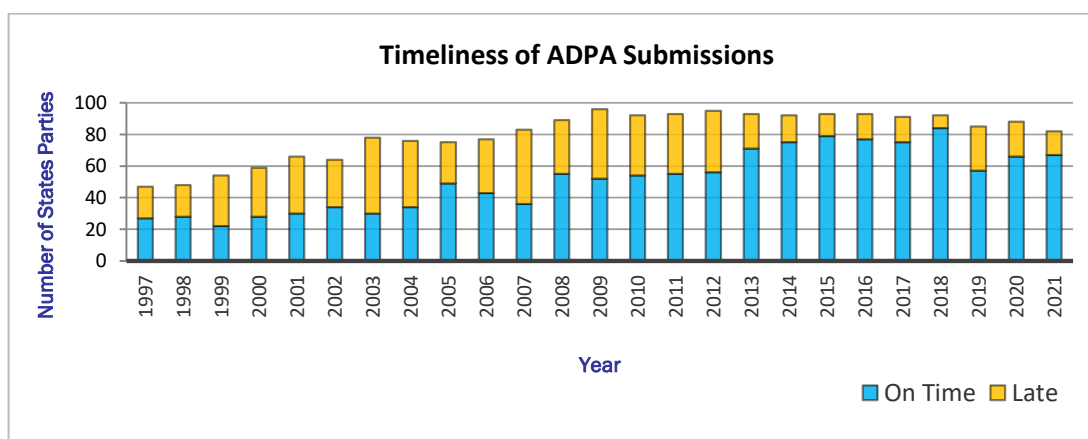
4. ONGOING EFFORTS TO ASSIST STATES PARTIES

- 4.1 The Secretariat stands ready to hold bilateral meetings with representatives of States Parties with regard to their ADPAs and ADAAs, to offer advice and assistance where needed. Furthermore, the Secretariat provides customised support to those States Parties that encounter difficulties in identifying declarable activities, collecting data for declaration, and preparing and submitting their annual declarations, through bilateral consultations with National Authorities and training of National Authorities' personnel. The Secretariat will continue to work with the States Parties concerned towards the timely submission of complete and accurate annual declarations.
- 4.2 As of 30 June 2022, the Secretariat made available to all States Parties its updated tools for the identification of scheduled chemicals, namely, the Handbook on Chemicals, the online Scheduled Chemical Database, and a brochure on the most traded scheduled chemicals, to assist States Parties primarily in the preparation of Article VI declarations.²
- 4.3 The Secretariat continues to support States Parties in using the Secure Information Exchange System (SIX) for the exchange of confidential information, including declarations. Currently, 120 users from 62 States Parties are registered to use SIX. In 2022, the system was used by 38 States Parties for the submission of ADPA 2021. Further details and updates regarding the system are available in the Note by the Secretariat S/2088/2022 (dated 11 August 2022). 5. ANALYSIS OF TRENDS IN THE TIMELINESS OF PAST ADPA SUBMISSIONS³

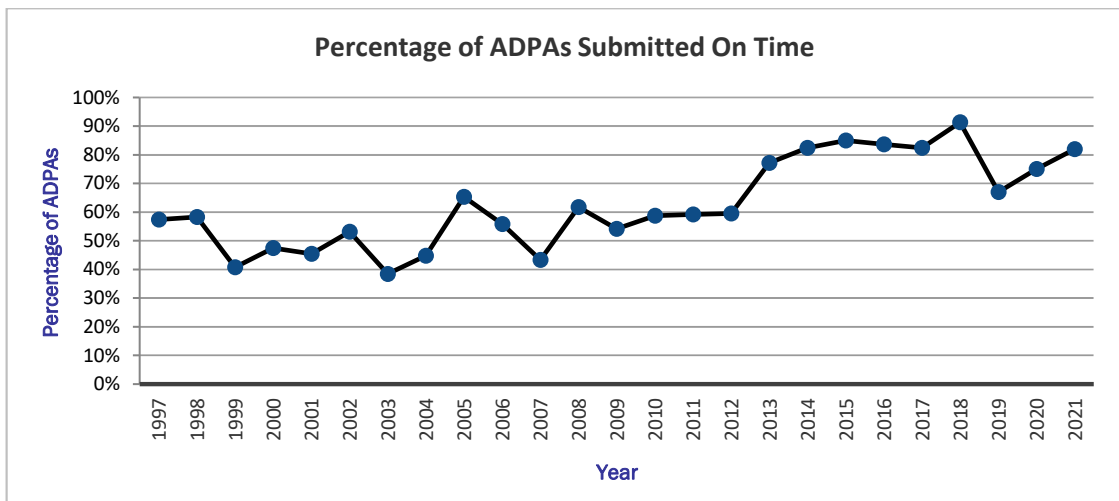
- 5.1 The percentage of ADPA 2021 received on time has improved in comparison with ADPA 2019 and ADPA 2020, which were impacted by the COVID-19 pandemic. However, the overall number of States Parties with declarable activities (as at 31 December 2022) has slightly decreased compared to the previous year, namely, 82 compared to 88 for ADPA 2020. A timeline of ADPA submissions from 1997 to 2021 is shown in Figure 1 below.

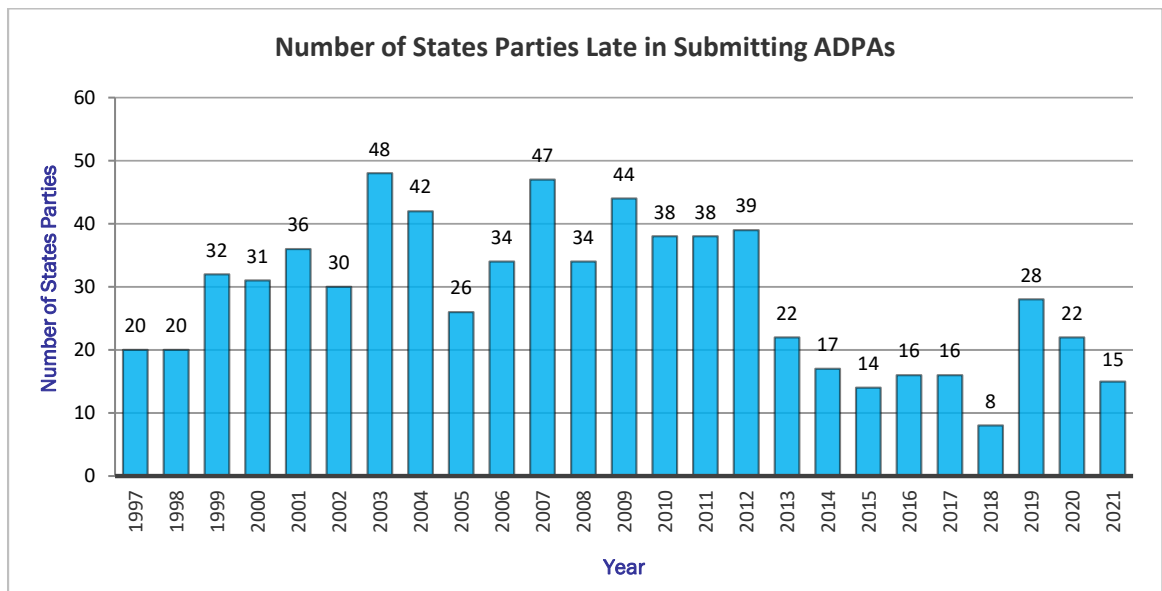

5.2 To highlight the importance of timely submissions and to offer advice and assistance, the Secretariat contacted those States Parties that had not submitted their annual declarations on time and from which, based on the previous declarations, the Secretariat would have expected submissions.

5.3 As at 31 December 2022, 15 States Parties were late in submitting declarable activities for ADPA 2021. Eight of these States Parties submitted their declarations within 30 days after the deadline, while another seven submitted more than 30 days after the deadline. An overview of late submissions of ADPA 1997 to ADPA 2021 is given in Figure 2 below.

5.4 For ADAA 2023 for Schedule 1 facilities, 22 States Parties submitted their declarations on time, compared to 23 States Parties for ADAA 2022.

5.5 Regarding ADAA 2023 for Schedule 2 and 3 plant site declarations, 37 States Parties submitted their declarations on time, compared to 35 States Parties for ADAA 2022. Two States Parties submitted their ADAA 2022 after the deadline.

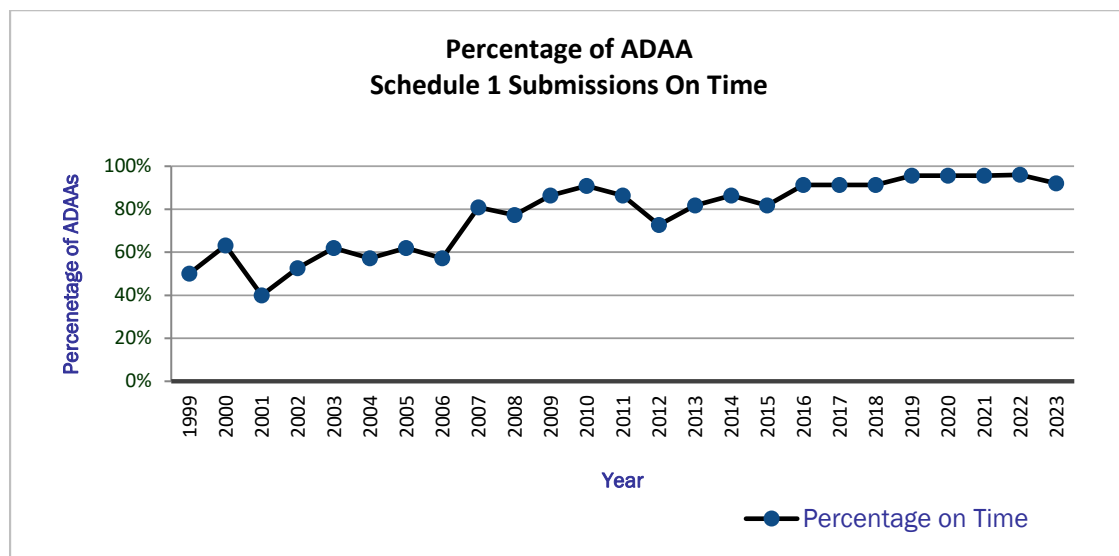
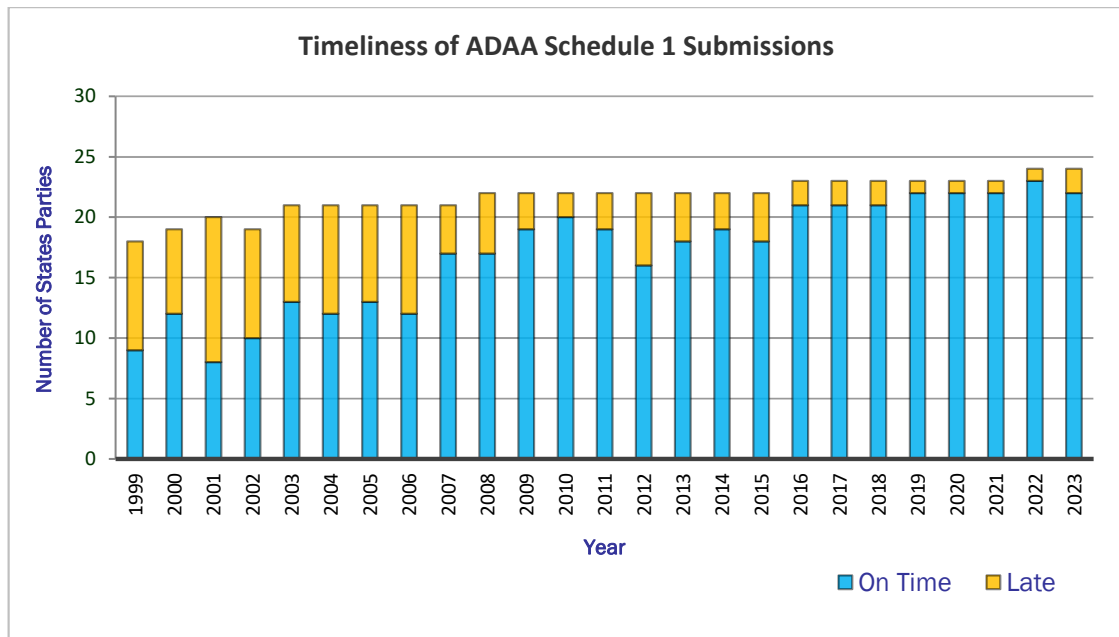
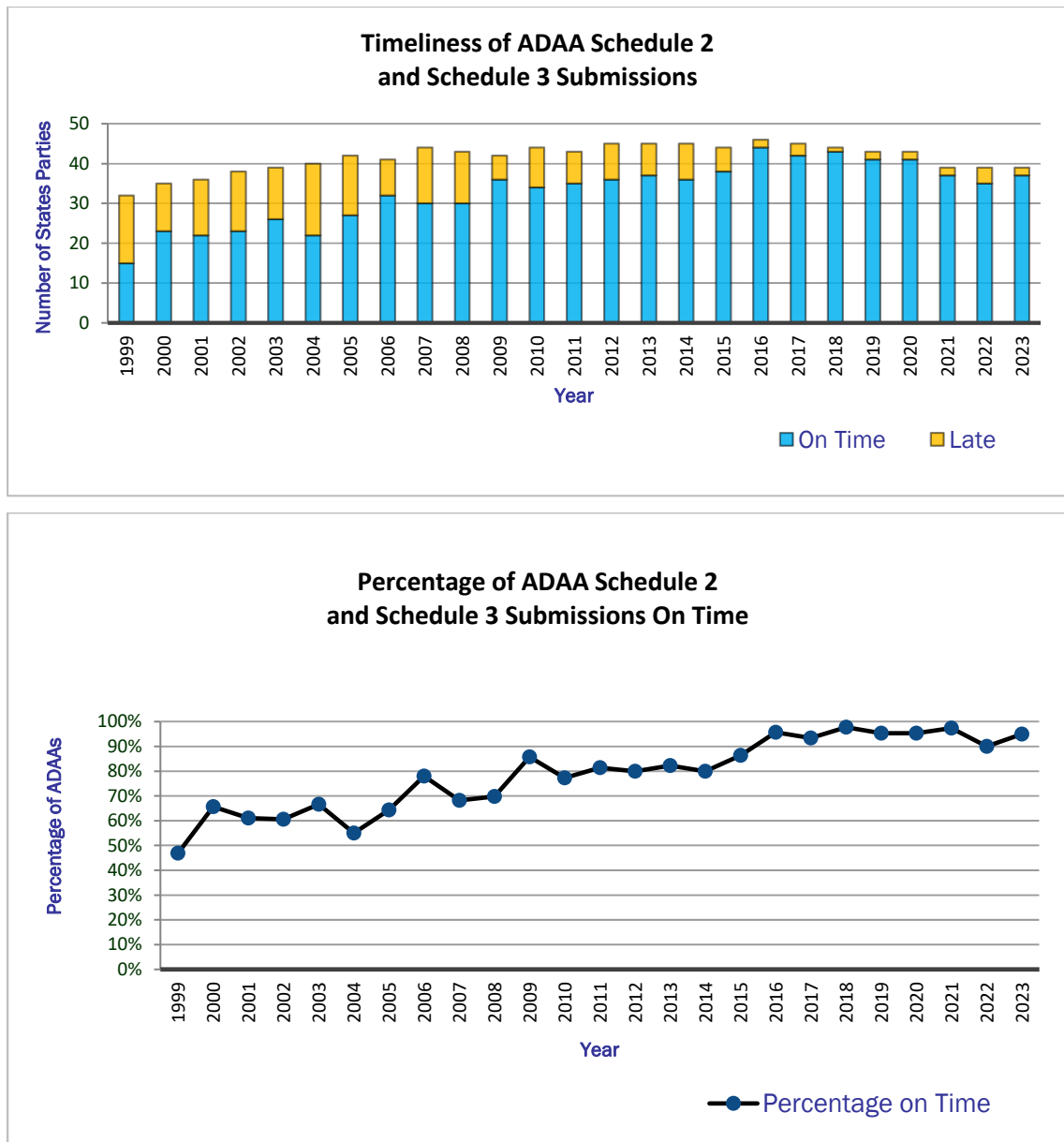


FIGURE 4: OVERVIEW OF SUBMISSIONS OF ADAA FOR SCHEDULE 2 AND SCHEDULE 3 PLANT SITES—ADAA 1999 – 2023

5.6 A timeline of ADAA submissions from 1999 to 2023 is shown below in Figure 3 (for Schedule 1 facilities) and in Figure 4 (for Schedule 2 and Schedule 3 plant sites).
