## **REPUBLIC OF CUBA**

## STATEMENT BY MR MAURICIO MARTINEZ DUQUE CHARGÉ D'AFFAIRES OF THE REPUBLIC OF CUBA, ON BEHALF OF THE MEMBER STATES OF THE NON-ALIGNED MOVEMENT THAT ARE STATES PARTIES TO THE CHEMICAL WEAPONS CONVENTION AND CHINA AT THE SIXTY-FIFTH SESSION OF THE EXECUTIVE COUNCIL

## Mr Chairperson,

- 1. On behalf of the Member States of the Non-Aligned Movement that are States Parties to the Chemical Weapons Convention (NAM CWC States Parties), and China, I would like to welcome you to the Chair of the Executive Council and express our confidence in your able leadership to steer this session to a successful conclusion.
- 2. The NAM CWC States Parties and China, committed to the full and non-discriminatory implementation of the Convention, wish to outline their position on the agenda of the Council.
- 3. The existence of weapons of mass destruction continues to pose a threat to international peace and security. Consequently, the NAM CWC States Parties and China reiterate their long-standing principled position toward the achievement of general and complete disarmament, under strict and effective international control, including the prohibition and elimination of all weapons of mass destruction in line with the first preambular paragraph of the Convention.
- 4. We stress that the total destruction of chemical weapons is one of the fundamental pillars of the Convention. In this regard, completion of destruction of all chemical weapons, including old and abandoned chemical weapons, within the final extended deadline of 29 April 2012, as set forth in the Convention, constitutes an integral part of the obligations by the chemical weapons possessor States and by abandoning States Parties.
- 5. Since more than 33.2% of chemical weapons stockpiles are yet to be destroyed and the destruction of a significant number of old and abandoned chemical weapons is yet to start, the NAM CWC States Parties and China reiterate their serious concern about the pace of destruction of chemical weapons stockpiles, as well as the destruction of old and abandoned chemical weapons, in light of the fast-approaching final extended deadline of 29 April 2012. We therefore reaffirm that verification of the destruction

of the remaining chemical weapons stockpiles as well as old and abandoned chemical weapons shall continue to be the top priority of the Technical Secretariat.

- 6. We have also taken note of the reports made by the possessor and abandoning States Parties and the Director-General on the progress in meeting the revised deadlines for the destruction of chemical weapons. Similarly, large quantities of old and abandoned chemical weapons remain to be destroyed. NAM CWC States Parties and China wish to reiterate concern at the probability that the destruction deadline of 29 April 2012 will not be met. And this endangers the credibility and the integrity of the Chemical Weapons Convention. NAM CWC States Parties and China call upon States Parties concerned to provide concrete information on their destruction plans as well as definitive completion dates to affirm that the latter concurs with the final extended deadline of 29 April 2012 and further request the Director-General to report immediately after 29 April 2012 whether the final extended deadline for destruction of chemical weapons has been met.
- 7. In this context, we welcome and fully support further consultations that are being conducted by you, Mr Chairperson, on this issue in accordance with the mandate given by the Sixty-Fourth Session of the Executive Council "with a view to finding a solution and submitting recommendations to the Conference for consideration at its Sixteenth Session." We look forward to open and transparent discussions among States Parties in order to find a consensus solution which will uphold the integrity and credibility of the Convention.
- 8. The NAM CWC States Parties and China welcome the successful conduct of the initial inspection in Iraq from 1 to 5 May 2011 by the Technical Secretariat and appreciate the efforts made to this effect by the Iraqi authorities and the OPCW inspection team. We consider this a significant step in the context of full implementation of the Convention.
- 9. NAM CWC States Parties and China, taking into account the current situation in Libya, recall the decision taken by the Thirtieth Meeting of the Executive Council to recommend to the Sixteenth Session of the Conference of the States Parties to grant an extension of the deadline to the Libyan Arab Jamahiriya, to 29 April 2012, to destroy all of its Category 1 and 2 chemical weapons. We look forward to the resumption of verified destruction operations in Libya in accordance with the provisions of the Convention as soon as circumstances permit.
- 10. The NAM CWC States Parties and China firmly believe that the effective contribution of the Convention to international and regional peace and security can be enhanced by full adherence to universality of the Convention.
- 11. We commend the Technical Secretariat and the States Parties for their efforts to promote the universality of the Convention, which is fundamental to the realisation of its object and purpose. We urge all States that have still not joined the Convention to do so without further delay, particularly those whose non-adherence to the Convention has given rise to serious concern. In this regard, we request the Technical Secretariat and States Parties which are in a position to do so to redouble their efforts with a view to achieving full universality at the earliest possible date.

- 12. The NAM CWC States Parties and China recall the importance of the provisions of Article XI of the Convention, underlined by the Second Review Conference, and emphasise that the full, effective, and non-discriminatory implementation of this article is essential for the realisation of the object and purpose of the Convention. States Parties are obliged to implement the Convention in a manner that avoids hampering the economic or technological development of States Parties, as well as international cooperation in the field of chemical activities for purposes not prohibited under the Convention.
- 13. We strongly believe that it is imperative to ensure the removal of and to avoid the imposition of any restrictions that are contrary to the letter and spirit of the Convention. In this context, we call upon the developed countries to fulfil their commitment to transfer technology, material, and equipment for peaceful purposes in the chemical field and to remove any discriminatory restrictions which affect the Convention's long-term viability and have an adverse impact on the trust existing among States Parties. We emphasise that the objectives of the Convention can be best achieved through multilaterally negotiated, universal, comprehensive, and non-discriminatory agreements by all States Parties.
- 14. Guided by the experience gained by the Organisation in the implementation of other provisions of the Convention through action plans, the NAM CWC States Parties and China reaffirm their full support for the ongoing informal consultations on the full implementation of Article XI. We welcome the final report of the workshop on Article XI held in November 2010 and look forward to continuing substantive discussions on its recommendations in order to expeditiously devise an action plan to ensure the full, effective and non-discriminatory implementation of Article XI.
- 15. The NAM CWC States Parties and China reaffirm that the implementation of Article X of the Convention on assistance and protection against chemical weapons makes a significant contribution to countering the threats of the use of chemical weapons. We stress the importance of achieving and maintaining a high level of readiness of the OPCW to provide timely, adequate, and effective assistance and protection to its States Parties in situations of use or threat of use of chemical weapons against them.
- 16. While paying due respect to all chemical weapons victims and their families, the NAM CWC States Parties and China reiterate their firm conviction that international support for providing special care and assistance to all victims suffering the effects of exposure to chemical weapons is an urgent humanitarian need requiring the OPCW's close attention. At its Fifteenth Session, the Conference noted the proposal by the Islamic Republic of Iran for the establishment of an international support network for the victims of chemical weapons and requested the Council to report back at its Sixteenth Session along with any appropriate recommendations. While welcoming the informal consultations that have taken place in this regard, we look forward to the timely finalisation of this proposal and reaching a conclusion.
- 17. The NAM CWC States Parties and China acknowledge the contribution of the OPCW, whose primary objective is the total destruction of chemical weapons, to global anti-terrorism efforts through full, effective and non-discriminatory implementation of the Convention bearing in mind that the OPCW is not an

- anti-terrorism Organisation. The Second Review Conference reaffirmed the independent and autonomous nature of the OPCW. We continue to hold the view that the obligation to implement the Convention has its origin in the Convention itself and not in any extraneous resolution or law, and believe that it is important that this principle should be reinforced when addressing any related issue.
- 18. The verification regime of the OPCW is an important element in the implementation of the relevant provisions of the Convention. Noting the considerable progress made in the ongoing industry cluster consultations, the NAM CWC States Parties and China reiterate their commitment to participating in the ongoing consultations.
- 19. In this regard, we stress that the number and frequency of Article VI inspections should be determined based on the hierarchy of risk posed by scheduled chemicals and OCPFs as stipulated in the Convention.
- 20. We stress the relevant paragraphs of the report of the Second Review Conference (RC-2/4) with regard to declaration and inspection of OCPF sites. The NAM CWC States Parties and China reiterate the desirability of directing inspections towards facilities of greater relevance to the object and purpose of the Convention, and that any proposals to be considered regarding this subject shall exclude the possibility of additional declaration obligations and shall correspond strictly with Part IX of the Verification Annex of the Convention, which is based on the concept of hierarchy of risk.
- 21. Furthermore, as it was reiterated in the report of the Second Review Conference (paragraph 9.66), any changes in the frequency of OCPF inspections, if required, shall take into account any refinements to the OCPF inspection regime or improvements in site-selection methodology, and should be based on a thorough discussion and a decision of the policy-making organs.
- 22. In this context, we recall that the modified methodology for the selection of OCPF inspection is an interim measure. The site-election methodology should be in accordance with the provisions of the Convention, and needs to be adopted by consensus. In this regard, we remain committed to actively and constructively participate in the facilitation conducted to resolve this important issue.
- 23. The NAM CWC States Parties and China reemphasise that the employment of personnel in the Technical Secretariat is to be fair and transparent and stress that in accordance with Article VIII, paragraph 44 of the Convention, the paramount consideration in the employment of the Staff shall be the necessity of securing the highest standards of efficiency, competence and integrity. In this context it is important that the Technical Secretariat observe an equitable geographical representation, particularly at the professional level.
- 24. The NAM CWC States Parties and China are actively participating in the ongoing facilitations on tenure policy. We would like to stress the need to act in a manner consistent with the Convention and previous decisions and staff rules and regulations of the OPCW. While ensuring equitable geographical distribution and without favouring any particular region, the tenure policy should be implemented in a way

- that the Organisation can continue to effectively meet its core objectives particularly the most important objective of destruction of chemical weapons.
- 25. In the context of the implementation of Article VII, we encourage all States Parties and the Technical Secretariat to continue to provide meaningful assistance and technical support to States Parties, at their request, and to come up with appropriate solutions to overcome the practical difficulties and resource constraints encountered by individual States Parties in carrying out their national implementation measures.
- 26. The NAM CWC States Parties and China look forward to open and transparent discussions on Draft 2012 Programme and Budget as well as the Medium-Term Plan, and underline the importance in achieving balance among the different items of the OPCW budget, including the allocation of adequate resources for the international cooperation and technical assistance projects.
- 27. The NAM CWC States Parties and China have noted the development related to the Advisory Panel of independent experts, established by the Director-General, on the question of the future of the OPCW under the Convention. The outcome of the Panel's work could be a useful contribution to the ongoing discussions by the States Parties on the future development of the Organisation, keeping in mind the full implementation of Article I of the Convention. We are of the view that the outcome of the Panel's work needs to be considered in an open and transparent manner. In this regard, we stress that the Organisation should continue to accord top priority to the complete destruction of all chemical weapons in accordance with the Convention.
- 28. I would like to request that the English version of the statement, which is the authentic version, be issued as an official document of the Sixty-Fifth Session of the Executive Council.
