ANNOTATED PROVISIONAL AGENDA FOR THE SEVENTY-SIXTH SESSION OF THE EXECUTIVE COUNCIL, 8-11 JULY 2014

6.1 Further to a decision by the Conference of the States Parties (hereinafter "the Conference") at its Sixteenth Session (C-16/DEC.11, dated 1 December 2011), the Council is **requested** to consider and note a report by the Director-General on the overall progress of destruction activities by possessor States Parties (this document will be assigned an official reference number when it is made available to delegations).

6.2 Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6, dated 15 February 2012), the Council is **requested** to consider and note a report by the Director-General on the overall progress of the destruction of abandoned chemical weapons (this document will be assigned an official reference number when it is made available to delegations).

Subitem 6(b): Implementation of the Conference of the States Parties and Executive Council decisions on destruction-related issues

- 6.3 The Secretariat is expected to brief the Council on its destruction-related verification activities.
- 6.4 The States Parties concerned are expected to brief the Council on their destruction-related activities.
- 6.5 The Council is **requested** to consider and note the report of the visit by the Chairperson of the Council and representatives of the Council to the Kizner chemical weapons destruction facility in the Russian Federation, from 14 to 18 April 2014 (EC-76/1, dated 30 May 2014).
- 6.6 Further to a decision by the Conference at its Sixteenth Session (C-16/DEC.11), the Council is **requested** to consider and note a national paper by the United States of America on the progress made on the completion of the destruction of its chemical weapons, including information on measures to accelerate such progress, and identifying progress made since the last briefing in order to meet the planned completion date. This report is also to include reporting on any specific measures undertaken to overcome problems in the destruction programme (EC-76/NAT.2, dated 12 June 2014).
- 6.7 Further to the same decision by the Conference at its Sixteenth Session (C-16/DEC.11), the Council is **requested** to consider and note a national paper by the Russian Federation on the progress made on the completion of the destruction of its chemical weapons, including information on measures to accelerate such progress, and identifying progress made since the last briefing in order to meet the planned completion date. This report is also to include reporting on any specific measures undertaken to overcome problems in the destruction programme (this document will be assigned an official reference number when it is made available to delegations).
- 6.8 Further to the same decision by the Conference at its Sixteenth Session (C-16/DEC.11), the Council is **requested** to consider and note a national paper by Libya on the progress made on the completion of the destruction of its chemical weapons, including information on measures to accelerate such progress, and identifying progress made since the last briefing in order to meet the planned completion date. This report is also to include reporting on any specific measures undertaken to overcome problems in the destruction programme (this document will be assigned an official reference number when it is made available to delegations).
- 6.9 The Council is **requested** to note a Note by the Director-General reporting on progress in the elimination of the Syrian chemical weapons programme (EC-76/DG.14, dated 25 June 2014).

- 6.10 A national paper by the Syrian Arab Republic has been made available to the members of the Council (EC-76/P/NAT.1, dated 16 June 2014).
- 6.11 At its Forty-Second Meeting, the Council further considered the combined plans for the destruction and verification of chemical weapons production facilities in the Syrian Arab Republic (EC-M-40/DG.2, dated 27 March 2014), and decided to continue consideration at its forthcoming session.
- 6.12 The Council is **requested** to note an overall report by the Director-General on the elimination of the Syrian chemical weapons programme (this document will be assigned an official reference number when it is made available to delegations).
- 6.13 Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6), a national paper by China and a national paper by Japan on the overall progress of the destruction of chemical weapons abandoned by Japan on the territory of China have been circulated to the members of the Council (these documents will be assigned official reference numbers when they are made available to delegations).

Subitem 6(c): Other verification-related issues

- 6.14 The Secretariat is expected to brief the Council on its other verification-related activities.
- 6.15 The Secretariat will make a presentation on the Secure Information Exchange (SIX) project.

Subitem 6(d): Destruction-related plans and facility agreements

- 6.16 The Secretariat has submitted to the Council a Note on amendments to the facility agreement with the Slovak Republic regarding on-site inspections at a Schedule 1 protective purposes facility (EC-76/S/3, dated 16 June 2014).
- 6.17 The Council is **requested** to consider and adopt a draft decision on amendments to the aforementioned facility agreement (EC-76/DEC/CRP.3, dated 16 June 2014). The amendments have been submitted separately to the Council (EC-76/P/DEC/CRP.1, dated 16 June 2014), which is **requested** to consider and approve them. The amendments to the facility agreement are reflected (in red-lining, for ease of reference) in the revised version of the facility agreement.
- 6.18 The Council is **requested** to consider and approve the agreed detailed plan for verification of the destruction of chemical weapons at the Pueblo Chemical Agent-Destruction Pilot Plant Explosive Destruction System, located at Pueblo, Colorado, the United States of America (EC-76/DEC/CRP.4, dated 23 June 2014).
- 6.19 The Council is **requested** to consider and approve the facility agreement with the United States of America regarding on-site inspections at the Pueblo Chemical Agent-Destruction Pilot Plant Explosive Destruction System, located at Pueblo, Colorado, the United States of America (EC-76/DEC/CRP.5, dated 23 June 2014).

Subitem 6(e): Verification Implementation Report for 2013

6.20 The Council is **requested** to consider and note the Verification Implementation Report (VIR) for the period from 1 January to 31 December 2013 (EC-76/HP/DG.1*, dated 29 April 2014). The Council is also **requested** to note the Chairperson's summary of the informal consultations on it (EC-76/4, dated 25 June 2014).

Subitem 6(f): The content of the assistance-and-protection data bank and its use

6.21 The Council is **requested** to consider and note a Note by the Secretariat on the content of the assistance-and-protection data bank and its use (EC-76/S/2, dated 11 June 2014).

Subitem 6(g): Timely submission of declarations under Article VI

- 6.22 Further to a decision by the Council at its Fifty-First Session (EC-51/DEC.1, dated 27 November 2007), the Council is **requested** to note a status report by the Director-General on the timely submission by States Parties of declarations under Article VI of the Chemical Weapons Convention (hereinafter "the Convention") for the period from 1 January to 31 May 2014 (EC-76/DG.10*, dated 11 June 2014).
- 6.23 Further to the decision of the Council at its Sixty-Sixth session on the policy guidelines for determining the number of Article VI inspections (EC-66/DEC.10, dated 7 October 2011), the Council is **requested** to note the report by the Director-General on the results of the implementation of these policy guidelines (EC-76/DG.3, dated 3 April 2014).

Subitem 6(h): Article VII: briefings by the facilitator and by the Technical Secretariat

- 6.24 The facilitator for this issue, Dr Zlatko Dimitroff of Bulgaria, is expected to report on the consultations carried out during the intersessional period.
- 6.25 The Secretariat will make a presentation on the status of implementation of Article VII.

Subitem 6(i): Article X: briefings by the facilitator and by the Technical Secretariat

- 6.26 The facilitator for this issue, Ms Sarah Broughton of the United Kingdom of Great Britain and Northern Ireland, is expected to report on the consultations carried out during the intersessional period.
- 6.27 The Secretariat will make a presentation on the status of implementation of Article X.

Subitem 6(j): Report by the Director-General on the Technical Secretariat's readiness to conduct a challenge inspection or an investigation of alleged use

6.28 The Council is **requested** to consider and note a Note by the Director-General reporting on the readiness of the Secretariat to conduct a challenge inspection or an investigation of alleged use (EC-76/DG.11, dated 12 June 2014).

7. AGENDA ITEM SEVEN – Summary report of the OPCW Fact-Finding Mission in Syria

At the Forty-Second Meeting of the Council on 17 June 2014, the Secretariat circulated the summary report of the OPCW Fact-Finding Mission in Syria covering the period from 3 to 31 May 2014 (S/1191/2014, dated 16 June 2014). Delegations requested more time to study the report and to revert to the matter at a later stage.

In accordance with Financial Regulation 12.5, the Director-General will transmit the report to the Conference at its Nineteenth Session, together with his own comments and any that the Council may deem appropriate.

11.6 At its Thirty-Fifth Meeting, the Council requested the Chairperson of the ABAF to consult with the other members of the ABAF regarding the financial implications of rehiring inspectors, and to report back to the next regular session of the Council, with a view to taking a decision at that meeting. The Secretariat was also requested to inform the Council at its next regular session whether there would be, or would not be, any additional financial implications with the implementation of the proposed initiative (paragraph 6 of EC-M-35/3, dated 29 November 2013).

11.7 The Council is **requested** to note the Note by the Secretariat on the rehiring of former inspectors (this document will be assigned an official reference number when it is made available to delegations).
