- 6.1 Further to a decision by the Conference of the States Parties (hereinafter "the Conference") at its Sixteenth Session (C-16/DEC.11, dated 1 December 2011), the Council is **requested** to consider and note a report by the Director-General on the overall progress of destruction activities by possessor States Parties (this document will be assigned an official reference number when it is made available to delegations).
- 6.2 Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6, dated 15 February 2012), the Council is **requested** to consider and note a report by the Director-General on the overall progress of the destruction of abandoned chemical weapons (this document will be assigned an official reference number when it is made available to delegations).

This report is also to include reporting on any specific measures undertaken to overcome problems in the destruction programme (EC-82/P/NAT.5, dated 23 June 2016).
- 6.7 The Council is **requested** to consider and note the report of the visit by the Chairperson of the Council and representatives of the Council to the Kizner chemical weapons destruction facility, the Russian Federation, from 25 to 29 April 2016 (EC-82/1, dated 30 May 2016).

- 6.8 Further to the aforementioned decision by the Conference at its Sixteenth Session (C-16/DEC.11), the Council is **requested** to consider and note a national paper by Libya on the progress made on the completion of the destruction of its chemical weapons, including information on measures to accelerate such progress, and identifying progress made since the last briefing in order to meet the planned completion date. This report is also to include reporting on any specific measures undertaken to overcome problems in the destruction programme (this document will be assigned an official reference number when it is made available to delegations).
- 6.9 The Council is **requested** to note four Notes by the Director-General reporting on progress in the elimination of the Syrian chemical weapons programme (EC-82/DG.1, dated 24 March 2016; EC-82/DG.5, dated 22 April 2016; EC-82/DG.9, dated 25 May 2016; and EC-82/DG.17, dated 24 June 2016).
- 6.10 The Council is **requested** to note four national papers by the Syrian Arab Republic on the activities related to the destruction of Syrian chemical weapons and their production facilities (EC-82/P/NAT.1, dated 17 March 2016; EC-82/P/NAT.2, dated 15 April 2016; EC-82/P/NAT.3, dated 19 May 2016; and EC-82/P/NAT.4, dated 17 June 2016).
- 6.11 Further to its consideration of this issue at its previous sessions, the Council is **requested** to consider and adopt a draft decision on the retention of samples of Syrian chemical weapons (EC-77/DEC/CRP.2/Rev.1, dated 23 March 2016).
- 6.12 Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6), a national paper by China (this document will be assigned an official reference number when it is made available to delegations) and a national paper by Japan (this document will be assigned an official reference number when it is made available to delegations) on the overall progress of the destruction of chemical weapons abandoned by Japan on the territory of China have been circulated to the members of the Council.

- 12.8 At its previous session, the Council welcomed the Director-General's monthly financial situation reports and called on all States Parties to pay their outstanding financial obligations to the Organisation in full and without delay. The Council requested the Director-General to manage the cash flow and financial situation of the Organisation and to keep the Council informed about the measures it has taken, or is considering, to mitigate as much as possible the situation.
