NOTE BY THE DIRECTOR-GENERAL

REQUEST BY THE RUSSIAN FEDERATION TO CONVENE A MEETING OF THE EXECUTIVE COUNCIL

- 1. The Chairperson of the Executive Council, His Excellency Ambassador Sheikh Mohammed Belal of Bangladesh, has received a request by the Permanent Representative of the Russian Federation to the OPCW, to convene a meeting of the Executive Council (hereinafter "the Council") under Rule 12 of the Rules of Procedure of the Council.
