NOTE BY THE DIRECTOR-GENERAL

**CALL FOR NOMINATIONS FOR THE FIFTEENTH REGIONAL MEETING
OF NATIONAL AUTHORITIES OF STATES PARTIES
IN LATIN AMERICA AND THE CARIBBEAN
SANTIAGO, CHILE
29 – 31 JULY 2014**

1. On behalf of the Government of Chile and the Organisation for the Prohibition of Chemical Weapons (OPCW), the Director-General wishes to invite National Authorities to nominate participants to attend the Fifteenth Regional Meeting of National Authorities of States Parties in Latin America and the Caribbean, which will be held in Santiago, Chile, from 29 to 31 July 2014. The meeting is designed to provide an opportunity for interaction amongst personnel of National Authorities who are involved with the national implementation of the Chemical Weapons Convention (hereinafter “the Convention”). Nominees should therefore be responsible for carrying out such tasks on a day-to-day basis.
2. The Third Special Session of the Conference of the States Parties to Review the Operation of the Chemical Weapons Convention (hereinafter “the Third Review Conference”) encouraged States Parties which are yet to fulfil their obligations to engage with the Technical Secretariat (hereinafter “the Secretariat”) on the steps that need to be undertaken for the national implementation of the Convention. It highlighted the need for a comprehensive approach to national implementation in line with each State Party’s constitutional requirements, to filling gaps in national implementation, and to ensuring that national implementation measures are consistent with the provisions of the Convention. It also encouraged the Secretariat to explore innovative methods of providing assistance on tailor-made approaches and develop, within existing resources, activities that will enhance South-South, regional, and subregional cooperation, as well as special programmes (RC-3/3*, dated 19 April 2013).
3. While acknowledging the challenges still faced by certain States Parties, the Third Review Conference also noted the value of bilateral assistance and networking within and among regions, especially for States Parties that may need particular assistance. States Parties and the Secretariat were encouraged to continue to consult in order to enhance further the utility and effectiveness of all implementation-support programmes. States Parties in a position to do so were further urged to continue to enhance their practical support for the implementation of Article VII obligations.



4. The meeting will provide States Parties in the region with updates on the work of the OPCW and the implementation of the Convention. During the meeting, representatives of participating National Authorities will be able to confer with each other, with the Secretariat staff, and with the resource persons to identify what further steps, if any, each State Party needs to take in order to implement fully its obligations under the Convention. This will enable the Secretariat, relevant subregional institutions in the region, and States Parties in a position to do so, to determine how to enhance the assistance provided to States Parties in the region to enable them realise their outstanding obligations under the Convention.
5. States Parties in the region can also present their needs for assistance in relation to their obligations under the Convention. States Parties that are in a position to do so will be requested to indicate what type of assistance they can offer to others.
6. The programme of the meeting will:
 - (a) provide updates on the status of implementation of the provisions of the Convention, recent developments within the OPCW, and recent developments in relation to Articles VI and VII and their impact on States Parties;
 - (b) discuss and make recommendations on practical issues affecting the national implementation of States Parties' obligations under the Convention;
 - (c) discuss and make recommendations on education, outreach, and awareness-raising and the national implementation of the Convention;
 - (d) review and share best practices regarding the implementation of provisions of the Convention; and
 - (e) arrange bilateral meetings between National Authority representatives and Secretariat staff.
7. In view of the fact that the programme is designed to be interactive and participatory, all participants will be expected to take an active part in the discussions and to give presentations in order to share their national experiences and best practices on the topics discussed during the meeting.
8. The provisional programme for the meeting is included as Annex 1 to this Note.
9. The Secretariat expects to be able to sponsor the participation of a limited number of representatives of National Authorities. Each nomination should specify whether sponsorship is a condition of the nominee's participation. For sponsored participants, the Secretariat will cover the costs of travel, accommodation, meals, and medical insurance, and will provide a limited subsistence allowance to cover sundry expenses. Sponsored participants who do not intend to use the accommodation arranged by the Secretariat are requested to indicate that as soon as possible, so that the Secretariat does not incur hotel cancellation fees. In any case, the Secretariat will not cover the costs of any accommodation it has not arranged.
10. When making travel arrangements for sponsored participants, the Secretariat will seek the most economical options. It will purchase tickets and send them to participants.

Participants will be allowed to purchase tickets locally only if this leads to further savings for the Secretariat and if the Secretariat authorises it. In order for the Secretariat to keep costs to a minimum, participants are expected to arrive no earlier than **Monday, 28 July 2014**, and to depart no later than **Friday, 1 August 2014**. The Secretariat's agreement is required for any changes to the arrival and departure dates. The Secretariat will not cover expenses unrelated to the meeting or that result from changes to travel arrangements it has not authorised. Sponsored participants shall bear all costs resulting from changes they make, including cancellations, once the Secretariat has purchased tickets. Participants who have not been sponsored are requested to make their own travel and accommodation arrangements, although the Secretariat can, if necessary, arrange accommodation at reduced rates.

11. Participants are requested to obtain any necessary visas (including transit visas) before travelling to Chile. When applying for any entry visa, they should present the Embassy or Consulate of Chile with a copy of the acceptance letter from the OPCW. The Secretariat will issue a visa support letter to sponsored participants to facilitate the issuance of their visas.
12. All activities during the meeting will be conducted in Spanish and English and interpretation services will be provided between these two languages. All participants are therefore expected to have a good command of English or Spanish.
13. Interested National Authorities are invited to complete the nomination and the endorsement forms that are included as Annex 2 and Annex 3 to this Note, making sure, in particular, to provide all the requested contact details. All nominations must be received by the Secretariat no later than **Sunday, 8 June 2014**. Owing to the large number of applications expected, only candidates whose applications have been successful will be contacted. Nominations received by the Secretariat after the deadline will not be considered for sponsorship.
