## Resolution No. 52 of 1997

RESOLUTION NO. 52/97

WHEREAS: The National Statistics Office was set up under the auspices of the Ministry of the Economy and Planning under the provisions of Article 3 of Decree Law No. 147 dated 21 April 1994 "On the Reorganisation of the Central Administration of the State".

WHEREAS: Resolution No. 3 dated 20 January 1995 from the Ministry of Economy and Planning specifically empowers the head of the National Statistics Office to make provisions to ensure the continuity and integrity of the work in this field, and to centralise and to issue the official statistics of the country, including the state cooperative, mixed and private sectors.

WHEREAS: By Resolution No. 152 dated 3 April 1996 from the Ministry of Economy and Planning a provisional appointment was made of the Director of National Statistics Office.

WHEREAS: The Harmonised System of Nomenclature for Commodity Description currently in force is the one established by Resolution No. 09 dated 6 April 1994 of the Minister/Chairman of the now defunct State Statistics Committee, as subsequently amended by Resolutions No. 30 dated 25 August 1995, No. 33 dated 25 October 1995 and No. 26 dated 24 October 1996 all by the Director of the National Statistics Office.

WHEREAS: The Customs Technical Commission has requested that account be taken of the recommendation of the Council of Customs Cooperation to the member governments and contracting parties to the Convention on the Harmonised System to insert into their statistical Nomenclatures the secondary designations corresponding to substances controlled by the Convention on the Prohibition of the Development, Production, Stockpiling and use of Chemical Weapons and on their Destruction.

THEREFORE: By virtue of the powers invested in me,

**I RESOLVE**

FIRST: To amend, as of 1 January 1998, the Nomenclature of the Harmonised System for Commodity Description as shown in the Annex hereto, which is an integral part hereof.

SECOND: To make the Computer Administration Service in the National Statistic Office responsible for the publication and distribution hereof.

THIRD: Notice hereof should be taken by the heads of the agencies of the Central Administration of the State, Chairman of the Councils of provincial

administration of the peoples power, the head of the General Customs Service of the Republic, the head of the National Bank of Cuba, the heads of the major organised unions, and the territorial officers of the National Statistics Office, and any other person natural or juridical concerned, and I order publication hereof in the official gazette of the Republic.

Given in the National Statistics Office in the city of La Havana on the 14<sup>th</sup> day of October 1997, “Year of the 30<sup>th</sup> Anniversary of the death in battle of the heroic guerrilla and his companions”.
