## 1. Declarations under this section

This section applies to declaration and information requirements for OCW produced between 1925-1946 that are stipulated in paragraph 1 (b) (i) of Article III of the Convention and paragraphs 3, 4 and 7 of Part IV(B) of the Verification Annex of the Convention. The initial declaration must be made no later than 30 days after entry into force of the Convention for the State Party (EIF(SP)). Subsequent information must be submitted if additional old chemical weapons are discovered after the initial declaration has been made. Information on destruction shall be provided in accordance with Part IV (A) of the Verification Annex.

## 2. Old chemical weapons produced between 1925-1946 declaration requirements and their deadlines

### 2.1 Overview

Table 1 below indicates a summary of the declaration/information requirements for States Parties and applicable forms for each kind of declarations.

## 2.2 OUTLINE OF DECLARATION/INFORMATION REQUIREMENTS

### 2.2.1 Declaration requirements

(i) In accordance with paragraph 5 (b) of Article II, old chemical weapons (OCWs) include chemical weapons produced in the period between 1925 and 1946 that have deteriorated to such extent that they can no longer be used as chemical weapons.

(ii) For such old chemical weapons, a State Party shall submit to the Technical Secretariat, within 30 days of the entry into force of the Convention for it, a declaration pursuant to subparagraph 1 (b) (i) of Article III of the Convention and paragraphs 1 to 3 of Part IV(A) of the Verification Annex.

Form OCW25-46 1.0 is to be used for this declaration.

(iii) A State Party which discovers old chemical weapons after the Convention enter into force for it shall, within 180 days of the discovery, submit to the Technical Secretariat, **to the extent possible**, the information specified in subparagraph (ii) above.

**Form OCW25-46 1.1** is to be used for this purpose.

(iv) To assist States Parties in preparing declarations, nomenclature and structural data on the chemicals contained in the Schedules will be compiled in advance in a Handbook on Chemicals (**Appendix 2**).

**(b) Information to be provided to the extent possible:**

For the initial declaration as well as for the submission of information related to old chemical weapons discovered after the entry into force of the Convention for it, a State Party is required to submit, to the extent possible, the following information specified in paragraphs 1 to 3 of Part IV(A) of the Verification Annex of the Convention.

(i) Aggregate quantity for each chemical declared.

**Form OCW25-46 2.0** is to be used for submitting this information.

(ii) The precise location of each old chemical weapons area/storage facility.

**Form OCW25-46 3.0** is to be used for submitting this information.

(iii) The detailed inventory at each old chemical weapons location.

**Forms OCW25-46 3.1; 3.2, 3.3 and 3.4** are to be used for submitting this information.

## **2.2.2 Declarations on destruction of old chemical weapons**

**Three types of declaration are required on destruction of old chemical weapons:**

**(a) the General Plan for destruction of old chemical weapons**

**Forms OCWD25-46 1.0, OCWD25-46 1.1, OCWD25-46 1.2, OCWD25-46 1.3**

**(b) the Detailed Annual Plan for destruction of old chemical weapons**

**Forms OCWD25-46 2.0, OCWD25-46 2.1, OCWD25-46 2.2, OCWD25-46 2.3, OCWD25-46 2.4, OCWD25-46 2.5, OCWD25-46 2.6**

**(c) the Annual Report on the destruction of old chemical weapons**

**Forms OCWD25-46 3.0, OCWD25-46 3.1, OCWD25-46 3.2, OCWD25-46 3.3**

**3. Definitions to be referred to in relation to the declaration requirements**

The following definitions taken from the CWC are to be taken into account when making declarations:

**"Chemical Weapons"** means the following, together or separately:

- (a) Toxic chemicals and their precursors, except where intended for purposes not prohibited under this Convention, as long as the types and quantities are consistent with such purposes;
- (b) Munitions and devices, specifically designed to cause death or other harm through the toxic properties of those toxic chemicals specified in subparagraph (a), which would be released as a result of the employment of such munitions and devices;
- (c) Any equipment specifically designed for use directly in connection with the employment of munitions and devices specified in subparagraph (b).

**"Toxic Chemical"** means:

Any chemical which through its chemical action on life processes can cause death, temporary incapacitation or permanent harm to humans or animals. This includes all such chemicals, regardless of their origin or of their method of production, and regardless of whether they are produced in facilities, in munitions or elsewhere. (For the purpose of implementing this Convention, toxic chemicals which have been identified for the application of verification measures are listed in Schedules contained in the Annex on Chemicals.)

**"Tonne"** is defined as metric ton, i.e. 1,000 kilograms.

**DATA FORMATS AND TECHNICAL GUIDELINES FOR  
COMPLETION THE DECLARATION FORMS**

**Instructions in regard to data formats**

1. **Names of Countries** should be declared using the appropriate code ISO 3166 as contained in **Appendix 1**.
2. **Dates** should be given as CCYY-MM-DD (e.g., 1998-03-31) or for **periods** as CCYY-MM/CCYY-MM (e.g., 1998-03/1998-09).
3. **Yes-No Questions** must always be answered.
4. **Chemicals** should be identified by chemical name in accordance with current International Union of Pure and Applied Chemistry (IUPAC) nomenclature, structural formula and Chemical Abstracts Service registry number, if assigned.
5. For each chemical the **total weight** present at the facility shall be declared and rounded as follows:
  - (a) for more than 10 tonnes, rounded to the nearest 1 tonne;
  - (b) for less than 10 tonnes and more than 1 tonne, rounded to the nearest 0.1 tonne;
  - (c) for less than 1 tonne and more than 0.1 tonnes, rounded to the nearest 0.01 tonne ;
  - (d) for less than 0.1 tonne, rounded to the nearest 0.001 tonne.
6. **Aggregate quantities** of each chemical declared on the aggregate formats are to be declared as accurately as possible and are to be rounded up to the nearest one thousand kilograms. If such quantity is less than one thousand kilograms, then it is to be rounded up as mentioned in paragraph 5 (c and d) of these instructions.
7. The measure to be used for declaring the **nominal weight** of chemical fill for each item is kilograms.
9. **Geographical co-ordinates** are to be declared to the nearest second according to the following formats:

Latitude: 00 (degree)/00(minute)/00(second)/0 (North or South)  
Example: "55/45/28/N"

Longitude: 000 (degree)/00(minute)/00(second)/0 (East or West)  
Example: "005/32/53/E"

Co-ordinates should be associated with a specific feature related to the location (e.g., entrance of a site, road intersection). The geographic reference system used should be specified.



10. **Attachments**, if any, are to be identified by unique labels, reference numbers or file names.
11. **Site diagram**, for a location is to be attached including to the extent possible:
  - (a) boundary map;
  - (b) the location of bunker/ storage areas.
12. If declaration information as a whole is to be treated as confidential, this should be indicated on declaration forms , with the appropriate classification code (see below).
13. If, however, only parts of the declaration are confidential, these may be indicated on the individual Declaration Forms prefixed with a "/" by inserting the appropriate confidential code before the slash. The following codes are to be used:  
  
**R:** OPCW Restricted  
**P:** OPCW Protected  
**H:** OPCW Highly Protected

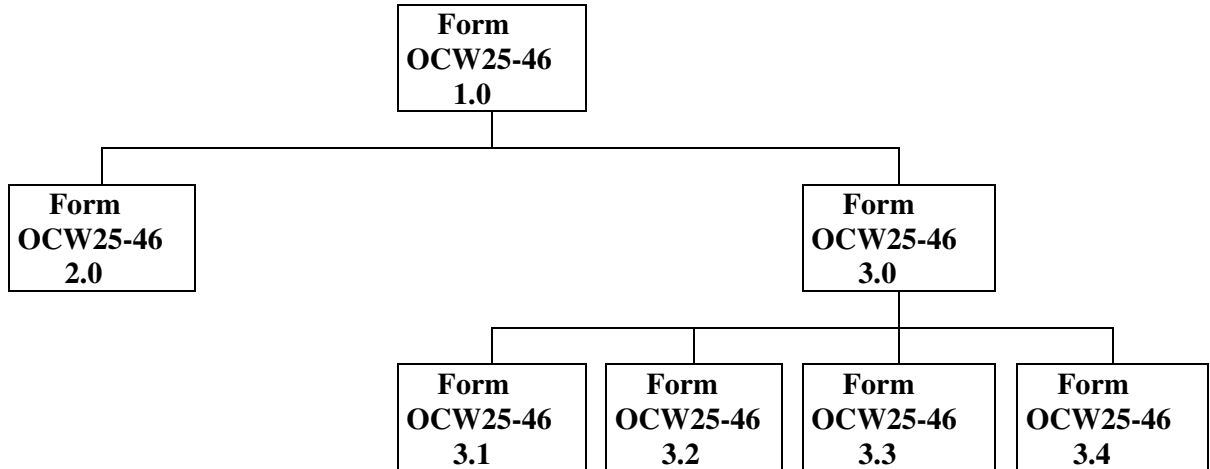

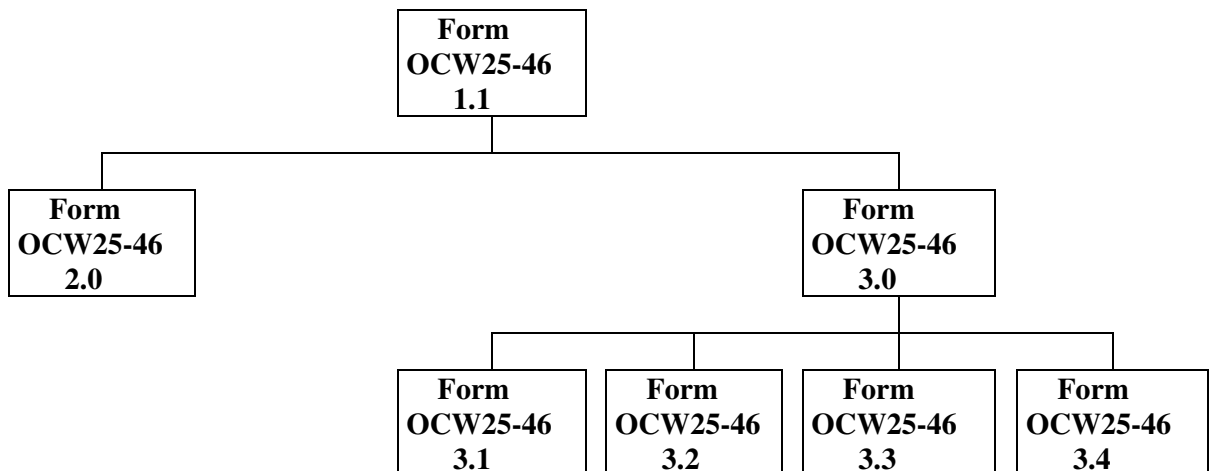
