## **NOTA DEL DIRECTOR GENERAL**

### **COMPOSICIÓN DEL CONSEJO CONSULTIVO CIENTÍFICO PARA EL PERÍODO 2001 A 2004**

1. Con arreglo al mandato del Consejo Consultivo Científico (C-II/DEC.10, de 5 de diciembre de 1997), el mandato de los miembros del Consejo tendrá una duración de tres años y será renovable una vez. Los primeros miembros del Consejo Consultivo Científico fueron nombrados por el Director General en julio de 1998 (véase S/62/98, de fecha 22 de julio de 1998). Su primer mandato terminó, por consiguiente, en julio de 2001.
2. Cuando presentó el cuarto informe del Consejo Consultivo Científico a los Estados Miembros en marzo de 2001, el Director General manifestó su intención de ofrecer "en interés de mantener la continuidad y, en particular, teniendo en cuenta que los preparativos para la Conferencia de Examen en 2003 requerirán una contribución importante del Consejo Consultivo, ... un segundo mandato a todos aquellos miembros del Consejo Consultivo que estén dispuestos a continuar" (párrafo 3.3 del EC-XXIV/DG.2, de fecha 9 de marzo de 2001).
3. Dos miembros del Consejo Consultivo habían manifestado su intención de no repetir mandato, por lo que el Director General invitó a los Estados Miembros a que presentaran candidaturas para cubrir esas vacantes inminentes (párrafo 3.4 del mismo documento). El Director General aprovecha la oportunidad para expresar su agradecimiento y su estima a los dos anteriores miembros del Consejo Consultivo, Dra. María Consuelo López-Zumel, de España, y Profesor Shintaro Furusaki, del Japón, por su valiosa contribución a los trabajos del Consejo Consultivo Científico.
4. El Director General había recibido para julio de 2001 dos propuestas de candidatura, ambas de candidatos muy idóneos, de los Gobiernos del Japón y de la República Checa respectivamente. No habiendo otras propuestas de candidatura y considerando el reconocido prestigio científico de los dos candidatos en campos de interés para la OPAQ y para la labor del Consejo Consultivo Científico, el Director General ha decidido ofrecerles sendos puestos en el Consejo Consultivo. Al mismo tiempo, ofreció prórroga a aquellos miembros del Consejo Consultivo que habían expresado su disposición a desempeñar un segundo mandato.

5. El Director General ha recibido ya cartas de aceptación de todos los expertos a los que había ofrecido un puesto en el Consejo Consultivo. Es su deseo informar a los Estados Miembros, con el anexo a la presente nota, de la composición del Consejo Consultivo Científico para el periodo de tres años que va de julio de 2001 a julio de 2004. Ralf Trapp continuará desempeñándose como Secretario del Consejo Consultivo.
