# MEETING OF GOVERNMENT EXPERTS TO REVIEW THE FINDINGS SUBMITTED BY THE SCIENTIFIC ADVISORY BOARD TO THE FIRST REVIEW CONFERENCE THE HAGUE, 12 – 14 NOVEMBER 2003

- 1. Having consulted with the Chairman of the Executive Council (hereinafter "the Council"), and following the recommendation of the First Special Session of the Conference of the States Parties to Review the Operation of the Chemical Weapons Convention (First Review Conference) (subparagraph 7.30 of RC-1/5, dated 9 May 2003), the Technical Secretariat (hereinafter "the Secretariat") wishes to inform States Parties that a meeting of government experts will be convened under the auspices of the Council to review the observations and recommendations in the Note by the Director-General entitled "Report of the Scientific Advisory Board on Developments in Science and Technology" (RC-1/DG.2, dated 23 April 2003).
- 2. The meeting will be held from 12 to 14 November 2003 in the Ieper Room of OPCW headquarters, with morning sessions from 10:00 to 12:30 and afternoon sessions from 14:30 to 17:00. The meeting will be conducted in English. A provisional programme is annexed hereto.
- 3. The aims of the meeting are to review RC-1/DG.2 and to prepare a report to the Council so as to enable it to begin work on the recommendations it was requested to prepare for the Conference of the States Parties.
- 4. States Parties are invited to nominate experts to participate in the meeting.
