NOTE BY THE TECHNICAL SECRETARIAT

AN INVITATION TO PARTICIPATE IN THE SIXTH ANNUAL MEETING OF NATIONAL AUTHORITIES THE HAGUE 26 – 28 NOVEMBER 2004

- 1. The Technical Secretariat (hereinafter "the Secretariat") wishes to invite the personnel of National Authorities to participate in the Sixth Annual Meeting of National Authorities, to be held at OPCW headquarters in The Hague from 26 to 28 November 2004.
- 2. The Meeting is designed as a forum for personnel from National Authorities who are involved daily with issues surrounding the national implementation of the Chemical Weapons Convention (hereinafter "the Convention"). Individuals nominated to participate in the Meeting should actually be responsible for the specific tasks involved in implementing the Convention at the national level.
- 3. The Secretariat also invites representatives from national parliaments to participate at the Meeting in discussions of the role of parliaments in the implementation of the Convention, as well as to consider ways and means of increasing awareness of the Convention amongst parliamentarians and thus of enhancing their involvement in the implementation of obligations under the Convention.
- 4. The overall objective of the Meeting is to help States Parties to increase their national capacity to comply with their obligations under the Convention. Its specific aims are to:
 - (a) facilitate the exchange of information and experiences regarding the implementation of the Convention and to promote cooperation amongst National Authorities;
 - (b) identify common implementation problems and facilitate their resolution through cooperative efforts by States Parties and the Secretariat;
 - (c) contribute to greater self-sufficiency as regards national-implementation capacities; and

- (d) enhance awareness of activities relating to international cooperation under the Convention.
- 5. Each year the Meeting has a thematic focus. This year it will be on the role that parliaments can play in the implementation of the Convention, and particularly on how cooperation between National Authorities and parliaments can be improved to this end. As at the date of this Note, 41% of States Parties had yet to submit information on the legislative and administrative measures they had taken in order to implement the Convention within their jurisdictions. In some cases, delays are caused by the fact that implementing legislation is still passing through the various stages of the review and approval required for its consistency and effectiveness. Parliaments play an important role, because they are responsible for the timely review and approval of this legislation.
- 6. In order for the Convention to be fully implemented, National Authorities and parliaments need to work closely together. The thematic segment of the Meeting will therefore be devoted to improving cooperation and fostering partnership between National Authorities and parliaments for the purpose of implementing the Convention. This segment of the Meeting will be entitled "The Role of Parliaments in the Implementation of the Chemical Weapons Convention" and will focus on the role that parliaments should play in facilitating the implementation of the Convention in their respective countries. It will thus help achieve the objectives of the plan of action regarding the implementation of Article VII obligations, which was adopted by the Conference of the States Parties at its Eighth Session (C-8/DEC.16, dated 24 October 2003). The Secretariat is holding consultations with the Inter-Parliamentary Union on ways in which it can provide assistance in organising this segment.
- 7. National Authorities are invited to submit applications to participate in the Meeting itself, along with applications from members of their national parliaments to participate in the thematic segment devoted to the role of parliaments in the implementation of the Convention.
- 8. There will be three parts to the Meeting:
 - (a) the aforementioned thematic segment on the role of parliaments, which will take place on 26 November 2004;
 - (b) an information update and an exchange of experiences among National Authorities, which will be held on 27 November 2004; and
 - (c) consultations between individual National Authorities and Secretariat officials on implementation issues, which will take place on 28 November 2004.
- 9. The presence in The Hague of the representatives of many National Authorities, in conjunction with the Ninth Session of the Conference of the States Parties, will provide a unique opportunity for these representatives to meet with Secretariat officials to discuss issues of specific interest to individual States Parties, and the morning of Sunday, 28 November 2004 will therefore be reserved for this purpose.

National Authorities are therefore requested to provide the Secretariat with advance notice of the particular national-implementation issues they would like to discuss with it, so that the Secretariat officials responsible for these issues can prepare to discuss them. During the Meeting, the Secretariat may also invite participants to bilateral discussions of implementation issues.

- 10. Interpretation services will be provided in the official languages of the Convention at the following times only:
 - (a) on Friday, 26 November, during the thematic segment devoted to the role of parliaments in the implementation of the Convention;
 - (b) on the morning of Saturday, 27 November, during the discussions on the status of implementation of the Convention; and
 - (c) on the afternoon of the same day, during the review of the discussions that will have taken place within the regional groups.
- 11. No interpretation services will be available either on 28 November, for meetings of regional groups, or for individual consultations.
- 12. The Secretariat expects to be able to sponsor the participation of a limited number of participants, including parliamentarians, in the Meeting. Each nomination should specify whether sponsorship is a condition of the nominee's participation. For sponsored participants, the Secretariat will cover the costs of travel, meals, accommodation, and medical insurance, and will provide a limited subsistence allowance to cover sundry expenses. In cases where the Secretariat arranges accommodation for sponsored participants, it will also cover the costs of that accommodation. Sponsored participants who do not intend to use the accommodation provided by the Secretariat are requested to indicate that as soon as possible, so that it does not incur hotel cancellation fees. The daily subsistence allowance will remain unchanged for those participants who opt to make their own accommodation arrangements.
- When making travel arrangements for sponsored participants, the Secretariat will seek 13. the most economical options. The Secretariat will purchase tickets and send them to participants. Participants will be allowed to purchase tickets locally only if this leads to further savings for the Secretariat and if the Secretariat authorises it. In order for the Secretariat to keep costs to a minimum, sponsored participants are expected to arrive no earlier than Thursday, 25 November 2004, and to depart no later than Monday, 29 November 2004. Participants wishing to stay in The Hague to participate in the Ninth Session of the Conference of the States Parties must inform the Secretariat of their intended return date so that appropriate arrangements can be made. The Secretariat's agreement is required for any changes to the arrival and departure dates of sponsored participants. The Secretariat will not cover expenses unrelated to the Meeting or that result from changes in travel arrangements it has not authorised. Sponsored participants shall bear all costs resulting from changes they make, including cancellations, once the Secretariat has purchased tickets. Participants who have not been sponsored are requested to make their own travel and accommodation

arrangements, although the Secretariat can, if necessary, arrange accommodation at reduced rates.

14. Participants are requested to obtain any necessary visas (including transit visas) before travelling to the Netherlands. Participants requiring an entry visa for the Netherlands are advised to contact the nearest diplomatic mission of the Netherlands as soon as possible.
