### NOTE BY THE TECHNICAL SECRETARIAT

## CALL FOR NOMINATIONS FOR THE TENTH ANNUAL MEETING OF NATIONAL AUTHORITIES THE HAGUE, THE NETHERLANDS 28 – 30 NOVEMBER 2008

- 1. The Technical Secretariat (hereinafter "the Secretariat") wishes to invite National Authorities to submit nominations for the Tenth Annual Meeting of National Authorities, which will be held at OPCW headquarters in The Hague from 28 to 30 November 2008.
- 2. The Meeting is designed as a forum for personnel from National Authorities who are involved daily with issues surrounding the national implementation of the Chemical Weapons Convention (hereinafter "the Convention").
- 3. Each year, the Meeting of National Authorities includes a thematic segment. This year, the thematic segment will take place on 28 November and will be devoted to the role of industry in the implementation of the Convention, with the focus being on recent developments relating to Article VI Industry Declarations and Verification.
- 4. The objectives of the Meeting are to:
  - (a) facilitate States Parties' efforts to increase their national capacity to comply with their obligations under the Convention;
  - (b) facilitate the exchange of information and experiences regarding the implementation of the Convention;
  - (c) promote cooperation among National Authorities;
  - (d) identify common implementation problems and facilitate their resolution through the cooperative efforts of States Parties and the Secretariat; and
  - (e) enhance awareness of activities relating to international cooperation under the Convention.

- 5. National Authorities are invited to nominate representatives who have been or will be directly involved in the implementation of the Convention, particularly in preparing Article VI declarations. Industry representatives and professional industry associations are also invited to attend the meeting.
- 6. During the thematic segment on 28 November, discussions on specific Article VI issues will take place.
- 7. On 29 November, National Authorities will be provided with information on the issues to be discussed during the Thirteenth Session of the Conference of the States Parties (hereinafter "the Conference") and on the progress made in implementing Article VII of the Convention. This will also be an opportunity for National Authorities to meet in their respective regional groups to identify key areas for the Secretariat's implementation-support programmes in 2009.
- 8. The Presidency of the European Union has informed the Technical Secretariat of their intention to host an EU sponsored event on capacity building for National Authorities on 1 December at the OPCW Headquarters. Further information on this event will be provided separately.
- 9. The presence in The Hague of the representatives of many National Authorities, in conjunction with the Thirteenth Session of the Conference, will provide a unique opportunity for these representatives to meet with Secretariat officials to discuss issues of specific interest to individual States Parties, and the morning of Sunday, 30 November 2008 will be reserved for this purpose. National Authorities are therefore requested to inform the Secretariat beforehand of the particular national implementation issues they would like to discuss with it, so that the Secretariat officials responsible for them can come prepared to the consultations. During the Meeting, the Secretariat may also invite participants to discuss implementation issues bilaterally. National Authorities that wish to discuss draft legislation are encouraged to submit the draft and to contact the Office of the Legal Adviser (LAO) in advance of the Meeting to discuss their specific needs. - 10. Interpretation services will be provided in the official languages of the OPCW only on Friday, 28 and Saturday, 29 November. No interpretation services will be available in the regional group meetings on 29 November or in the morning of 30 November.
- 11. The Secretariat expects to be able to sponsor the participation of a limited number of officials from National Authorities. Each nomination should specify whether sponsorship is a condition of the nominee's participation. For sponsored participants, the Secretariat will cover the costs of travel, meals, accommodation, and medical insurance, and will provide a limited subsistence allowance to cover sundry expenses. Sponsored participants who do not intend to use the accommodation provided by the Secretariat are requested to indicate that as soon as possible, so that it does not incur hotel cancellation fees. In any case, the Secretariat will not cover the costs of any accommodation it has not arranged.

- 12. When making travel arrangements for sponsored participants, the Secretariat will seek the most economical options. It will purchase tickets and send them to participants. Participants will be allowed to purchase tickets locally only if this leads to further savings for the Secretariat and if the Secretariat authorises it. In order for the Secretariat to keep costs to a minimum, sponsored participants are expected to arrive no earlier than Thursday, 27 November 2008, and to depart no later than Monday, 1 December 2008. Participants wishing to stay in The Hague so that they can participate in the Thirteenth Session of the Conference must inform the Secretariat of their intended return date so that appropriate arrangements can be made. Please note that any additional overnight stays by sponsored participants in connection with the Thirteenth Session of the Conference will be at their own expense.
- 13. The Secretariat's agreement is required for any changes to the arrival and departure dates of sponsored participants. The Secretariat will not cover expenses unrelated to the Meeting or that result from changes in travel arrangements it has not authorised. Sponsored participants shall bear all costs resulting from changes they make, including cancellations, once the Secretariat has purchased tickets. Participants who have not been sponsored are requested to make their own travel and accommodation arrangements, although the Secretariat can, if necessary, arrange accommodation at reduced rates.
- 14. Participants are requested to obtain any necessary visas (including transit visas) before travelling to the Netherlands. Participants requiring an entry visa for the Netherlands are advised to contact the nearest diplomatic mission of the Netherlands as soon as possible. Participants who need further assistance may contact the Protocol and Visa Branch of the Secretariat by phone at +31 (0)70 416 3777 or by fax at +31 (0)70 306 3890.
- 15. Interested National Authorities are invited to complete a separate nomination form for each nominee (see Annex 2 to this Note), making sure in particular to provide all the contact details it requests. Please note that any applications received after 6 October 2008 will not be considered for sponsorship. Furthermore, please be advised that participants must present an OPCW acceptance letter in order to register at the Meeting.
