NOTE BY THE DIRECTOR-GENERAL

CALL FOR NOMINATIONS FOR A REGIONAL WORKSHOP ON ASSISTANCE AND PROTECTION UNDER ARTICLE X OF THE CHEMICAL WEAPONS CONVENTION AND ISSUES OF REGIONAL COORDINATION BUENOS AIRES, ARGENTINA 15 – 17 OCTOBER 2013

- 1. On behalf of the Government of Argentina and the Organisation for the Prohibition of Chemical Weapons (OPCW), the Director-General wishes to invite States Parties in Latin America and the Caribbean to submit nominations for a regional workshop on Article X and issues of regional coordination in the area of assistance and emergency response, to be held from 15 to 17 October 2013 in Buenos Aires, Argentina. The workshop will be conducted under the European Union Council Decision 2012 on support for OPCW activities.
- 2. This workshop is designed as a forum for managers, planners, and policy makers who are involved in the protection of their civilian populations against chemical weapons and incidents involving toxic industrial chemicals, or who would be responsible for the provision of emergency assistance under Article X of the Chemical Weapons Convention (hereinafter "the Convention"). It will provide information on the following:
 - (a) The Convention and the status of implementation of its Article X;
 - (b) Preparedness of the OPCW to respond in case of a request for assistance;
 - (c) Regional coordination issues related to delivery of assistance and emergency response; and
 - (d) Regional approaches to capacity-building in assistance and protection.
- 3. The workshop will provide an overview of assistance and protection activities in the region and is intended to foster comprehensive discussion and analysis of assistance-and-protection-related issues in accordance with Article X of the Convention, with special focus on matters related to regional coordination and delivery of emergency assistance in cases of chemical attack and incidents involving toxic industrial chemicals. Working sessions will be conducted in order to identify strengths and weaknesses, as well as to develop recommendations aimed at reinforcing the emergency-response capabilities of the region.
- 4. The Secretariat expects to be able to sponsor the attendance at the workshop of a limited number of participants from States Parties of the Latin America and Caribbean

regional group. Each nomination should specify whether sponsorship is a condition of the nominee's participation. For sponsored participants, the Secretariat will cover the costs of travel, medical insurance, accommodation, and meals, and will provide a limited subsistence allowance to cover sundry expenses. Further details regarding accommodation, the workshop venue, and transport will be issued to all confirmed participants at a later date. The workshop will be held in the Spanish language; no interpretation services will be available.

- 5. When making travel arrangements for sponsored participants, the Secretariat will seek the most economical options. Participants are expected to arrive **no earlier than Monday, 14 October 2013** and to depart **no later than Saturday, 19 October 2013**. The Secretariat's approval is required for any changes to the arrival and departure dates of sponsored participants. The Secretariat will not cover expenses unrelated to the workshop, or that result from unauthorised changes to travel arrangements. Sponsored participants shall bear all costs resulting from changes they make, including cancellations, once the Secretariat has purchased their tickets. Selected participants who are not sponsored are requested to make their own travel arrangements.
- 6. Each State Party represented at the workshop will be required to give a presentation lasting from 7 to 10 minutes on its national emergency-response system, which will provide information on the general, legal, and coordination requirements, as well as other elements that could enhance the individual and collective response capability in the region.
- 7. Participants are requested to obtain all necessary visas, including transit visas, before travelling to Argentina.
- 8. Interested applicants are invited to complete the nomination form that is included as Annex 2 to this Note, making sure in particular to provide all the contact details it requests. Completed nomination forms should be sent, along with a brief curriculum vitae, to the Director, International Cooperation and Assistance Division, OPCW, Johan de Wittlaan 32, 2517 JR The Hague, the Netherlands. They may also be submitted by fax to +31 (0)70 416 3209, or by e-mail to EmergAssistBr@opcw.org. All materials must be received by the Secretariat no later than 31 August 2013. Please be advised that participants must present an OPCW acceptance letter in order to register for the workshop.
- 9. Those individuals who have been selected to participate will be contacted no later than two weeks after the submission deadline. States Parties are requested to inform the International Cooperation and Assistance Division (ICA) of any administrative or other problems that may arise in connection with the attendance of any participant.
- 10. The provisional programme for the workshop is included as Annex 1 to this Note; further details will be issued at a later date.
