### NOTE BY THE TECHNICAL SECRETARIAT

#### **SUBMISSION OF ANNUAL DECLARATIONS ON PAST ACTIVITIES FOR 2012 AND 2013, ON PROJECTED ACTIVITIES AND ANTICIPATED PRODUCTION IN 2014 AT SCHEDULE 1 FACILITIES, AND ON ANTICIPATED ACTIVITIES AT SCHEDULE 2 AND 3 PLANT SITES IN 2014 AS AT 31 MARCH 2014**

1. According to paragraph 8 of Article VI of the Chemical Weapons Convention (hereinafter “the Convention”), “Each State Party shall make annual declarations regarding the relevant chemicals and facilities in accordance with the Verification Annex”.
2. According to paragraph 8 of Article VI and Parts VI, VII, VIII, and IX of the Verification Annex to the Convention (hereinafter “the Verification Annex”), States Parties shall submit annual declarations on past activities (ADPAs) in relation to scheduled chemicals and related facilities, and each year shall submit the information necessary to update the list of other chemical production facilities not later than 90 days after the end of the previous calendar year.
3. The deadline for the submission of ADPAs for 2013 was thus 31 March 2014. The 78 States Parties listed in Annex 1 submitted their ADPAs by that deadline, in comparison with 59 submitted by the deadline last year. This is a significant increase, with 19 (32%) more ADPAs submitted compared to last year.
4. Further to the information provided in S/1089/2013 (dated 24 April 2013) on the submission of the ADPAs for 2012, Annex 2 to the present Note lists the 93 States Parties (of the 188 that had joined the Convention by the end of 2012) that had submitted ADPAs for 2012 by 31 March 2014.
5. According to paragraph 16 of Part VI of the Verification Annex, “Each State Party producing Schedule 1 chemicals at a single small-scale facility shall make a detailed annual declaration regarding the projected activities and the anticipated production at the facility for the coming year”. It further requires that the declaration “shall be submitted not less than 90 days before the beginning of that year”. In addition, paragraph 20 of Part VI of the Verification Annex requires the same of each State Party producing Schedule 1 chemicals at other facilities referred to in paragraphs 10 and 11 of Part VI of the Verification Annex.



6. Further to the information provided in S/1133/2013 (dated 21 October 2013) on the submission of annual declarations regarding projected activities and anticipated production at Schedule 1 facilities in 2014, Annex 3 to the present Note lists the 24 States Parties (of the 190 as at 31 December 2013) that had submitted their declarations for 2014 by 31 March 2014, of which two were nil declarations.
7. According to subparagraph 4(c) of Part VII of the Verification Annex, each State Party shall submit annual declarations on anticipated activities (ADAAs) at Schedule 2 plant sites not later than 60 days before the beginning of the following calendar year, while subparagraph 4(c) of Part VIII requires the same of each State Party for plant sites producing Schedule 3 chemicals.
8. Further to the information provided in S/1139/2013 (dated 18 November 2013) on the submission of ADAAs for 2014, Annex 4 to the present Note lists the 48 States Parties (of the 190 as at 31 December 2013) that had submitted ADAAs for 2014 by 31 March 2014. This is an increase of eight in the number of States Parties that submitted ADAAs since the above-mentioned report.
