## NOTE BY THE TECHNICAL SECRETARIAT

## STATUS OF SUBMISSION OF ANNUAL DECLARATIONS REGARDING ANTICIPATED ACTIVITIES AT SCHEDULE 2 AND 3 PLANT SITES IN 2015

- 1. Paragraph 8 of Article VI of the Chemical Weapons Convention (hereinafter "the Convention"), states that "[e]ach State Party shall make annual declarations regarding the relevant chemicals and facilities in accordance with the Verification Annex".
- 2. Part VII of the Verification Annex to the Convention (hereinafter "the Verification Annex") covers the regime for Schedule 2 chemicals and facilities related to them. According to subparagraph 4(c) of that Part, each State Party shall submit annual declarations on anticipated activities "not later than 60 days before the beginning of the following calendar year".
- 3. Subparagraph 4(c) of Part VIII of the Verification Annex requires the same of each State Party for plant sites producing Schedule 3 chemicals.
- 4. The deadline for the submission of these declarations for 2015 was thus 1 November 2014. The States Parties listed below met that deadline.
