# NOTE BY THE DIRECTOR-GENERAL

# CALL FOR NOMINATIONS FOR THE FOURTEENTH REGIONAL MEETING OF NATIONAL AUTHORITIES OF STATES PARTIES IN EASTERN EUROPE LJUBLJANA, SLOVENIA 26 – 28 MAY 2015

- 1. On behalf of the Government of the Republic of Slovenia and the Organisation for the Prohibition of Chemical Weapons (OPCW), the Director-General wishes to invite National Authorities to nominate representatives to attend the Fourteenth Regional Meeting of National Authorities of States Parties in Eastern Europe, which will be held in Ljubljana, Slovenia, from 26 to 28 May 2015. The meeting is designed to provide an opportunity for interaction amongst personnel of National Authorities who are involved with the national implementation of the Chemical Weapons Convention (hereinafter "the Convention"). Nominees should therefore be responsible for carrying out such tasks on a day-to-day basis.
- 2. The purpose of the meeting is to provide a forum for representatives of National Authorities in Eastern Europe to review and discuss issues related to the practical implementation of the Convention, to share best practices and challenges, and to present their needs for assistance in relation to Article VII and indicate what assistance they can offer to other States Parties in this regard. The programme for the meeting includes the following:
  - (a) a review of the current status of the implementation of the Convention and new approaches and initiatives in this regard;
  - (b) a review of recent developments and updates, including those regarding the implementation of Article VI of the Convention;
  - (c) deliberation of legislative and administrative aspects and requirements;
  - (d) discussion of and recommendations on education, outreach, and awareness-raising issues;
  - (e) assessment and identification of priorities for effective national implementation of the Convention; and
  - (f) bilateral meetings with Secretariat staff.

- 3. In view of the fact that the programme is designed to be interactive and participatory, all participants will be expected to take an active part in the discussions and to make presentations in order to share their national experiences and best practices on the topics discussed during the meeting.
- 4. The provisional programme for the meeting is included as Annex 1 to this Note.
- 5. The Technical Secretariat (hereinafter "the Secretariat") expects to be able to sponsor the attendance at the meeting of one representative from each National Authority in the region. Each nomination should specify whether sponsorship is a condition of the nominee's participation.
- 6. For sponsored participants, the Secretariat will cover the costs of travel, meals, and medical insurance, and will provide a limited subsistence allowance to cover sundry expenses. The Secretariat will also arrange and pay for accommodation for sponsored participants. Sponsored participants who do not intend to use the accommodation arranged by the Secretariat are requested to indicate this as soon as possible so that hotel cancellation fees are not incurred. In any case, the Secretariat will not cover the costs of any accommodation it has not arranged.
- 7. When making travel arrangements for sponsored participants, the Secretariat will seek the most economical options. The Secretariat will purchase tickets and send them to participants. Participants will be allowed to purchase tickets locally only if this leads to further savings and if the Secretariat authorises it, in order to keep costs to a minimum. Participants are expected to arrive no earlier than Monday, 25 May 2015, and to depart no later than Friday, 29 May 2015. The Secretariat's agreement is required for any changes to these arrival and departure dates.
- 8. The Secretariat will not cover expenses unrelated to the meeting or that result from changes in travel arrangements that it has not authorised. Sponsored participants shall bear all costs resulting from changes they make, including cancellations, once the Secretariat has purchased tickets.
- 9. Participants are requested to obtain any necessary visas (including transit visas) before travelling to Ljubljana. When applying for any required visas, they should present the Embassy or Consulate of Slovenia with a copy of the acceptance letter from the OPCW. Participants are required to approach the Embassy or Consulate of Slovenia immediately after receiving their acceptance letter issued by the OPCW.
- 10. All activities during the meeting will be conducted in English. Participants are therefore expected to have a good oral and written command of this language.
- 11. Interested National Authorities are invited to complete the nomination and the endorsement forms that are included as Annex 2 and Annex 3 to this Note, making sure in particular to provide all requested contact details. Completed forms should be addressed to: Director, International Cooperation and Assistance Division, OPCW, Johan de Wittlaan 32, 2517 JR The Hague, the Netherlands. All forms must be received by the Secretariat **no later than Monday, 30 March 2015**. National Authorities are kindly requested to note that the Secretariat will not accept any nominations after the final nominations deadline.

Please be advised that participants must present an OPCW acceptance letter in order to register for the regional meeting.
