NOTE BY THE DIRECTOR-GENERAL

CALL FOR NOMINATIONS FOR THE TWENTY-FIRST REGIONAL MEETING OF NATIONAL AUTHORITIES OF STATES PARTIES IN LATIN AMERICA AND THE CARIBBEAN LA PAZ, PLURINATIONAL STATE OF BOLIVIA 2 – 4 JUNE 2020

- 1. On behalf of the Government of the Plurinational State of Bolivia and the Organisation for the Prohibition of Chemical Weapons (OPCW), the Director-General wishes to invite National Authorities to nominate representatives to attend the Twenty-first Regional Meeting of National Authorities of States Parties in Latin America and the Caribbean, which will be held in La Paz, the Plurinational State of Bolivia, from 2 to 4 June 2020.
- 2. At its Eighth Session, the Conference of the States Parties (hereinafter "the Conference") adopted a plan of action regarding the implementation of obligations under Article VII of the Chemical Weapons Convention (hereinafter "the Convention") (C-8/DEC.16, dated 24 October 2003). On many occasions, States Parties have highlighted the value of a comprehensive and integrated approach to national implementation that is in line with each State Party's constitutional requirements, and aimed at filling gaps in national implementation and ensuring that national implementation measures address the specific needs of each State Party and are consistent with the provisions of the Convention.
- 3. The Twenty-first Regional Meeting of National Authorities, which is to be held from 2 to 4 June 2020, will serve as a forum in which States Parties in the region can address various national implementation issues and the National Implementation Framework, as well as the region's needs and priorities for capacity-building programmes and activities organised by the Technical Secretariat (hereinafter "the Secretariat"), and other issues relating to the Convention. National Authorities will also share good practices and challenges in acting as focal points for effective liaison with the OPCW for national implementation of the Convention.
- 4. The objectives for the meeting are to discuss:
 - (a) good practices, issues, and challenges in national implementation of the Convention;
 - (b) regional priorities and capacity-building needs for Latin America and the Caribbean;

- (c) the status of implementation of the Article VII of the Convention, specifically the adoption of national implementing legislation;
- (d) the assessment of the impact of International Cooperation and Assistance Division programmes;
- (e) good practices and experiences in addressing chemical safety and security issues as well as enhancing the capabilities of chemical laboratories;
- (f) recent developments and updates, including those regarding the implementation of Article VI of the Convention; and
- (g) approaches and ways to further improve capacity-building programmes that meet the specific needs of States Parties in Latin America and the Caribbean, and ways to enhance regional cooperation.
- 5. The expected results of the meeting include the following:
 - (a) enhanced understanding of the needs and priorities of States Parties in Latin America and the Caribbean on national implementation of the Convention to inform future planning of assistance and cooperation activities;
 - (b) increased awareness among States Parties on modalities for further enhancing national implementation of the Convention;
 - (c) increased understanding on the current status and challenges facing States Parties in Latin America and the Caribbean in the adoption of national implementing legislation;
 - (d) enhanced understanding of good practices, needs and requirements in chemical safety and security, and available capacity-building programmes and activities;
 - (e) increased awareness of the benefits, results, and impact of participation in OPCW capacity-building activities, such as the National Authority Mentorship/Partnership Programme; and
 - (f) enhanced awareness among States Parties of the benefits and concrete results of participating in OPCW capacity-building programmes and activities, and the collection of feedback on the needs of States Parties and means of improving programme delivery.
- 6. The provisional programme for the regional meeting is attached as Annex 1 to this Note.
- 7. The Secretariat expects to be able to sponsor one participant from each State Party from the region. The nominee should be a representative of the National Authority. The nomination should specify whether sponsorship is a condition of the nominee's participation.

- 8. For sponsored participants, the Secretariat will cover the costs of travel, accommodation, meals, and medical insurance, and will provide a limited subsistence allowance to cover terminal and sundry expenses. Sponsored participants who do not intend to use the accommodation arranged by the Secretariat are requested to indicate this as soon as possible to prevent the Secretariat from incurring hotel cancellation fees. In any case, the Secretariat will not cover the costs of any accommodation that it has not arranged.
- 9. When making travel arrangements for sponsored participants, the Secretariat will seek the most economical options. The Secretariat will purchase tickets and send them to the participants. Participants will be allowed to purchase tickets locally only if the Secretariat authorises it and if it leads to further savings for the Secretariat. Sponsored participants must bear all costs resulting from any changes they make once the Secretariat has purchased the tickets. Participants who have not been sponsored will be requested to make their own travel and accommodation arrangements. In order to keep costs to a minimum, sponsored participants are expected to arrive **no earlier than Monday, 1 June 2020** and to depart **no later than Friday, 5 June 2020**.
- 10. Participants are requested to obtain any necessary visas (including transit visas) before travelling to the Plurinational State of Bolivia. When applying for any entry visa, they should present the Embassy or Consulate of the Plurinational State of Bolivia with a copy of the acceptance letter from the OPCW.
- 11. The meetings will be conducted in English and Spanish, and interpretation services will be provided between these two languages.
- 12. Interested National Authority representatives are invited to register their nomination online **no later than 14 April 2020** through Eventus—the OPCW event management system (https://apps.opcw.org/eventus). Each nomination must be accompanied by an endorsement form from the candidate's respective National Authority (Annex 2, Part A) and a completed questionnaire (Annex 2, Part B). Annex 2 (Parts A and B) should be uploaded in Eventus during the registration process. National Authorities are kindly requested to note that the Secretariat will not accept any nominations submitted after the deadline or incomplete nominations that do not contain responses to Annex 2 (Part B).
