The decision reflected the concern of States Parties that the Convention adapts to new challenges and remaining current at all times. I am happy to inform that, in order to give effect to their Decision, India has already commenced work to incorporate required changes to its national legislation. We are confident of completing this process before June 7, 2020, as per the timeline laid out in Article XV of the CWC.

My delegation is pleased to draw the attention of all delegations to a Course on Analytical Skills Development, hosted by India in collaboration with the Technical Secretariat, at the Indian Institute of Chemical Technology, Hyderabad from November 25 to December 6, 2019. Nineteen participants from eighteen countries of Africa, Asia, Eastern Europe and Latin America region attended the Course. We were satisfied with the success of the Course as well as our collaboration with the OPCW. India will continue to contribute towards all efforts to promote the peaceful uses of chemical technology and enhancing international cooperation in this field.

We urge further discussions and deliberation on the matter keeping in mind the limitations imposed by the Convention.
