



**NOTE BY THE TECHNICAL SECRETARIAT**

**SUBMISSION OF ANNUAL DECLARATIONS ON PAST ACTIVITIES  
FOR 2018 AND 2019, PROJECTED ACTIVITIES AND ANTICIPATED PRODUCTION  
AT SCHEDULE 1 FACILITIES IN 2020, AND ANTICIPATED ACTIVITIES  
AT SCHEDULE 2 AND 3 PLANT SITES IN 2020, AS AT 30 MARCH 2020**

1. According to paragraph 8 of Article VI of the Chemical Weapons Convention (hereinafter “the Convention”), “[e]ach State Party shall make annual declarations regarding the relevant chemicals and facilities in accordance with the Verification Annex”.
2. According to paragraph 8 of Article VI and Parts VI, VII, VIII, and IX of the Verification Annex to the Convention (hereinafter “the Verification Annex”), States Parties shall submit annual declarations on past activities (ADPAs) in relation to scheduled chemicals and related facilities, and each year shall submit the information necessary to update the list of other chemical production facilities not later than 90 days after the end of the previous calendar year.
3. The deadline for the submission of ADPAs for 2019 was thus 30 March 2020. Annex 1 lists the 57 States Parties with declarable activities, plus the five States Parties with nil declarations, which submitted their ADPAs by that deadline. These figures represent a decrease in the number of States Parties submitting their ADPAs on time compared to 2018, when 84 States Parties with declarable activities, plus four States Parties with nil declarations, submitted their ADPAs by the deadline. The impact of the outbreak of the novel coronavirus (COVID-19) may be one factor that could explain the cause of this decrease.
4. In line with Executive Council decision EC-51/DEC.1, dated 27 November 2007, concerning the timely submission by States Parties of declarations under Article VI of the Convention, paragraph 4 requests “States Parties that anticipate difficulties in regard to the timely submission of their declarations [...] to inform the Secretariat at the earliest possible date of the circumstances of such difficulties”. Canada, Denmark, Norway, and Portugal are States Parties that provided such information, naming the COVID-19 pandemic as a factor causing anticipated delays in the timely submission of their 2019 ADPAs.
5. With regard to 2018 ADPAs, eight States Parties with declarable activities submitted their ADPAs after the deadline of 31 March 2019. Further to the information provided in S/1743/2019, dated 17 April 2019, on the status of submission of annual declarations for projected activities in 2020 at Schedule 1 facilities, Annex 2 to this



Note lists the 92 States Parties with declarable activities, plus 11 States Parties with nil declarations, that submitted their ADPAs for 2018 by 30 March 2020.

6. As for Schedule 1 projected activities, according to paragraph 16 of Part VI of the Verification Annex, “[e]ach State Party producing Schedule 1 chemicals at a single small-scale facility shall make a detailed annual declaration regarding the projected activities and the anticipated production at the facility for the coming year”. It further requires that the declaration “shall be submitted not less than 90 days before the beginning of that year”. In addition, paragraph 20 of Part VI of the Verification Annex requires the same of each State Party producing Schedule 1 chemicals at other facilities referred to in paragraphs 10 and 11 of Part VI of the Verification Annex.
7. One State Party submitted its annual declaration on projected activities and anticipated production at Schedule 1 facilities for 2020 after the deadline of 2 October 2019. Further to the information on the status of submission of annual declarations on projected activities in 2020 at Schedule 1 facilities provided in S/1800/2019, dated 8 October 2019, Annex 3 to this Note lists the 23 States Parties with projected activities and anticipated production at Schedule 1 facilities, plus 13 States Parties with nil declarations that submitted their 2020 declarations by 30 March 2020.
8. With regard to annual declarations of anticipated activities (hereinafter “ADAAs”), according to subparagraph 4(c) of Part VII of the Verification Annex, each State Party shall submit ADAAs at Schedule 2 plant sites “not later than 60 days before the beginning of the following calendar year”, while subparagraph 4(c) of Part VIII requires the same of each State Party for plant sites producing Schedule 3 chemicals.
9. Two States Parties with declarable activities submitted their 2020 ADAAs for Schedule 2 and/or Schedule 3 plant sites after the deadline of 1 November 2019. Further to the information on the status of submission of 2020 ADAAs for Schedule 2 and Schedule 3 plant sites provided in S/1810/2019, dated 13 November 2019, Annex 4 to this Note lists the 43 States Parties with declarable activities, plus the 18 States Parties with nil declarations, that submitted 2020 ADAAs for Schedule 2 and Schedule 3 plant sites by 30 March 2020.
