CURRICULUM VITAE OF CANDIDATE



Mr Hans-Christian Mangelsdorf

Having served in different positions at German Embassies abroad inter alia in the Hashemite Kingdom of Jordan, South Africa and Egypt and at FFO headquarters in Berlin, Mr Mangelsdorf is currently the Head of Division for Early Warning Processes and Instruments overseeing big data analysis, artificial intelligence application development and digitalization efforts.

Between 2016 and 2017, he was in charge of the German Federal Foreign Office's stabilization portfolio for Sub-Sahara Africa, Asia, Europe and Latin America.

Starting in 2018 and until assuming his current position, he was responsible for the UN – budgetary and management dossier. This included oversight over Germany's assessed contribution to the UN, the Fifth Committee and wider UN budgetary and administrative issues across funds, programs and specialized agencies in the system.

Before joining the German Federal Foreign Office in 2006, Mr Mangelsdorf obtained degrees in economics, finance and business administration from Leipzig University and Université Lyon 2. He holds degrees as Diplom-Volkswirt, Diplom-Betriebswirt and a Maitrise en Finance.

Mr Mangelsdorf currently serves as a Member on the Advisory Body for Administration and Finance of the OPCW in The Hague and as Member on the Consultative Advisory Group of the International Public Sector Accounting Standards Board (IPSASB).
