NOTE BY THE TECHNICAL SECRETARIAT

OPCW CALENDAR FOR MARCH TO DECEMBER 2021

1. The calendar annexed hereto lists the events organised by the OPCW in the period from March to December 2021. It includes also the sessions of the policy-making organs and their subsidiary bodies. It does not include consultations of an informal nature or other activities of the Executive Council; these are reflected in the OPCW weekly Journal.
2. In light of the restrictions posed by the current pandemic (COVID-19) and in line with the measures adopted by the OPCW Host Country Government, the Technical Secretariat (hereinafter “the Secretariat”) is regularly reviewing the feasibility of the planned events and their delivery format. This may require further updating of this list as conditions evolve. The Secretariat is committed to resuming the in-person format of delivery as soon as conditions permit, while actively pursuing the provision of capacity-building support through alternative means in the form of remote online sessions.
