#### NOTE BY THE TECHNICAL SECRETARIAT

### INFORMATION PROVIDED BY THE SYRIAN ARAB REPUBLIC FOR CONSIDERATION BY THE TECHNICAL SECRETARIAT: OVERVIEW OF PROCESSING

#### **OVERVIEW**

- 1. Over the last five years, and as at 19 February 2021, a total of 197 notes verbales by the Permanent Representation of the Syrian Arab Republic to the OCPW have been received and processed by the Technical Secretariat (hereinafter "the Secretariat").
- 2. The content of these notes verbales concerns one or more alleged activities by armed groups on the territory of the Syrian Arab Republic, and relates in particular to:
  - (a) storage of chemicals or weapons;
  - (b) movement of chemicals or weapons;
  - (c) intent of use of chemical weapons or toxic chemicals as weapons; and
  - (d) intent of staging the use of chemical weapons or toxic chemicals as weapons by armed groups and/or the "White Helmets".
- 3. The analysis by the Secretariat of these notes verbales has shown that the information conveyed by the Syrian Arab Republic to the Secretariat does not contain any details or technical supporting documentation that could be independently verified. An example note verbale is provided in the Annex hereto.
- 4. The Secretariat has consistently examined whether the above-mentioned information could be linked with allegations under its review of the use of toxic chemicals as weapons.
- 5. However, no such link has ever appeared between the information provided and such allegations (see Table below).
- 6. The Secretariat maintains a repository of these elements in case they could be related to any allegations of use.

#### Note Verbal

The Permanent Mission of the Syrian Arab Republic to the Organization for the Prohibition of Chemical Weapons OPCW presents its compliments to the Technical Secretariat, and would like to share the information received from the Syrian National Authority:

The terrorist armed groups located in "Bab Alhawa" crossing border between the Syrian Arab Republic and Turkey, prepared long convoys of military machineries and ambulances, in addition to a large number of the terrorists of so called "the national army" terrorist group, wearing the vests of the so called "White Helmet" terrorist group, and carrying weapons and missiles with heads containing chemicals.

Furthermore, the terrorist groups are also preparing to fabricate chemical attacks in three locations in Idlib Governorate to accuse the Syrian Arab Army of committing them.

The Permanent Mission of the Syrian Arab Republic would kindly ask the Technical Secretariat to consider this information as unclassified and to publish and circulate this Note Verbal to all State Parties as an official document of the 96<sup>th</sup> session of the Executive Council.

The Permanent Mission of the Syrian Arab Republic avails itself of this opportunity to renew to the Technical Secretariat of the Organization for the Prohibition of Chemical Weapons the assurances of its highest consideration.

#### Official translation

According to the information received by the relevant Syrian authorities, armed terrorist groups present at the "Bab al-Hawa" crossing on the Syrian-Turkish borders have prepared large convoys of military vehicles and ambulances, in addition to large numbers of terrorists of the so-called "National Army" terrorist group, wearing the "uniform" of the so-called "White Helmets" terrorist organisation and equipped with weapons and missiles carrying chemical warheads. The nature of these preparations indicates that the said terrorist groups are preparing false-flag attacks with chemical weapons to blame them on the Syrian Arab Army.

In addition, the terrorist groups are preparing to stage false-flag chemical attacks in three locations in the Idlib Governorate to blame them on the Syrian Arab Army.
