NOTE BY THE TECHNICAL SECRETARIAT**INVITATION TO APPLY FOR A WORKSHOP ON GENERAL ASPECTS
OF CHEMICAL SAFETY AND SECURITY IN LABORATORIES
(ONLINE EVENT VIA MICROSOFT TEAMS)
8 – 10 JUNE 2021****Purpose of the workshop**

1. The Technical Secretariat (hereinafter “the Secretariat”) wishes to inform Member States that it will hold an online workshop on General Aspects of Chemical Safety and Security in Laboratories, via the Microsoft Teams platform, from 8 to 10 June 2021. The workshop will be co-organised by the OPCW and the Institute of Chemical Sciences and Technologies “Giulio Natta” (SCITEC) of the Italian National Research Council (CNR) in cooperation with Federchimica (Italy), and with support from the National Authority of the Italian Republic.
2. The objective of the workshop is to provide an update on the current standards, policies, and best practices in chemical safety and security in both research and industrial experimental work setups. It has been designed for specialised personnel, such as safety coordinators and environmental health and safety managers, as well as representatives of related policy-making institutions from OPCW Member States. The workshop is being implemented within the scope of the capacity-building programmes on the peaceful applications of chemistry under Article XI of the Chemical Weapons Convention.

Content

3. The three-day programme will include theoretical lectures, as well as practical and interactive sessions, as follows:
 - (a) Participants will be introduced to the general framework in which the OPCW and other organisations work to promote chemical safety and security management; they will also learn more about major relevant international policies, initiatives, and tools, such as the Global Harmonized System (GHS) and the Emergency Response Guidebook (ERG) manual, among others. The workshop will feature a series of lectures dedicated to hazardous chemicals and related risk assessment, personal protection equipment, emergency management, environmental impact, and sustainability.



- (b) Table-top exercises in the fields of emergency response and risk assessment at the site of an incident involving hazardous chemicals will be conducted in order to provide participants with the practical skills needed to take action in chemical emergency scenarios as technical advisors or decision makers.
 - (c) Participants will also be encouraged to present case studies and issues from their organisations and engage in an interactive discussion to identify gaps and needs, and make specific proposals on how to improve existing practices in chemical safety and security management in their respective institutions and countries.
4. The workshop will accommodate a maximum of 30 participants from OPCW Member States; participants will be selected based on their qualifications and experience.

Admission requirements

5. The workshop is open to those who:
- (a) have a minimum of a first degree (BSc or equivalent) in chemical or environmental sciences or engineering from a recognised university or institution (or a degree in other fields in combination with at least five years of qualifying experience, as referred to in subparagraph (b) below); and
 - (b) have been working in the chemical industry, research and academia, specialised institutions performing laboratory-scale activities involving hazardous chemicals, or governmental agencies that coordinate chemical safety and security at such establishments.
6. The workshop will be conducted in English. Candidates must therefore have a strong command of both written and spoken English.
7. Female candidates are encouraged to apply.

Selection procedure

8. Applications will be carefully screened on the basis of the criteria specified in paragraphs 5 and 6 above. The Secretariat may decide to interview applicants. Successful candidates will be contacted for admission **no later than 14 May 2021**.

Application procedure

9. Interested candidates are invited to apply for participation in the workshop by filling out the form that is annexed to this Note. It should then be submitted to the Secretariat via the candidate's National Authority or Permanent Representation to the OPCW¹ **no later than 7 May 2021**.
10. Application forms (see the Annex to this Note) should be sent to the International Cooperation and Assistance Division via email (icb.events@opcw.org) with the words "Chemical Safety and Security in Laboratories, Italy 2021" in the subject line of the email.

11. Eligible applicants are also invited to complete the online application through Eventus—the OPCW event management system (<https://apps.opcw.org/eventus>). They must first create an account and then register for the event.
12. Application forms must be accompanied by:
 - (a) an updated curriculum vitae;
 - (b) a letter of recommendation from the candidate’s supervisor in his or her institution addressing the candidate’s qualifications in relation to the criteria specified in paragraph 5 above, and attesting to the relevance of the workshop to the work of the applicant’s institution;
 - (c) a copy of the personal identification pages of the candidate’s passport; and
 - (d) an endorsement from the National Authority or Permanent Representation of the candidate’s country to the OPCW (Section 7 of the application form in the Annex).
13. Incomplete or improperly completed applications cannot be considered.
