## NOTE BY THE DIRECTOR-GENERAL

### CALL FOR NOMINATIONS FOR THE NINETEENTH REGIONAL MEETING OF NATIONAL AUTHORITIES OF STATES PARTIES IN AFRICA (ONLINE) 15 – 17 JUNE 2021

- 1. On behalf of the Organisation for the Prohibition of Chemical Weapons (OPCW), the Director-General wishes to invite African National Authorities to nominate representatives to attend the Nineteenth Regional Meeting of National Authorities of States Parties in Africa, which will be held online from 15 to 17 June 2021.
- 2. This regional meeting of National Authorities will serve as a forum for States Parties to discuss needs, priorities, actions taken, and best practices in relation to the implementation of the Chemical Weapons Convention (hereinafter "the Convention") at the national, subregional, and regional levels, as well as the capacity-building support provided within the framework of the fifth phase of the OPCW Programme to Strengthen Cooperation with Africa on the Chemical Weapons Convention (hereinafter "the Africa Programme").
- 3. The purpose of the meeting is to facilitate discussions of:
  - (a) the status and progress of the implementation of the Africa Programme;
  - (b) the status and progress of the adoption of national implementing legislation, in particular in States Parties that have yet to adopt implementing legislation covering all initial measures;
  - (c) national implementation of the Convention, including issues concerning Article VI-related obligations;
  - (d) use of the Protection and Assistance Databank (PAD);
  - (e) issues related to chemical safety and security;
  - (f) enhancing the capabilities of chemical laboratories; and
  - (g) the status of the OPCW Centre for Chemistry and Technology (ChemTech Centre) project.

- 4. The expected results of the meeting include:
  - (a) improved understanding of follow-up actions and best practices of States Parties in relation to the implementation of the Convention, and of progress in the implementation of the Africa Programme;
  - (b) improved understanding of specific issues related to Articles VI, VII, X, and XI of the Convention and the respective support provided by the Technical Secretariat (hereinafter "the Secretariat"); and
  - (c) provision of updated information on the status of the implementation of the Convention in the region, in support of the Secretariat's development of its future assistance and cooperation activities for States Parties.
- 5. The provisional programme for the regional meeting is included as Annex 1 to this Note.
- 6. The National Authority of each State Party is requested to nominate up to two delegates for participation in the regional meeting.
- 7. The meeting will be conducted in English and French, with interpretation services available. Participants are therefore expected to have a good oral and written command of either English or French.
- National Authorities' nominees are invited to register online no later than 30 April 2021 through Eventus—the OPCW event management system (<u>https://apps.opcw.org/eventus</u>).
  Each nomination must be accompanied by an endorsement form (Annex 2) from the nominee's respective National Authority.
- 9. National Authorities that wish for their nominee(s) to make a presentation at the meeting should inform the Secretariat about the presentation's specific thematic area. Ideally, presentations should be limited to seven minutes and highlight best practices, as well as challenges encountered in relation to the implementation of the Convention. In addition, specific actions taken by a State Party as a result of attending or participating in the Secretariat's capacity-building events (in particular those within the framework of the Africa Programme) could be brought to the attention of the meeting participants.
- 10. Furthermore, National Authorities may express their interest in bilateral consultation with the Secretariat on specific issues related to national implementation of the Convention.
- 11. Information on national presentations and bilateral consultations should be conveyed by the respective nominee(s) to Mr Pavlo Byalyk (<u>pavlo.byalyk@opcw.org</u>), Programme Manager in charge of organising the regional meeting.
