NOTE BY THE TECHNICAL SECRETARIAT

CALL FOR NOMINATIONS FOR THE TWENTY-THIRD ANNUAL MEETING OF NATIONAL AUTHORITIES THE HAGUE, THE NETHERLANDS 23 – 26 NOVEMBER 2021

- 1. The Technical Secretariat (hereinafter "the Secretariat") wishes to invite National Authorities to submit nominations for the Twenty-Third Annual Meeting of National Authorities.
- 2. The annual meeting will take place online over a four-day period from Tuesday, 23 November to Friday, 26 November 2021. Bilateral meetings between the representatives of National Authorities and the Secretariat may be conducted online upon request.
- 3. The annual meeting of National Authorities is designed to serve as a mechanism for interactive communications and cooperation among the National Authorities, both among themselves and with the OPCW. As such, it is intended to promote a global network in support of the implementation of the Chemical Weapons Convention (hereinafter "the Convention") and to further enhance the engagement of States Parties in capacity-building activities offered by the Secretariat.
- 4. The objectives of the annual meeting are to:
 - (a) provide an occasion for National Authorities to share their experience and knowledge in order to enhance their capacity to comply with their obligations under the Convention:
 - (b) provide an occasion for the Secretariat and States Parties to interact and discuss ways for the effective provision of capacity-building support in an integrated and comprehensive manner;
 - (c) promote cooperation among National Authorities in order to further the implementation of the Convention; and
 - (d) provide an opportunity for interaction between the States Parties and the Secretariat to address outstanding issues and efforts to enhance the implementation of the Convention.

- 5. The Secretariat assists States Parties in their efforts to meet their obligations under the Convention, thereby enabling them to achieve full and effective implementation. This is being done through the implementation of various capacitybuilding programmes within the framework of Articles VII, X, and XI of the Convention. While the International Cooperation and Assistance Division continually strives to ensure effective and efficient provision of capacity-building support to States Parties, achieving and sustaining its impact requires the ownership and commitment of national governments. It is therefore essential to ensure that support be planned and delivered in dialogue with States Parties and in line with their needs and priorities.
- 6. Due to the continuing impact of and restrictions posed by COVID-19, this year's annual meeting will be held in an online format. States Parties will be updated on the OPCW's efforts and planned capacity-building activities across its key mandates. Furthermore, National Authorities will be provided with updates on policy-related issues. In addition, National Authorities will share their experiences, knowledge, and good practices in the implementation of the Convention. Bearing in mind the suggestions made during regional National Authorities meetings earlier in the year, particular emphasis will be placed on discussing an integrated approach to capacity building for chemical security, including relevant prevention, monitoring and response aspects. Throughout the meeting, National Authorities will have opportunities to discuss, exchange views, and learn from one another's experience and challenges in implementing the Convention.
- 7. All presentations will be recorded and made available on the Secretariat's TalentSoft platform at least two weeks before the online meeting starts.
- 8. Should there be interest in bilateral consultations with the Secretariat, interested National Authorities are requested to inform the Secretariat ahead of the meeting and communicate the particular national implementation issues they would like to discuss. This will enable the appropriate Secretariat officials to prepare for the relevant bilateral meetings.
- 9. National Authorities that wish to discuss draft implementing legislation are encouraged to submit drafts in advance and contact the Programme Officer Legal of the Implementation Support Branch, Ms Sharon Rivera, by email: sharon.rivera@opcw.org or ipb-legal@opcw.org.
- 10. The provisional programme for the meeting is attached as Annex 1 to this Note.
- 11. National Authorities are encouraged to nominate representatives who have been directly involved in the implementation of the Convention, particularly in their day-to-day activities.
- 12. Interested applicants are invited to register in Eventus—the OPCW event management system (https://apps.opcw.org/eventus)—no later than Monday, 18 October 2021. All nominations must be endorsed by the Head or Chief Coordinator of the National Authority. The endorsement form, which is attached as Annex 2 to this Note, must be uploaded by applicants during the registration process for the meeting.

The Secretariat will provide the necessary advice and assistance with the registration.
