H.E. AMBASSADOR PRADEEP KUMAR RAWAT
REPRESENTATIVE
AT THE NINETY-EIGHT SESSION OF THE EXECUTIVE COUNCIL
05-08 OCTOBER 2021

Mr. Chairperson,

Mr. Director-General,

Ambassadors and Delegates,

Permit me to begin by welcoming back Ambassador Abdelouahab Bellouki as the Chairperson of the Executive Council. I am confident that this Session will be smooth and successful under your able leadership. I would like to assure you of the full support and cooperation of my delegation.

I thank the Director General for his comprehensive statement, as well as the Vice-Chairs for their reports on the activities conducted under their respective clusters of issues.

India associates itself with the statement of NAM States Parties to the Chemical Weapons Convention and China, delivered by the Permanent Representation of the Republic of Azerbaijan to the OPCW, Ambassador Fikrat Akhundov.

India attaches high importance to the Chemical Weapons Convention, and stands for its full, effective and non-discriminatory implementation.

We hope that the remaining chemical weapons stockpiles would be destroyed soon.

We note the updated reports on the progress in the elimination of the Syrian chemical weapons programme. We urge continued and effective cooperation between the Syrian Arab Republic and the Technical Secretariat for early resolution of all outstanding issues.

India remains firmly opposed to the use of chemical weapons anywhere, by anyone, and continues to underline that any investigation on the alleged use of chemical weapons must be conducted in strict compliance with the provisions and procedures laid down in the convention.

My delegation takes note of the draft programme and budget of the OPCW for 2022-2023, and the draft decision on draft programme and budget of the OPCW for 2022-2023. India continues to urge return to the past practice of separate draft decisions on Programme and

Budget which provides States Parties the opportunity to consider and decide on several but distinct elements of the Budget.

We commend the co-facilitators on Organizational Governance Issues, Ambassador Matthew Neuhaus of Australia and Ambassador Laura Dupuy Lasserre of Uruguay for their dedicated and constructive efforts in finding common ground on our discussions on amendment of the OPCW Tenure Policy. We look forward to having further consultation on all organizational governance issues, and I assure my delegation's full cooperation in this regard. India would like to once again emphasize that such a decision shall be taken by consensus even if it means that we will have to make extra efforts.

We urge for early convening of meetings to achieving further progress to advance the full and effective implementation of all provisions of the Convention, as outlined in the October 04, 2019 position paper of the NAM States Parties to the Chemical Weapons Convention and China.

We note the merits of the draft decision on allowing the convening of Executive Council meetings or sessions in extraordinary circumstances. We would like to place on record our appreciation for the Co-sponsors of the draft decision for making it clear that they would only adopt the draft decision by consensus, thus respecting the OPCW traditional practice of consensus-based decision-making. India remains willing to engage further to find consensus on the draft decision.
