NOTE BY THE TECHNICAL SECRETARIAT

COURSE ON MEDICAL ASPECTS OF ASSISTANCE AND PROTECTION AGAINST CHEMICAL WEAPONS FOR STATES PARTIES IN THE LATIN AMERICA AND CARIBBEAN REGION RIO DE JANEIRO, BRAZIL 23 – 27 MAY 2022

- 1. On behalf of the Government of Brazil and the Organisation for the Prohibition of Chemical Weapons (OPCW), the Technical Secretariat (hereinafter "the Secretariat") wishes to invite Member States from the Latin American and Caribbean Group (GRULAC) to nominate representatives to participate in a regional course on medical aspects of assistance and protection against chemical weapons, to take place from 23 to 27 May 2022 in Rio de Janeiro, Brazil.
- 2. The course will be organised jointly by the Government of Brazil and the Secretariat and is aimed at enhancing chemical response preparedness at the regional and subregional levels in accordance with the recommendations received from the Third Review Conference¹ regarding the implementation of Article X of the Chemical Weapons Convention (hereinafter "the Convention").
- 3. The event will address matters related to medical assistance in case of an incident involving chemical warfare agents. It will focus on the physiological effects and clinical picture of chemical warfare agents, the signs and symptoms of exposure, and the medical treatment of casualties exposed to various chemical warfare agents as well as countermeasures. Participants in the course will learn to operate with personal protective equipment, and analyse a situation to design and coordinate an effective response plan for the medical management of chemical casualties in the field or at an emergency medical facility.
- 4. The course is also aimed at facilitating the exchange of information and at promoting networking among the participants representing national institutions, with a view to enhancing the implementation of Article X of the Convention in the GRULAC region as a whole. Applicants should be familiar with medical response practices and procedures in the event of attacks involving chemical warfare agents and/or incidents with toxic industrial chemicals, in line with the provisions of Article X of the Convention.

- 5. Given the objectives of the course, candidates will be carefully selected. They should be members of emergency response units from institutions involved in chemical, biological, radiological, and nuclear (CBRN) response systems, including emergency medical services, military medical units, and hazardous materials (HAZMAT) teams, among others. Candidates should have a solid background in emergency medicine, toxicology, or health care associated with protection against chemical weapons and other toxic chemicals. Participants should be physically fit and able to wear personal protective equipment during the course, if necessary.
- 6. Only candidates endorsed by the National Authority of their Member State will be considered in the selection process. The Secretariat will select only one participant from any given Member State.
- 7. The Secretariat expects to be able to sponsor a maximum of 20 participants. When proposing candidates for the course, Member States should specify whether such sponsorship is a condition of their participation. For sponsored participants, the Secretariat will cover the costs of travel, accommodation, transfers to and from the airport, medical insurance, and meals, and will provide a limited subsistence allowance to cover sundry expenses.
- 8. Participants are requested to obtain all necessary visas (including transit visas) before travelling to Brazil.
- 9. All GRULAC Member States are encouraged to nominate candidates for this event, which will be conducted in Spanish. Participants are required to have a good command of Spanish, both written and oral. No interpretation services of any kind will be provided during the event.
- 10. Interested applicants are invited to register their nomination online through Eventus the OPCW event management system—**no later than 27 March 2022**. The Eventus registration link is accessible via the OPCW website (<u>https://apps.opcw.org/eventus</u>). Please note that all questions marked with an asterisk (*) in the online registration form must be answered in order for the nomination to be received and for the candidate to be considered for the event. The endorsement form from the National Authority (attached as Annex 3 to this Note) must be uploaded during the course registration process.
- 11. Interested applicants who, for technical reasons, are unable to submit their application online via Eventus are requested to complete and send the nomination and endorsement forms (attached as Annexes 2 and 3 to this Note) via email attachment (to both EmergAssistBr@opcw.org and miguel.albaladejopomares@opcw.org) with a reference to the name and location of the event in the subject line of the message.
- 12. Candidates who have been selected to participate in the course will be contacted no later than two weeks after the submission deadline. Member States are requested to inform the International Cooperation and Assistance Division of any administrative or other problems that may arise in connection with the attendance of any participant.
- 13. The provisional programme for the course is included as Annex 1 to this Note. Further details regarding accommodation, the course venue, transportation, as well as an updated version of the programme will be submitted to all selected participants at a later date.
