Through these activities and more, the Secretariat also helps in building capacity and the ability of States Parties to prevent the re-emergence of chemical weapons.

Over the past year, the Secretariat has adapted to the unprecedented challenges posed by the COVID-19 pandemic by using innovative online and hybrid mechanisms to deliver its capacity building programmes and activities to advance the implementation of Article XI.

Since our last Workshop in November 2020, the Secretariat successfully organised 23 Article XI online capacity building programmes, including training activities, workshops, and seminars, with a total of about 900 participants from 118 States Parties.

The Secretariat also supported 13 fellowships and three conferences.

Some of the recent notable achievements under the framework of Article XI include the launch of "Indicative Guidelines for Chemical Safety and Security in Small and Mediumsized Enterprises".

These non-binding guidelines are the first of their kind and are designed to support States Parties in strengthening chemical safety and security best practices.

Also, this year, through being engaged under an OPCW capacity building project funded by the United Kingdom, a laboratory in Brazil succeeded in securing the OPCW designated status, becoming the first laboratory in the GRULAC region to achieve this goal. I seize this opportunity to thank the United Kingdom for this important contribution, and to congratulate the Brazilian laboratory for having secured this status. This represents a concrete illustration of the use and necessity of international cooperation related activities.

The Secretariat will continue to spare no efforts in encouraging, supporting, facilitating, and guiding States Parties towards ensuring full, effective, and non-discriminatory implementation of Article XI.

I am confident that together, with your active engagement and valuable inputs, we will achieve our goal, and thus strengthen the implementation of the Chemical Weapons Convention as a whole.

I look forward to your deliberations and wish the Workshop every success.
