## STATEMENT BY H.E. AMBASSADOR DR HISSA ABDULLA ALOTAIBA PERMANENT REPRESENTATIVE OF THE UNITED ARAB EMIRATES TO THE OPCW AT THE NINETY-SEVENTH SESSION OF THE EXECUTIVE COUNCIL UNDER AGENDA ITEM 17

Your Excellency, the Chairperson of the Executive Council of the OPCW, Your Excellency, the Director-General of the OPCW, Excellencies, Ladies and gentlemen,

May peace and God's mercy and blessings be upon you.

On behalf of the delegation of the United Arab Emirates, it gives me pleasure to congratulate you, Excellency Ambassador Abdelouahab Bellouki of the Kingdom of Morocco, on your election as Chairperson of the Executive Council. I wish you full success in your mission.

I would like to extend my greetings and appreciation to the Director-General of the OPCW, H.E.
