The Conference of the States Parties,

## **Background information:**

## 1. African Centre for Science and International Security (AFRICSIS)

<u>City and Country:</u> Abuja, Nigeria <u>Contact person(s):</u> Hubert Foy Website: www.africsis.org

<u>Overview:</u> Identifying solutions to complex weapons proliferation problems; encouraging technical-based policy-making process and dialogue between stakeholders to reach agreement on the approaches to deal with chemical weapons.

<u>Activities</u>: For twelve years, we have worked to build capacity and raise awareness of the universal destruction of chemical weapons and their prohibition. In the last year, we have implemented several projects related to the CWC including capacity-building events on the prohibition of chemical weapons use in February 2021, with a panel including officials from the OPCW and EU CBRN CoE, and INTERPOL. The event gathered an audience of 80 people. In partnership with UNODA, AFRICSIS will hold an onsite 2-day workshop in Accra in September 2022 on UNSCR 1540 for African government representatives and other stakeholders.

<u>Financial resources:</u> AFRICSIS sources of funding are project-based and consulting. Together with our partners, we have received funding from the UK, Norway, McArthur Foundation, and Bill and Melinda Gates.

<u>Membership:</u> AFRICSIS work covers the continent of Africa and we have working relations with more than 90% of the governments in Africa including MFA, regulatory bodies, and defense academies.

Overview: The protection of civilians during armed conflict is the cornerstone of international humanitarian law. Such protection extends to both public and private civilian property, as well as protection from the effects of such pollution and from pollution caused by weapons. This type of pollution deprives entire populations of water, firewood, agricultural land, healthcare and education. It also impedes relief work, deprives the population of humanitarian aid and exacerbates humanitarian problems.
