REPORT OF THE FIFTH SPECIAL SESSION OF THE CONFERENCE OF THE STATES PARTIES TO REVIEW THE OPERATION OF THE CHEMICAL WEAPONS CONVENTION (FIFTH REVIEW CONFERENCE)

1. AGENDA ITEM ONE – Opening of the Fifth Review Conference

- 1.1 The Fifth Special Session of the Conference of the States Parties to Review the Operation of the Chemical Weapons Convention (hereinafter "the Fifth Review Conference") was opened at 10:12 on 15 May 2023 in the King Willem-Alexander Theater in the World Forum by the Chairperson of the Twenty-Seventh Session of the Conference of the States Parties (hereinafter "the Conference"), Ambassador Vusimuzi Philemon Madonsela of South Africa.
- 1.2 The following 137 States Parties participated in the Fifth Review Conference: Albania, Algeria, Andorra, Angola, Argentina, Armenia, Australia, Austria, Azerbaijan, Bahrain, Bangladesh, Belarus, Belgium, Bolivia (Plurinational State of), Bosnia and Herzegovina, Botswana, Brazil, Bulgaria, Burkina Faso, Burundi, Cambodia, Cameroon, Canada, Chile, China, Colombia, Costa Rica, Côte d'Ivoire, Croatia, Cuba, Cyprus, the Czech Republic, Denmark, the Dominican Republic, Ecuador, El Salvador, Estonia, Ethiopia, Fiji, Finland, France, the Gambia, Georgia, Germany, Ghana, Greece, Guatemala, the Holy See, Honduras, Hungary, India, Indonesia, Iran (Islamic Republic of), Iraq, Ireland, Italy, Jamaica, Japan, Jordan, Kazakhstan, Kenya, Kuwait, Kyrgyzstan, the Lao People's Democratic Republic, Latvia, Lebanon, Libya, Liechtenstein, Lithuania, Luxembourg, Malaysia, Malta, Mexico, Monaco, Mongolia, Montenegro, Morocco, Mozambique, Myanmar, Namibia, Nepal, the Netherlands, New Zealand, Nicaragua, the Niger, Nigeria, North Macedonia, Norway, Oman, Pakistan, Panama, Paraguay, Peru, the Philippines, Poland, Portugal, Qatar, the Republic of Korea, the Republic of Moldova, Romania, the Russian Federation, Rwanda, Samoa, San Marino, Saudi Arabia, Senegal, Serbia, Singapore, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, the State of Palestine, the Sudan, Sweden, Switzerland, the Syrian Arab Republic, Tajikistan, Thailand, Togo, Trinidad and Tobago, Tunisia, Türkiye, Turkmenistan, Uganda, Ukraine, the United Arab Emirates, the United Kingdom of Great Britain and Northern Ireland, the United Republic of Tanzania, the United States of America, Uruguay, Venezuela (Bolivarian Republic of), Viet Nam, Yemen, Zambia, and Zimbabwe.

- 1.3 In accordance with Rule 29 of the Rules of Procedure of the Conference, the following signatory State participated in the Fifth Review Conference as an observer: Israel.
- 1.4 In accordance with Rule 30 of the Rules of Procedure of the Conference, and pursuant to a decision of the Fifth Review Conference on the matter (RC-5/DEC.1, dated 15 May 2023), the following non-signatory State was accorded observer status: South Sudan.
- 1.5 In accordance with Rules 31 and 32 of these Rules of Procedure, and pursuant to a decision of the Fifth Review Conference on the matter (RC-5/DEC.2, dated 15 May 2023), 14 international organisations, specialised agencies, and other international bodies attended the Fifth Review Conference.
- 1.6 In accordance with the recommendations of the Third Special Session of the Conference of the States Parties to Review the Operation of the Chemical Weapons Convention (RC-3/3*, dated 19 April 2013), and pursuant to a decision of the Fifth Review Conference on the matter (RC-5/DEC.3, dated 15 May 2023), the Fifth Review Conference **invited** representatives of the global chemical industry and scientific community to attend the Fifth Review Conference.
- 1.7 In accordance with Rule 33 of these Rules of Procedure, and pursuant to a decision of the Fifth Review Conference on the matter (RC-5/DEC.4, dated 15 May 2023), the Fifth Review Conference **invited** 74 non-governmental organisations to attend and participate in the Fifth Review Conference in person or by remote access, as well as through pre-recorded statements.
- 1.8 The Permanent Representative of Germany read a joint statement on behalf of Albania, Andorra, Australia, Austria, Belgium, Brazil, Bulgaria, Canada, Chile, Colombia, Costa Rica, Croatia, Cyprus, the Czech Republic, Denmark, Ecuador, Estonia, Finland, France, Georgia, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Mexico, Monaco, Montenegro, the Netherlands, New Zealand, North Macedonia, Norway, Peru, Poland, Portugal, the Republic of Moldova, Romania, San Marino, Slovakia, Slovenia, Spain, Sweden, Switzerland, Ukraine, the United Kingdom of Great Britain and Northern Ireland, and the United States of America concerning cooperation with non-governmental organisations and their involvement in the work of the OPCW, including their attendance at sessions of the Conference.
- 1.9 The delegations of Türkiye, the Russian Federation, Ireland, and the Islamic Republic of Iran made statements under this agenda item.

2. AGENDA ITEM TWO – Election of the Chairperson

In accordance with Rule 8(b) of the Rules of Procedure of the Conference, the Fifth Review Conference, by acclamation, **elected** as its Chairperson Ambassador Henk Cor van der Kwast of the Netherlands.

3. AGENDA ITEM THREE – Election of Vice-Chairpersons and other officers

3.1 In accordance with Rule 8(b) of the Rules of Procedure of the Conference, the Fifth Review Conference, by acclamation, **elected** representatives of the following eight States Parties as Vice-Chairpersons of the Fifth Review Conference: Algeria, Angola, Australia, Bolivia (Plurinational State of), Cyprus, El Salvador, Germany, and Japan.

- 3.2 The delegations of Lithuania, North Macedonia, and the Russian Federation presented their candidacies for the two seats pertaining to the Eastern European Group.
- 3.3 Pursuant to Rule 79 of the Rules of Procedure of the Conference, the delegation of Latvia (on behalf of Albania, Bosnia and Herzegovina, Bulgaria, Croatia, the Czech Republic, Estonia, Georgia, Hungary, Latvia, Lithuania, Montenegro, North Macedonia, Poland, the Republic of Moldova, Romania, Slovakia, Slovenia, and Ukraine) requested a vote by secret ballot to fill the two seats pertaining to the Eastern European Group. The delegation of the Russian Federation also made a statement under this agenda item.
- 3.4 The Fifth Review Conference **elected** the following two States Parties from the Eastern European Group as Vice-Chairpersons of the Fifth Review Conference: Lithuania and North Macedonia.
- 3.5 Also in accordance with Rule 8(b) of the Rules of Procedure of the Conference, the Fifth Review Conference **elected** as Chairperson of the Committee of the Whole Ambassador José Antonio Zabalgoitia Trejo of Mexico.

- 8.7 In accordance with RC-5/DEC.2, the following international organisations and international bodies made statements during the general debate: the Security Council Committee established pursuant to resolution 1540 (2004), and the North Atlantic Treaty Organization (NATO).
- 8.8 On behalf of the Advisory Board on Education and Outreach, Professor Magda Bauta Solés addressed the Fifth Review Conference on the importance of education and outreach for the work of the OPCW (the statement was posted on the external server of the OPCW).
