3. AGENDA ITEM THREE – Replacement of the Vice-Chairperson of the Executive Council from the Asian Group

Further to the end of mission of Ambassador Nazar Issa Abdulhadi Al-Khirullah of Iraq prior to the expiry of his term of office as Vice-Chairperson of the Council from the Asian Group, the Council, in accordance with Rules 6 and 8 of its Rules of Procedure, **elected** Ambassador Hiroshi Minami of Japan as Vice-Chairperson for the unexpired term of office until 11 May 2024.

- 5.2 The Council **expressed appreciation** for the work done by the outgoing facilitators, Ms Bianca Müller of Germany for her work as facilitator for chemical industry and other Article VI-related issues, and Ms Yoko Sakurai of Japan for her work as facilitator for the Office of Internal Oversight and the External Auditor. The Council **welcomed** Ms Sandra Rodríguez of Peru as facilitator for Article VII-related issues, Mr Lesther Antonio Ortega Lemus of Guatemala as facilitator for issues related to the universality of the Chemical Weapons Convention (hereinafter "the Convention"), and Ms Martina Filippiová of the Czech Republic as facilitator for Article X-related issues.

- 6.2 The delegation of the Russian Federation exercised its right of reply.

7. AGENDA ITEM SEVEN – Status of implementation of the Chemical Weapons Convention

Subitem 7(a): Reports by the Director-General on destruction-related issues

- 7.1 Further to a decision by the Conference of the States Parties (hereinafter "the Conference") at its Sixteenth Session (C-16/DEC.11, dated 1 December 2011), the Council **considered** and **noted** a report by the Director-General on the overall progress with respect to the destruction of the remaining chemical weapons stockpiles (EC-103/DG.15, dated 3 July 2023).
- 7.2 The delegation of Spain (observer) made a statement on behalf of the European Union.
- 7.3 Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6, dated 15 February 2012), the Council **considered** and **noted** a report by the Director-General on the overall progress in the destruction of abandoned chemical weapons (EC-103/DG.18, dated 7 July 2023).

Subitem 7(b): Implementation of the Conference of the States Parties and Executive Council decisions on destruction-related issues

- 7.4 The Technical Secretariat (hereinafter "the Secretariat") provided updates to the Council on its destruction-related verification activities and on Article III-related submissions (the presentations were posted on the external server of the OPCW).
- 7.5 The delegation of the United States of America provided an update to the Council on its destruction-related activities, including on the completion of the destruction of all its declared chemical weapons stockpiles (the presentation was posted on the external server of the OPCW).
- 7.6 The following delegations made statements: the Islamic Republic of Iran and the Russian Federation.
- 7.7 The delegations of Japan and China provided updates to the Council on their destruction-related activities (the presentation was posted on the external server of the OPCW).
- 7.8 Further to Conference decision C-16/DEC.11, the Council **considered** and **noted** a national paper by the United States of America on the progress achieved towards complete destruction of its chemical weapons stockpile, including information on measures to accelerate such progress, and identifying progress made since the last briefing in order to meet the planned completion date. This report included reporting on any specific measures undertaken to overcome problems in the destruction programme (EC-103/NAT.2, dated 22 June 2023).
- 7.9 The Council **considered** and **noted** the initial report of the visit by the Chairperson of the Council, the Director-General, and representatives of the Council to the Blue Grass Chemical Agent-Destruction Pilot Plant, Kentucky, the United States of America, from 12 to 14 June 2023 (EC-103/2, dated 7 July 2023).

7.10 Further to Council decision EC-67/DEC.6 and the destruction plan beyond the year 2022 for the chemical weapons abandoned by Japan in China (EC-101/DEC.2, dated 4 October 2022), attached as annex 3 to Council decision EC-67/DEC.6, a national paper by China (EC-103/NAT.3, dated 28 June 2023) and a national paper by Japan (EC-103/NAT.1, dated 22 June 2023) on the overall progress of the destruction of chemical weapons abandoned by Japan on the territory of China were circulated to the members of the Council.

Subitem 7(c): Elimination of the Syrian chemical weapons programme

- 7.11 Further to its decision at its Eighty-Third Session (EC-83/DEC.5, dated 11 November 2016), the Council decided to place "Elimination of the Syrian Chemical Weapons Programme" on the agenda of all future Council sessions until the Council determines that all elements of the Syrian chemical weapons programme have been eliminated.
- 7.12 As stated in the Note by the Director-General EC-81/DG.5 (dated 25 January 2016), all of the chemicals declared by the Syrian Arab Republic that had been removed from its territory in 2014 have been destroyed. The Secretariat has also verified the destruction of all 27 chemical weapons production facilities declared by the Syrian Arab Republic (EC-89/DG.1, dated 24 July 2018).
- 7.13 The Secretariat provided a briefing to the States Parties on 3 July 2023 on its activities related to the Syrian Arab Republic, including on the activities of the Declaration Assessment Team, the OPCW Fact-Finding Mission in Syria, and the Investigation and Identification Team.
- 7.14 The Council **noted** four reports by the Director-General reporting on progress in the elimination of the Syrian chemical weapons programme (EC-103/DG.2, dated 24 March 2023; EC-103/DG.3, dated 25 April 2023; EC-103/DG.6, dated 24 May 2023, and EC-103/DG.11, dated 23 June 2023).
- 7.15 The Council **noted** four national papers by the Syrian Arab Republic on the activities related to the destruction of Syrian chemical weapons and their production facilities (EC-103/P/NAT.1, dated 20 March 2023; EC-103/P/NAT.2, dated 15 April 2023; EC-103/P/NAT.3, dated 15 May 2023; and EC-103/P/NAT.4, dated 15 June 2023).
- 7.16 The Council **noted** a Note by the Director-General entitled "Report on the Work of the Declaration Assessment Team" (EC-103/HP/DG.1, dated 6 July 2023).
- 7.17 The Secretariat circulated a Note by the Secretariat entitled "Report of the OPCW Fact-Finding Mission Regarding Incidents of Alleged Use of Toxic Chemicals as a Weapon in Kharbit Massasneh, Syrian Arab Republic, on 7 July and 4 August 2017" (S/2186/2023, dated 28 June 2023).
- 7.18 The following delegations made statements: China, the Russian Federation, the United Kingdom of Great Britain and Northern Ireland, Canada, France, Chile, Türkiye, Japan, Ireland, the United States of America, Spain (observer) (on behalf of the European Union and Albania, Andorra, Bosnia and Herzegovina, Georgia, Iceland, Liechtenstein, Monaco, Montenegro, North Macedonia, Norway, the Republic of Moldova, San Marino, Türkiye, and Ukraine), the Islamic Republic of Iran, the Syrian Arab Republic (observer), the Bolivarian Republic of Venezuela (observer), and Australia (observer).
- 7.19 The Director-General made a statement.

Subitem 7(d): Other verification-related issues

- 7.20 The Secretariat updated the Council on its other verification-related activities (the presentation was posted on the external server of the OPCW).
- 7.21 Further to the decision of the Council at its Sixty-Sixth Session on the policy guidelines for determining the number of Article VI inspections (EC-66/DEC.10, dated 7 October 2011), the Council **noted** a Note by the Director-General on the results of the eleventh year of implementation of these policy guidelines (EC-103/DG.1, dated 24 March 2023).

Subitem 7(e): Addressing the threat from chemical weapons use

- 7.22 The Council **noted** the regular report by the Director-General to the Council on progress made in the implementation of the decision of the Conference entitled "Addressing the Threat from Chemical Weapons Use" (C-SS-4/DEC.3, dated 27 June 2018) (EC-103/DG.13, dated 26 June 2023).
- 7.23 The following delegations made statements: Canada, Germany, Italy, the Russian Federation, Türkiye, the Islamic Republic of Iran, France, Albania, China, the United States of America, the United Kingdom of Great Britain and Northern Ireland, the Syrian Arab Republic (observer), the Czech Republic (observer), the Bolivarian Republic of Venezuela (observer), and Australia (observer).
- 7.24 The delegation of Canada exercised its right of reply.
- 7.25 The following delegations made statements on other issues under this agenda item: Germany, Spain (observer) (on behalf of the European Union and Albania, Andorra, Bosnia and Herzegovina, Iceland, Liechtenstein, Monaco, Montenegro, North Macedonia, Norway, the Republic of Moldova, San Marino, and Ukraine), Italy, France, Canada (on behalf of Australia, Canada, and New Zealand), Japan, the Russian Federation, the United States of America, the United Kingdom of Great Britain and Northern Ireland, China, Albania, the Syrian Arab Republic (observer), Ukraine (observer), and the Czech Republic (observer).
- 7.26 The following delegations exercised their right of reply: the Russian Federation, Ukraine (observer), the United Kingdom of Great Britain and Northern Ireland, and Germany.

Subitem 7(f): Timely submission of declarations under Article VI of the Chemical Weapons Convention

7.27 Further to a decision by the Council at its Fifty-First Session (EC-51/DEC.1, dated 27 November 2007), the Council **noted** a status report by the Director-General on the timely submission by States Parties of declarations under Article VI of the Chemical Weapons Convention for the period 1 January to 31 May 2023 (EC-103/DG.10, dated 16 June 2023).

Subitem 7(g): Article VII: briefings by the facilitator and by the Technical Secretariat

7.28 The Secretariat circulated a presentation on the status of implementation of Article VII (the presentation was posted on the external server of the OPCW).

Subitem 7(h): The content of the Protection and Assistance Databank and its use

7.29 The Council **considered** and **noted** a Note by the Secretariat on the content of the Protection and Assistance Databank and its use (EC-103/S/2, dated 16 June 2023).

- 7.30 The Secretariat circulated a presentation on the status of implementation of Article X (the presentation was posted on the external server of the OPCW).
- 7.31 The facilitator for Article X-related matters, Ms Martina Filippiová of the Czech Republic, reported to the Council on the consultations carried out during the intersessional period (the report was posted on the external server of the OPCW).

- 8.1 The Chairperson of the Open-Ended Working Group on Terrorism (OEWG-T), Ambassador Vusimuzi Philemon Madonsela of South Africa, briefed the Council on the work of the OEWG-T during the intersessional period.
- 8.2 The following delegations made statements: the Russian Federation, the Syrian Arab Republic (observer), the United Kingdom of Great Britain and Northern Ireland, China, the United States of America, and Canada.
- 8.3 The delegations of the Syrian Arab Republic (observer) and Canada exercised their right of reply.

9. AGENDA ITEM NINE – Draft annual report of the OPCW on the implementation of the Chemical Weapons Convention in 2022

- 9.1 The Council **considered** the "Draft Report of the OPCW on the Implementation of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction in 2022" (EC-103/CRP.1^{*}, dated 27 June 2023).
- 9.2 The following delegations made statements: the Russian Federation, Spain (observer) (on behalf of the European Union and Albania, Andorra, Bosnia and Herzegovina, Georgia, Iceland, Liechtenstein, Monaco, Montenegro, North Macedonia, Norway, the Republic of Moldova, San Marino, and Ukraine), the United Kingdom of Great Britain and Northern Ireland, the Syrian Arab Republic (observer), China, and the Islamic Republic of Iran.
- 9.3 The Council **submitted** the Draft Report of the OPCW (EC-103/CRP.1^{*}, dated 27 June 2023) to the Conference for consideration at its Twenty-Eighth Session.
- 9.4 The delegations of the Russian Federation, China, and the Islamic Republic of Iran dissociated themselves from the submission to the Conference of the above-mentioned Draft Report in its current form.

10. AGENDA ITEM TEN – Reports of the Office of Internal Oversight

10.1 The facilitator for informal consultations on the report of the Office of Internal Oversight and the External Auditor, Ms Yoko Sakurai of Japan, reported to the Council on the consultations carried out during the intersessional period (the report was posted on the external server of the OPCW).

- 11.7 Following the discussion on the tenure policy, the Council **established** a facilitation on the matter with the aim of preparing a recommendation to the next session of the Conference.

12. AGENDA ITEM TWELVE – Follow-up to the Review Conferences

- 12.1 At its Seventy-Third Session (paragraph 13.1 of EC-73/6, dated 19 July 2013), the Council requested the Director-General to submit to each regular session of the Council the updated version of the "Matrix of Actionable Items Identified at the Third Review Conference". The Council **considered** and **noted** the updated Matrix document (EC-103/S/1, dated 13 June 2023) and **decided** that the Secretariat would cease preparing, updating, and issuing the above-mentioned document with the aim of using the Secretariat's resources in the most efficient manner.
- 12.2 A working paper entitled "Reflections by H.E. Ambassador Henk Cor van der Kwast Chairperson of the Fifth Review Conference on the Outcome of the Fifth Review Conference" was circulated under the symbol EC-103/WP.1 (dated 26 June 2023).
- 12.3 The delegation of the Netherlands made a statement.

OPCW engagement with civil society

- 12.4 Germany submitted a working paper entitled "Follow-up to the Fifth Special Session of the Conference of the States Parties to Review the Operation of the Chemical Weapons Convention Engagement with Civil Society" (EC-103/WP.2, dated 4 July 2023).

In accordance with Rule 34 of the Rules of Procedure of the Council, the Secretariat circulated a report by the Director-General on the financial, administrative, and programme and budget implications of the proposal (EC-103/DG.19, dated 11 July 2023).

- 12.11 The Council **adopted** the decision (EC-103/DEC.1, dated 12 July 2023).

Chemical weapons abandoned by Japan on the territory of China
