NOTE BY THE TECHNICAL SECRETARIAT

SUBMISSION OF ANNUAL DECLARATIONS ON PAST ACTIVITIES FOR 2022 AND 2023, ON PROJECTED ACTIVITIES AND ANTICIPATED PRODUCTION IN 2024 AT SCHEDULE 1 FACILITIES, AND ON ANTICIPATED ACTIVITIES AT SCHEDULE 2 AND 3 PLANT SITES IN 2024 AS AT 30 MARCH 2024

1. According to paragraph 8 of Article VI of the Chemical Weapons Convention (the Convention), “[e]ach State Party shall make annual declarations regarding the relevant chemicals and facilities in accordance with the Verification Annex”.
2. According to paragraph 8 of Article VI and Parts VI, VII, VIII, and IX of the Verification Annex to the Convention (the Verification Annex), States Parties shall submit annual declarations on past activities (ADPAs) in relation to scheduled chemicals and related facilities, and each year shall submit the information necessary to update the list of other chemical production facilities not later than 90 days after the end of the previous calendar year.
3. The deadline for the submission of ADPAs for 2023 was thus 30 March 2024. Annex 1 lists the 68 States Parties with declarable activities, plus the eight States Parties with nil declarations (no declarable activities during the given year), that submitted their ADPAs by that deadline. These figures are comparable with the number of States Parties submitting their ADPAs for 2022 on time, when 68 States Parties with declarable activities, plus seven States Parties with nil declarations, submitted their ADPAs by the deadline.
4. In line with Executive Council decision EC-51/DEC.1 (dated 27 November 2007) concerning the timely submission by States Parties of declarations under Article VI of the Convention, paragraph 4 requests “States Parties that anticipate difficulties in regard to the timely submission of their declarations ... to inform the Secretariat at the earliest possible date of the circumstances of such difficulties”. As of the ADPA 2023 deadline, two States Parties (Denmark and Ireland) had submitted such information.
5. With regard to 2022 ADPAs, 19 States Parties with declarable activities submitted their ADPAs after the deadline of 30 March 2023. Further to the information provided in S/2164/2023 (dated 20 April 2023), Annex 2 to this Note lists the 87 States Parties with declarable activities, plus 13 States Parties with nil declarations, that submitted their ADPAs for 2022 by 30 March 2024.



6. As for Schedule 1 projected activities, according to paragraph 16 of Part VI of the Verification Annex, “[e]ach State Party producing Schedule 1 chemicals at a single small-scale facility shall make a detailed annual declaration regarding the projected activities and the anticipated production at the facility for the coming year”. It further requires that the declaration shall be submitted not less than 90 days before the beginning of that year. In addition, paragraph 20 of Part VI of the Verification Annex requires the same of each State Party producing Schedule 1 chemicals at other facilities referred to in paragraphs 10 and 11 of Part VI of the Verification Annex.
7. One State Party submitted its annual declaration on projected activities and anticipated production at Schedule 1 facilities for 2024 after the deadline of 2 October 2023. Further to the information on the status of submission of annual declarations on projected activities in 2024 at Schedule 1 facilities provided in S/2216/2023 (dated 11 October 2023), Annex 3 to this Note lists the 24 States Parties with projected activities and anticipated production at Schedule 1 facilities, plus four States Parties with nil declarations, that submitted their 2024 declarations by 30 March 2024.
8. With regard to annual declarations of anticipated activities (ADAAs), according to subparagraph 4(c) of Part VII of the Verification Annex, each State Party shall submit ADAAs at Schedule 2 plant sites not later than 60 days before the beginning of the following calendar year. Subparagraph 4(c) of Part VIII requires the same of each State Party for plant sites producing Schedule 3 chemicals.
9. Two States Parties with declarable activities submitted their 2024 ADAAs for Schedule 2 and/or Schedule 3 plant sites after the deadline of 1 November 2023. Further to the information on the status of submission of 2024 ADAAs for Schedule 2 and Schedule 3 plant sites provided in S/2226/2023 (dated 17 November 2023), Annex 4 to this Note lists the 38 States Parties with declarable activities, plus the five States Parties with nil declarations, that submitted 2024 ADAAs for Schedule 2 and Schedule 3 plant sites by 30 March 2024.
