The Republic of Benin, recalling that the Convention strictly prohibits any use of chemical weapons, wishes to express its deep concern with regard to allegations which, if proved, would pose a serious threat to regional security, and to African countries in particular.

In this context, and in accordance with Rule 16 of the Rules of Procedure of the Executive Council of the OCPW, the Republic of Benin kindly requests the Director-General of the OPCW to include on the agenda of the 109th Session of the Council an item on the alarming reports of the alleged use of chemical weapons in the ongoing conflict in the Republic of the Sudan.

In this connection, Benin would like clarification on the following points:

- Have chemical weapons been used in the ongoing conflict in the Sudan?
- What guarantees are in place to ensure the independence, objectivity, and transparency of the national committee announced by the Sudanese authorities?
- Does the Sudan possess chemical weapons or is it aware of the presence of chemical weapons on its territory?

Moreover, the Republic of Benin requests that this note verbale be circulated to all of the States Parties to the Convention and published on the OPCW website and Catalyst platform as an official document of the 109th Session of the Executive Council.
