NOTE BY THE DIRECTOR-GENERAL

NOTIFICATION OF A MEETING OF THE EXECUTIVE COUNCIL

- 1. The Director-General, in consultation with the Chairperson of the Executive Council (the Council), Ambassador Thomas Schieb of Germany, and in accordance with Rule 12(b) of the Rules of Procedure of the Council, is requesting that the Council meet to receive and consider information on the situation in the Syrian Arab Republic.
- 2. The Director-General's request is in response to the request from the Permanent Representative of the State of Qatar to the OPCW to convene a meeting of the Council (two Letters from H.E. Ambassador Mutlaq M. Al Qahtani, Permanent Representative of the State of Qatar to the OPCW (Annexes 2 and 3)). A letter from the Director-General of the OPCW Technical Secretariat (Annex 4) and a letter from the Chairperson of the Council (Annex 5), have been transmitted to H.E. Ambassador Mutlaq bin Majed Al Qahtani, Permanent Representative of the State of Qatar to the OPCW, in response.
- 3. The meeting of the Council will be held at 10:00 on Tuesday, 22 July 2025, in the Ieper Room of the OPCW Main Building (Johan de Wittlaan 32, The Hague).

I am writing to you in my capacity as representing the interests of the Syrian Arab Republic to the OPCW to bring to your urgent attention the grave developments arising from the Israeli air strike on 16 July 2025 targeting several sites in Damascus, including the General Staff Headquarters of the Ministry of Defence.

The Ministry of Defence plays a critical role in supporting the OPCW Technical Secretariat's deployed teams in Syria. These teams are essential to the ongoing process of identifying, declaring, destroying, and verifying residual elements of the Syrian chemical weapons programme left behind as a legacy of the former government. The recent attack poses a direct threat to Syria's capacity to fulfil its obligations under the Chemical Weapons Convention.

Significantly, the building targeted in this strike is the very same location where meetings were held between the OPCW Technical Secretariat and the Syrian Ministry of Defence during the last deployment to discuss support to be provided to the OPCW.

This strike constitutes a serious violation of Syrian sovereignty and international law. It has immediate implications for the ability of Syria to safely facilitate deployments of OPCW experts and obstructs the effective implementation of the Convention on the ground.

In light of these developments, I respectfully request that you convene an urgent Special Meeting of the Executive Council, pursuant to Rule 12(a) of the Rules of Procedure which, inter alia, states that "the Council shall meet without delay to consider any issue or matter within its competence affecting the Convention and its implementation." Excellency,

Thank you for your letter of 16 July 2025, sent in your capacity as representing the interests of the Syrian Arab Republic at the OPCW, requesting the convening of a meeting of the Executive Council (Council) pursuant to Rule 12(a) of the Rules of Procedure of the Council, which, *inter alia*, states that "the Council shall meet without delay to consider any issue or matter within its competence affecting the Convention and its implementation..."

Rule 12 of the Rules of Procedure of the Council clarifies that the members of the Council should be prepared, at short notice, to attend meetings of the Council and Rule 12(a) outlines some of the circumstances in particular in which this rule may be invoked.

The term "without delay" under Rule 12 has to be understood in light of Rule 14 of the Rules of Procedure of the Council which provides, in relevant part, that "[t]he Director-General shall notify each Representative as far in advance as possible and in any case not less than seventy-two hours in advance of the calling of other meetings unless shorter notification timelines are required by the Convention."

The Convention expressly provides for shorter notification timelines for meetings of the Council only in certain circumstances, including, e.g., under paragraph 17 of Article IX of the Convention, which provides for a meeting of the Council not later

Mr Mutlaq bin Majed Al Qahtani Ambassador, Permanent Representative of the State of Qatar to the OPCW Borweg 7 2597 LR The Hague than 12 hours after having received a request for a Challenge Inspection, as is also reflected in Rule 12(a) of the Rules of Procedure of the Council, which uses the term "immediately" for the same purpose.

The terms "without delay" and "immediately" in Rule 12(a) of the Rules of Procedure of the Council have to be read in light of the provisions of the Convention as well as Rule 14 of the Rules of Procedure of the Council. Unless the Convention specifically provides a shorter timeline for the convening of a meeting of the Council, Rule 14 requires a minimum of seventy-two hours' notice for convening meetings of the Council. Consequently, Representatives have a legitimate expectation that the applicable notification timelines will be followed to allow them time to sufficiently prepare for the meeting.

You will recall that recent meetings of the Council were convened with adherence to the minimum notification timeline under Rule 14, i.e., EC-M-66, which was convened on 12 December 2024 at the request of the Director-General, and EC-M-67, which was convened on 1 July 2025 at the request of the Islamic Republic of Iran to discuss a similar subject-matter.

In accordance with Rules 12(b) and 14 of the Rules of Procedure of the Council, the Director-General has notified the members of the Council that a meeting of the Council shall be convened on Tuesday, 22 July 2025 at 10:00, pursuant to your request.
