### NOTE BY THE CHAIRPERSON OF THE EXECUTIVE COUNCIL

# WITHDRAWAL BY THE PERMANENT REPRESENTATION OF THE REPUBLIC OF COSTA RICA OF A CANDIDATE FOR THE APPOINTMENT TO THE POSITION OF DIRECTOR-GENERAL

- 1. A Note by the Technical Secretariat (EC-109/S/6, dated 2 April 2025) was circulated to the members of the Executive Council (the Council), informing them of the nomination by the Permanent Representation of the Republic of Costa Rica to the OPCW of H.E. Ambassador Arnoldo Brenes Castro as candidate for the position of Director-General of the Technical Secretariat of the Organisation for the Prohibition of Chemical Weapons (OPCW).
- 2. Further to that communication, the Permanent Representation of the Republic of Costa Rica to the OPCW informed the Chairperson, by Note Verbale No. ECRNL-2025-355 dated 18 September 2025, that the candidacy of H.E. Ambassador Arnoldo Brenes Castro for the position of Director-General has been withdrawn.
- 3. At the request of the Permanent Representation of the Republic of Costa Rica to the OPCW, the above-mentioned note verbale is herewith circulated to the members of the Council.
