DECISION

SCALE OF ASSESSMENTS FOR 2007

The Conference of the States Parties,

Recalling that Article VIII, paragraph 7, of the Chemical Weapons Convention (hereinafter “the Convention”), and Regulation 5.1 of the OPCW Financial Regulations require that annual contributions to meet the costs of the OPCW’s activities be paid by States Parties in accordance with the United Nations (UN) scale of assessments adjusted to take into account differences in membership between the UN and the OPCW;

Recalling also that Article VIII, subparagraph 21(b), of the Convention, and Regulation 3.6 of the OPCW Financial Regulations, stipulate that the Conference of the States Parties (hereinafter “the Conference”) shall decide on the scale of financial contributions to be paid by States Parties;

Bearing in mind that its decision on the OPCW Programme and Budget for 2007 (C-11/DEC.11, dated 8 December 2006) calls for assessed annual contributions by States Parties totalling EUR 68,640,103;

Recalling further that, according to OPCW Financial Regulation 5.4, assessed annual contributions to the OPCW Programme and Budget shall be due and payable in full within 30 days of the receipt of communications from the Director-General informing the States Parties of their commitments, or on the first day of the financial period to which the communications relate, whichever is later;

Bearing in mind also that the UN General Assembly established a scale of assessments for 2004 to 2006 at its Fifty-Eighth Session (A/RES/58/1 B, dated 3 March 2004), and that it is expected to determine a new scale of assessments for 2007 by the end of 2006; and

Affirming that it is crucial to the funding of OPCW activities for 2007 that the Technical Secretariat receive assessed annual contributions early in that new financial year;

Hereby:

1. **Adopts** a scale of assessments for annual contributions to the OPCW Programme and Budget for 2007 that shall be adjusted to take into account differences in membership between the UN and the OPCW, and that shall be based on:
 - (a) the UN scale of assessments for 2007 if the UN General Assembly determines the UN scale of assessments for 2007 by the end of 2006; or
 - (b) the UN scale of assessments for 2006 if the UN General Assembly does not determine the UN scale of assessments for 2007 by the end of 2006; and
2. **Calls upon** all States Parties to pay their assessed annual contributions for 2007, in full and on time, in accordance with Regulation 5.4 of the OPCW Financial Regulations.
