ЗАПИСКА ГЕНЕРАЛЬНОГО ДИРЕКТОРА

НОВЫЙ ВНЕШНИЙ АУДИТОР ОЗХО

1. На своей десятой сессии Конференция государств-участников (далее "Конференция") постановила назначить г-на Мухаммада Юнис Хана, Генерального аудитора Пакистана, Внешним аудитором ОЗХО на следующий срок для проведения аудиторской проверки финансовой и административной деятельности ОЗХО за 2006-2008 финансовые годы (документ C-10/DEC.6 от 10 ноября 2005 года).
2. После выхода в отставку 19 июля 2007 года г-на Мухаммада Юнис Хана новым Генеральным аудитором Пакистана стал г-н Танвир Али Ага, который сменил его на посту Внешнего аудитора ОЗХО в соответствии с финансовым положением 13.2, которое гласит:

"Если Внешний аудитор прекращает занимать должность Генерального аудитора в своей собственной стране, его назначение в качестве Внешнего аудитора ОЗХО с этого момента прекращается и в должность Внешнего аудитора вместо него вступает лицо, сменившее его на посту Генерального аудитора в его стране. Внешний аудитор не может быть смещен с должности в течение срока его назначения, иначе как по решению Конференции государств-участников".
3. Срок полномочий г-на Танвира Али Аги в качестве Внешнего аудитора ОЗХО начался 20 июля 2007 года и будет продолжаться до конца 2008 финансового года. К настоящему прилагаются его краткое резюме и биография.



4. В соответствии с упомянутым решением Конференции (документ C-10/DEC.6) в 2009-2011 годах следующим Внешним аудитором ОЗХО будет г-н Норберт Хаузер, заместитель председателя Высшего аудиторского учреждения Германии, для проведения аудиторской проверки финансовой и административной деятельности ОЗХО на первоначальный трехлетний срок.


My Dear Nelson,

Mr. Tanwir Ali Agha The Auditor-General of Pakistan

Mr. Tanwir Ali Agha became the 16th Auditor-General of Pakistan on 20th July, 2007. As the head of the Supreme Audit Institution of Pakistan, Mr. Agha is entrusted with the responsibility of overseeing the financial operations of the Federal and Provincial Governments on behalf of the legislature. He is constitutionally mandated to report to the legislature on the fiscal transparency and results of operations in the public sector.

Mr. Tanwir Ali Agha joined the Pakistan Audit and Accounts Service in 1972. He managed and supervised key slots in the Ministry of Finance for more than two decades. The positions held by Mr. Agha include the Economic Minister to the Embassy of Pakistan, Washington D.C. USA, Executive Director on the Board of the World Bank Washington D.C., Special Secretary Ministry of Finance and Secretary Ministry of Finance.

Mr. Agha's ambition is to bring greater transparency and accountability in the management and over all working of public institutions in Pakistan. As the Auditor-General of Pakistan his aim is to enhance Pakistan's interaction at the professional forums of the international and regional organizations of the Supreme Audit Institutions.
