REPORT BY THE DIRECTOR-GENERAL

STATUS OF IMPLEMENTATION OF ARTICLE VII OF THE CHEMICAL WEAPONS CONVENTION AS AT 27 JULY 2012: ARTICLE VII(1)(A) TO (C) AND OTHER OBLIGATIONS

Legislative and administrative implementation

- 1. In operative paragraph 1 of the decision on the follow-up to the plan of action regarding the implementation of Article VII obligations (C-10/DEC.16, dated 11 November 2005), the Conference stressed that it is imperative for States Parties that had yet to fulfil their obligations under Article VII to do so without delay. Pursuant to C-14/DEC.12, reporting on this matter will be contained in two concurrent reports. This report discusses the status of implementation of Article VII(1)(a) to (c) and other obligations.
- 2. The global status, as at 27 July 2012, of those elements of legislative and administrative implementation falling under the purview of the present report is reflected in the following transversal table:
