It is the need of the hour that the OPCW and States Parties help develop Centers of Excellence on Countering Chemical Terrorism (CECCT) in different regions of the world so that all intentions and plans of using toxic chemicals to terrorize civilians are prevented. Pakistan House considers that such a platform will be one of the most useful sources of applying policy and tactical methods in countering chemical terrorism. We are ready to offer our expertise and services in building such centers.

As an independent, non-partisan and non-political organization, Pakistan House is consistently contributing to the futuristic vision of the OPCW. I am confident that the OPCW will continue to provide both intellectual and material resources to promote the cause of countering chemical terrorism and promotion of responsible chemistry.

Let me take this opportunity and reaffirm that the platform of Pakistan House is available to further the noble cause of the OPCW and CWC Coalition and we look forward to participate in the on-going research projects and to help initiate new ones.
