



## DECISION

### SCALE OF ASSESSMENTS FOR 2018

#### The Conference of the States Parties,

**Recalling** that paragraph 7 of Article VIII of the Chemical Weapons Convention (hereinafter “the Convention”) and Regulation 5.1 of the Financial Regulations and Rules of the OPCW require that annual contributions to meet the costs of the OPCW’s activities be paid by States Parties in accordance with the United Nations scale of assessments, adjusted to take into account differences in membership between the United Nations and the OPCW;

**Recalling also** that subparagraph 21(b) of Article VIII of the Convention and Regulation 3.6 of the Financial Regulations and Rules stipulate that the Conference of the States Parties shall decide on the scale of financial contributions to be paid by States Parties;

**Bearing in mind** that its decision on the Programme and Budget of the OPCW for 2018 (EC-86/DEC.4, dated 11 October 2017) calls for assessed annual contributions by States Parties totalling EUR 65,529,600;

**Recalling further** that, according to Financial Regulation 5.4, assessed annual contributions to the OPCW Programme and Budget shall be due and payable in full within 30 days of the receipt of communications from the Director-General informing the States Parties of their commitments, or on the first day of the financial period to which the communications relate, whichever is later; and

**Affirming** that it is crucial to the funding of OPCW activities for 2018 that the Technical Secretariat receive assessed annual contributions early in that new financial year;

#### Hereby:

1. **Adopts** the scale of assessments for 2018 annexed hereto; and
2. **Calls upon** all States Parties to pay their assessed annual contributions for 2018 in full and on time in accordance with Regulation 5.4 of the Financial Regulations and Rules of the OPCW.
