DÉCISION

BARÈME DES QUOTES-PARTS POUR 2005

La Conférence des États parties,

Sachant que, aux termes de l'article 5.1 du Règlement financier de l'OIAC, le coût des activités de l'OIAC est payé par les États parties conformément au barème des quotes-parts des Nations Unies, sous réserve des ajustements apportés pour tenir compte des différences entre le nombre des États membres de l'Organisation des Nations Unies (ONU) et celui des États membres de l'OIAC,

Notant que le barème des quotes-parts de l'ONU établi pour 2004 par la cinquante-huitième session de l'Assemblée générale de l'ONU (document A/58/1 B) s'applique également à l'ONU pour 2005,

Ayant présent à l'esprit que, aux termes de l'article 5.4 du Règlement financier, les États parties sont tenus de s'acquitter intégralement de leurs contributions au budget dans les 30 jours qui suivent la réception de l'appel de contributions adressé par le Secrétariat, ou le premier jour de l'exercice 2005, si cette date est postérieure,

Rappelant que sa décision (C-9/DEC.14 du 2 décembre 2004) relative au Budget-programme de l'OIAC pour 2005 établit à 70 677 400 euros le montant total des contributions annuelles des États parties mises en recouvrement,

Adopte le barème des quotes-parts pour 2005 joint en annexe au présent document,

Exhorte tous les États parties à s'acquitter intégralement de leurs quotes-parts, conformément aux dispositions de l'article 5.4 du Règlement financier.
