NOTE DU DIRECTEUR GENERAL

SITUATION RELATIVE A LA PRESENTATION DE DECLARATIONS INITIALES ET DE NOTIFICATIONS

Le Directeur général joint à la présente note, comme l'a demandé le Conseil exécutif à sa dixième session (paragraphe 3.4 du rapport de la dixième session du Conseil exécutif, EC-X/2 du 19 juin 1998), la liste des Etats parties qui, au 2 novembre 1998, n'avaient soumis aucune déclaration initiale ou avaient soumis une déclaration initiale incomplète ainsi que d'autres informations qui ont été régulièrement fournies au Conseil exécutif dans les rapports sur l'état d'avancement de l'application de la Convention. Comme il ressort de cette annexe, au 2 novembre 1998, 34 Etats parties n'avaient pas encore soumis leur déclaration initiale telle que prévue aux Articles III, IV, V et VI et à l'Annexe sur la vérification de la Convention. Ces Etats parties sont : Bahreïn, Bénin, Bolivie, Bosnie-Herzégovine, Botswana, Brunéi Darussalam, Burkina Faso, Burundi, Cameroun, Chypre, Costa Rica, Gambie, Ghana, Guinée équatoriale, Guinée, Guyana, Iran (République islamique d'), Koweït, Malawi, Mali, Mauritanie, Namibie, Papouasie-Nouvelle-Guinée, Paraguay, Qatar, République démocratique populaire lao, République de Moldova, République-Unie de Tanzanie, Sainte-Lucie, Sénégal, Swaziland, Togo, Trinité-et-Tobago, Turkménistan.

Depuis la date limite retenue pour arrêter l'annexe de la présente note, Panama est devenu un Etat partie (le 6 novembre 1998) et a déjà soumis sa déclaration initiale conformément aux Articles III et VI de la Convention et à la sixième partie (B) de l'Annexe sur la vérification.
