GRULAC in its meeting held on 2 May 2013 decided to send a communication to the Chairperson of the Executive Council to include a new item on the agenda of the Seventy-Second Session of the Executive Council, according to the following argumentation:

"Status of the Implementation of Article XI"

As it is stated in the facilitation mandate, the facilitator should report in each session of the Executive Council the activities that took place during the intersessional period.

Therefore, it is necessary that the facilitator presents in a specific item of the agenda a detailed report on the meeting that took place before the Third Review Conference, in which the Technical Secretariat made a presentation on the status of the implementation of Article XI, and several delegations discussed on the best way to carry on such implementation. It is not enough that this issue is only presented by the Vice Chair in charge of Article XI, as it does not provide the necessary space for delegations to discuss and debate.

A written report of the Director General should not be a requisite to request the specific discussion of such important issue. There are many precedents of sessions of the Executive Council in which, without a written report from the Director General, and after the formal presentation of the Vice Chair, there is a specific item in the agenda for the facilitator to present the activities and results, allowing for a proper discussion that is later on reflected in the final report of the EC.
