EXPLANATORY MEMORANDUM

RE: REQUEST FOR AN EC-73 AGENDA ITEM

ENTITLED "CONCERNS ABOUT USE OF CHEMICAL WEAPONS IN SYRIA"

The Permanent Representatives to the OPCW of Canada, France, Germany, the United Kingdom and the United States respectfully request that the issue of "Concerns about Use of Chemical Weapons in Syria" be added to the agenda of EC-73.

At the Third Review Conference in April 2013, the States Parties reiterated their deep concern that chemical weapons may have been used in the Syrian Arab Republic. Since then, reports of the use of chemical weapons have intensified. The United Kingdom, France and the United States have now publicly stated that they have high confidence that chemical weapons have been used in Syria.

The Third Review Conference also stressed that "the use of chemical weapons by anyone under any circumstances would be reprehensible and completely contrary to the legal norms and standards of the international community." The Preamble of the Chemical Weapons Convention makes clear the determination of the States Parties "...for the sake of all mankind, to exclude completely the possibility of the use of chemical weapons, through the implementation of the provisions of this Convention, thereby complementing the obligations assumed under the Geneva Protocol of 1925...." Thus, the reported use of chemical weapons by anyone is directly related to the object and purpose of the Convention.

For the sake of the credibility and relevance of the OPCW as the international body with the responsibility "to exclude completely the possibility of the use of chemical weapons," the Executive Council must demonstrate that it is seriously addressing the Syrian issue by including it in its formal agenda for EC-73.
