### **ANNOTATED PROVISIONAL AGENDA FOR THE SEVENTY-SIXTH SESSION OF THE EXECUTIVE COUNCIL, 8-11 JULY 2014**

This revised annotated agenda<sup>1</sup> has been prepared by the Technical Secretariat (hereinafter “the Secretariat”) to guide and assist members of the Executive Council (hereinafter “the Council”) in their substantive preparations for its Seventy-Sixth Session. - 6.1 Further to a decision by the Conference of the States Parties (hereinafter “the Conference”) at its Sixteenth Session (C-16/DEC.11, dated 1 December 2011), the Council is **requested** to consider and note a report by the Director-General on the overall progress of destruction activities by possessor States Parties (EC-76/DG.15, dated 4 July 2014).

6.2 Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6, dated 15 February 2012), the Council is **requested** to consider and note a report by the Director-General on the overall progress of the destruction of abandoned chemical weapons (EC-76/DG.17, dated 7 July 2014).

**Subitem 6(b): Implementation of the Conference of the States Parties and Executive Council decisions on destruction-related issues**

6.3 The Secretariat is expected to brief the Council on its destruction-related verification activities.

6.4 The States Parties concerned are expected to brief the Council on their destruction-related activities.

6.5 The Council is **requested** to consider and note the report of the visit by the Chairperson of the Council and representatives of the Council to the Kizner chemical weapons destruction facility in the Russian Federation, from 14 to 18 April 2014 (EC-76/1, dated 30 May 2014).

6.6 Further to a decision by the Conference at its Sixteenth Session (C-16/DEC.11), the Council is **requested** to consider and note a national paper by the United States of America on the progress made on the completion of the destruction of its chemical weapons, including information on measures to accelerate such progress, and identifying progress made since the last briefing in order to meet the planned completion date. This report is also to include reporting on any specific measures undertaken to overcome problems in the destruction programme (EC-76/NAT.2, dated 12 June 2014).

6.7 Further to the same decision by the Conference at its Sixteenth Session (C-16/DEC.11), the Council is **requested** to consider and note a national paper by the Russian Federation on the progress made on the completion of the destruction of its chemical weapons, including information on measures to accelerate such progress, and identifying progress made since the last briefing in order to meet the planned completion date. This report is also to include reporting on any specific measures undertaken to overcome problems in the destruction programme (EC-76/NAT.4, dated 26 June 2014).

6.8 Further to the same decision by the Conference at its Sixteenth Session (C-16/DEC.11), the Council is **requested** to consider and note a national paper by Libya on the progress made on the completion of the destruction of its chemical weapons, including information on measures to accelerate such progress, and identifying progress made since the last briefing in order to meet the planned completion date. This report is also to include reporting on any specific measures undertaken to overcome problems in the destruction programme (EC-76/NAT.5, dated 30 June 2014).

6.9 The Council is **requested** to note a Note by the Director-General reporting on progress in the elimination of the Syrian chemical weapons programme (EC-76/DG.14, dated 25 June 2014).

- 6.10 A national paper by the Syrian Arab Republic has been made available to the members of the Council (EC-76/P/NAT.1, dated 16 June 2014).
- 6.11 At its Forty-Second Meeting, the Council further considered the combined plans for the destruction and verification of chemical weapons production facilities in the Syrian Arab Republic (EC-M-40/DG.2, dated 27 March 2014), and decided to continue consideration at its forthcoming session.
- 6.12 The Council is **requested** to note an overall report by the Director-General on the elimination of the Syrian chemical weapons programme (EC-76/DG.16, dated 4 July 2014).
- 6.13 Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6), a national paper by China (EC-76/NAT.6, dated 2 July 2014) and a national paper by Japan (EC-76/NAT.3, dated 13 June 2014) on the overall progress of the destruction of chemical weapons abandoned by Japan on the territory of China have been circulated to the members of the Council.

**Subitem 6(c): Other verification-related issues**

- 6.14 The Secretariat is expected to brief the Council on its other verification-related activities.
- 6.15 The Secretariat will make a presentation on the Secure Information Exchange (SIX) project.

**Subitem 6(d): Destruction-related plans and facility agreements**

- 6.16 The Secretariat has submitted to the Council a Note on amendments to the facility agreement with the Slovak Republic regarding on-site inspections at a Schedule 1 protective purposes facility (EC-76/S/3, dated 16 June 2014).
- 6.17 The Council is **requested** to consider and adopt a draft decision on amendments to the aforementioned facility agreement (EC-76/DEC/CRP.3, dated 16 June 2014). The amendments have been submitted separately to the Council (EC-76/P/DEC/CRP.1, dated 16 June 2014), which is **requested** to consider and approve them. The amendments to the facility agreement are reflected (in red-lining, for ease of reference) in the revised version of the facility agreement.
- 6.18 The Council is **requested** to consider and approve the agreed detailed plan for verification of the destruction of chemical weapons at the Pueblo Chemical Agent-Destruction Pilot Plant Explosive Destruction System, located at Pueblo, Colorado, the United States of America (EC-76/DEC/CRP.4, dated 23 June 2014).
- 6.19 The Council is **requested** to consider and approve the facility agreement with the United States of America regarding on-site inspections at the Pueblo Chemical Agent-Destruction Pilot Plant Explosive Destruction System, located at Pueblo, Colorado, the United States of America (EC-76/DEC/CRP.5, dated 23 June 2014).

**Subitem 6(e): Verification Implementation Report for 2013**

- 6.20 The Council is **requested** to consider and note the Verification Implementation Report (VIR) for the period from 1 January to 31 December 2013 (EC-76/HP/DG.1\*, dated 29 April 2014 and Corr.1, dated 7 July 2014). The Council is also **requested** to note the comments and views received on the 2013 VIR (EC-76/HP/DG.2, dated 7 July 2014), as well as the Chairperson's summary of the informal consultations on it (EC-76/4, dated 25 June 2014).

**Subitem 6(f): The content of the assistance-and-protection data bank and its use**

- 6.21 The Council is **requested** to consider and note a Note by the Secretariat on the content of the assistance-and-protection data bank and its use (EC-76/S/2, dated 11 June 2014).

**Subitem 6(g): Timely submission of declarations under Article VI**

- 6.22 Further to a decision by the Council at its Fifty-First Session (EC-51/DEC.1, dated 27 November 2007), the Council is **requested** to note a status report by the Director-General on the timely submission by States Parties of declarations under Article VI of the Chemical Weapons Convention (hereinafter "the Convention") for the period from 1 January to 31 May 2014 (EC-76/DG.10\*, dated 11 June 2014).
- 6.23 Further to the decision of the Council at its Sixty-Sixth session on the policy guidelines for determining the number of Article VI inspections (EC-66/DEC.10, dated 7 October 2011), the Council is **requested** to note the report by the Director-General on the results of the implementation of these policy guidelines (EC-76/DG.3, dated 3 April 2014).

**Subitem 6(h): Article VII: briefings by the facilitator and by the Technical Secretariat**

- 6.24 The facilitator for this issue, Dr Zlatko Dimitroff of Bulgaria, is expected to report on the consultations carried out during the intersessional period.
- 6.25 The Secretariat will make a presentation on the status of implementation of Article VII.

**Subitem 6(i): Article X: briefings by the facilitator and by the Technical Secretariat**

- 6.26 The facilitator for this issue, Ms Sarah Broughton of the United Kingdom of Great Britain and Northern Ireland, is expected to report on the consultations carried out during the intersessional period.
- 6.27 The Secretariat will make a presentation on the status of implementation of Article X.

**Subitem 6(j): Report by the Director-General on the Technical Secretariat's readiness to conduct a challenge inspection or an investigation of alleged use**

- 6.28 The Council is **requested** to consider and note a Note by the Director-General reporting on the readiness of the Secretariat to conduct a challenge inspection or an investigation of alleged use (EC-76/DG.11, dated 12 June 2014).

**Subitem 6(k): Technical Secretariat's activities: submission of the summary report of the OPCW Fact-Finding Mission in Syria**

- 6.29 At the Forty-Second Meeting of the Council on 17 June 2014, the Secretariat circulated the summary report of the OPCW Fact-Finding Mission in Syria covering the period from 3 to 31 May 2014 (S/1191/2014, dated 16 June 2014). Delegations requested more time to study the report and to revert to the matter at a later stage.

**7. AGENDA ITEM SEVEN – OPCW Central Analytical Database**

The Council is **requested** to consider a Note by the Director-General on the lists of new validated data of scheduled chemicals for approval by the Council for inclusion in the OPCW Central Analytical Database (EC-76/DG.4, dated 22 April 2014) and to adopt a decision on their inclusion (EC-76/DEC/CRP.1, dated 27 May 2014).

**8. AGENDA ITEM EIGHT – Reports of the Office of Internal Oversight**

**Subitem 8 (a) Report on the implementation in 2013 of the recommendations of the Office of Internal Oversight**

- 8.1 The Council is **requested** to consider a report by the Director-General on the implementation in 2013 of the recommendations contained in the 2012 annual report of the Office of Internal Oversight (OIO) (EC-76/DG.1, dated 17 March 2014).
- 8.2 The facilitator for this issue, Ms Sakiko Hayakawa of Japan, is expected to report on consultations held during the intersessional period.

**Subitem 8 (b) Report of the Office of Internal Oversight for 2013**

- 8.3 The Council is **requested** to consider and note the annual report of the OIO for the period from 1 January to 31 December 2013 (EC-76/DG.2 C-19/DG.3, dated 27 March 2014), which the Director-General has submitted to it, along with his comments. The Council is also **requested** to make any comments it deems appropriate on the report. In accordance with Financial Regulation 12.5, the Director-General will transmit the report to the Conference at its Nineteenth Session, together with his own comments and any that the Council may deem appropriate.
- 8.4 The facilitator for this issue, Ms Sakiko Hayakawa of Japan, is expected to report on consultations held during the intersessional period.

**9. AGENDA ITEM NINE – Draft annual report of the OPCW on the implementation of the Convention in 2013**

The Council is **requested** to consider the “Draft Report of the OPCW on the Implementation of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction in 2013” (EC-76/CRP.1, dated 19 May 2014), and to forward it to the Conference for consideration at its Nineteenth Session.

10.3 The Council is **requested** to note a Note by the Secretariat on a nomination for membership of the ABAF (EC-76/S/7, dated 7 July 2014) and to appoint Mr Nikolay V. Lozinskiy of the Russian Federation, to replace Mr Vladimir A. Iosifov, retroactive to the date of the letter of nomination for Mr Lozinskiy (2 July 2014).

10.4 The Council is **requested** to note the Director-General’s “Annual Report on the Composition of the Technical Secretariat” (EC-76/DG.9, dated 4 June 2014).

**Subitem 10(c): Report by the Director-General on the implementation of the tenure policy in 2013**

10.5 The Council is **requested** to consider and note a report by the Director-General on the implementation of the tenure policy in 2013 (EC-76/DG.7, dated 3 June 2014).

**Subitem 10(d): Amendment to Interim Staff Rule 4.1.05 on retirement**

10.6 The Council is **requested** to consider the proposed amendment to Interim Staff Rule 4.1.05 (EC-76/DG.12, dated 16 June 2014) and to adopt a draft decision on this matter (EC-76/DEC/CRP.2, dated 16 June 2014).

**Subitem 10(e): Proposal for the rehiring of inspectors**

10.7 At its Thirty-Fifth Meeting, the Council requested the Chairperson of the ABAF to consult with the other members of the ABAF regarding the financial implications of rehiring inspectors, and to report back to the next regular session of the Council, with



a view to taking a decision at that meeting. The Secretariat was also requested to inform the Council at its next regular session whether there would be, or would not be, any additional financial implications with the implementation of the proposed initiative (paragraph 6 of EC-M-35/3, dated 29 November 2013).

- 10.8 The Council is **requested** to note the Note by the Secretariat on the rehiring of former inspectors (EC-76/S/5, dated 2 July 2014).

**11. AGENDA ITEM ELEVEN – Follow-up process to the Third Review Conference**

At its Seventy-Third Session, the Council requested the Director-General to submit to each regular session of the Council the updated version of the “Matrix of Actionable Items Identified at the Third Review Conference” (paragraph 13.1 of EC-73/6, dated 19 July 2013), which the Council is **requested** to consider and note (EC-76/S/6, dated 3 July 2014).

**12. AGENDA ITEM TWELVE – Education and outreach**

- 12.1 The Permanent Representative of Argentina submitted a request to the Chairperson of the Council and the Director-General to include an agenda item entitled “Education and Outreach” on the provisional agenda of this session (EC-76/3).

- 12.2 A national paper by Argentina entitled “Final Report on the Regional Meeting on Education in the Responsible Application of Knowledge of Dual-Use Chemicals, Buenos Aires, Argentina, 7–9 April 2014” has been made available (EC-76/NAT.1, dated 5 June 2014).
