NOTE BY THE CHAIRPERSON OF THE EXECUTIVE COUNCIL

NOMINATION BY LITHUANIA OF A CANDIDATE FOR APPOINTMENT TO THE POSITION OF DIRECTOR-GENERAL

- 1. At its Eighty-Fourth Session, the Executive Council (hereinafter "the Council") adopted a decision on the process for the appointment of the Director-General (EC-84/DEC.7, dated 9 March 2017), requesting the Chairperson of the Council to invite, on the Council's behalf, States Parties to present their nominations of candidates for the position of Director-General of the Technical Secretariat of the Organisation for the Prohibition of Chemical Weapons (OPCW) by no later than 23 June 2017, to enable their consideration at the Eighty-Fifth Session of the Council.
- 2. The Permanent Representation of Lithuania to the OPCW has submitted to the Chairperson of the Council a note verbale informing him of the nomination by the Government of Lithuania of H.E. Ambassador Vaidotas Verba, OSCE Project Co-ordinator in Ukraine, as candidate for the position of Director-General.
- 3. Pursuant to Rule 48 of the Rules of Procedure of the Council, the above-mentioned note verbale is herewith circulated to the members of the Council and all other States Parties
