Fifteenth Session (16 - 20 December 1996)

REPORT OF THE COMMISSION

1. Introduction

- 1.1 In accordance with its decision recorded in the Report of the Fourteenth Session of the Preparatory Commission (PC-XIV/29), the Commission convened its Fifteenth Session in The Hague, the Netherlands, from 16 20 December 1996.
- 1.2 During the period under review, no additional States signed the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction. The number of signatory States therefore stood at 160.
- 1.3 In the same period, seven additional States deposited an instrument of ratification with the Secretary-General of the United Nations, as Depositary of the Convention, thus bringing the number of ratifications to 67: Saudi Arabia (9 August 1996), India (3 September 1996), Portugal (10 September 1996), Cameroon (16 September 1996), Hungary (31 October 1996), Swaziland (20 November 1996), and the Philippines (11 December 1996). The deposit of the 65th instrument of ratification, on 31 October 1996, triggered the entry into force of the Convention 180 days later, on 29 April 1997.
- 1.4 The following 90 Member States participated in the Fifteenth Session of the Commission:

4. AGENDA ITEM THREE - Report of the Executive Secretary

The Commission **received** the Report of the Executive Secretary, Mr Ian R. Kenyon (PC-XV/5 and Corr.1 and 2). The Report is divided into two parts: Part I provides an overview; and Part II covers the intersessional period from 17 July to 12 December 1996.

5. AGENDA ITEM FOUR - General discussion on major outstanding issues

- 5.1 Statements were made by the delegations of Japan, South Africa, Brazil (on behalf of the Latin American and Caribbean Group), Germany, Brazil, Italy, France, Ireland, China, Indonesia, India, Hungary, United Kingdom of Great Britain and Northern Ireland, Sweden, Russian Federation, Pakistan, United States of America, France (on behalf of the Western European and Other States Group), Austria, Ethiopia (on behalf of the African Group), Zimbabwe, Switzerland, Uganda, Poland, Cuba, Canada, Philippines, Kenya, Turkey, and the Islamic Republic of Iran.
- 5.2 In accordance with the recommendation of Working Group A, the Commission allocated specific time under this agenda item for a discussion of the Preliminary Draft OPCW Programme and Budget for 1997, including its budgetary variations which may be necessary due to expressed concerns about basic assumptions. The delegations of Mexico, the Islamic Republic of Iran, India, Germany, Canada, Italy, Sweden, Australia, the United States of America, the United Kingdom of Great

Britain and Northern Ireland, France and the Russian Federation spoke during this segment of the debate. The Executive Secretary noted that several delegations, including some of those which spoke in the first part of the general debate, had expressed concerns about the need to ensure that the Draft OPCW Budget, to be proposed by the Commission to the First Session of the Conference of the States Parties for adoption, should be appropriate to the circumstances at that time and that the assumptions which had guided the work on budgetary issues thus far might prove to be invalid. The Executive Secretary assured the Commission that he was aware of the problem and of the discussion which had taken place in connection with the Secretariat discussion paper: "Verification Resource Requirements: Variations on a Theme" (PoWB Paper No. 12). The Executive Secretary expressed the view that the most effective way to proceed would be for the Expert Group on Programme of Work and Budget to have a detailed discussion of the OPCW Draft Programme and Budget document (PC-XV/A/WP.3) prepared by the Secretariat; to identify means to adjust, if necessary, the draft OPCW Budget in accordance with the prevailing situation; to produce a draft budget incorporating different options enabling sufficient flexibility for the final Session of the Commission to propose an adequate budget to the First Session of the Conference of the States Parties. The Commission endorsed this approach.

- 5.3 The Commission **decided** to review at its next Session the status of ratification of the Convention by all possessors of chemical weapons, chemical weapons production facilities or chemical weapons development facilities, and in this context the status of ratification in the Russian Federation and the United States of America and the implications of that to the universal and comprehensive nature of the Convention, and to make appropriate recommendations to the First Session of the Conference of the States Parties.
- 5.4 The Commission **requested** the Executive Secretary to present to the next Session of the Commission a comprehensive background report on the issue and on possible scenarios.
- 6. AGENDA ITEM FIVE Preparations for the First Session of the Conference of the States Parties
- 6.1 The Commission **noted** the Report of the Committee on Preparations for the First Session of the Conference of the States Parties (PC-XV/FS/1), which was presented by the Chairman of the Committee, Ambassador Marin Buhoara of Romania.
- 6.2 The Commission **reached agreement** on the arrangements for the First Session of the Conference of the States Parties as reflected in the draft letter of invitation and the draft note verbale contained in Annex 1 to this Report.

7. AGENDA ITEM SIX - Report of Working Group A

7.1 On 20 December 1996 the Chairman of Working Group A, Ambassador Carlos Enrique Nones of Venezuela, introduced the Report of Working Group A

(PC-XV/A/8). The Commission **took the following action** in relation to matters arising out of the Report of Working Group A:

Administrative, Financial, and Personnel Matters

7.2 The Commission **delegated** to Working Group A the authority to finally approve, after consideration during the intersessional period prior to the Sixteenth Session of the Commission, the Draft Protocol Regarding the Transfer of Assets, Liabilities, Records and Functions from the Preparatory Commission for the Organisation for the Prohibition of Chemical Weapons (Annex to PC-XV/A/WP.11).

Programme of Work and Budget

On transfers in the 1996 Programme of Work and Budget of the Commission

7.3 The Commission **noted** that Working Group A, in accordance with the authority delegated to it by the Commission at its Fourteenth Session (PC-XIV/29, subparagraph 8.7), had approved the inter-programme transfer of funds contained in PC-XV/3 (subparagraph 2.2 of PC-XV/A/3).

On the Prorated 1997 Part I Programme of Work and Budget of the Commission

- Noting that, in accordance with the ad referendum procedure agreed to by the Expert Group on Programme of Work and Budget (subparagraph 6.1 of PC-XV/A/WP.9), no objection to the Prorated 1997 Part I Programme of Work and Budget of the Commission (PC-XV/A/WP.2/Rev.1 and Corr.1) had been received by the Secretariat by 15 November 1996, the Commission:
 - (a) **approved** the contents of subparagraph 3.2 of PC-XV/A/WP.9;
 - (b) **approved** the Prorated Part I Programme of Work and Budget of the Commission for the 1997 budgetary period (PC-XV/A/WP.2/Rev.1 and Corr.1);
 - (c) **appropriated**, in Dutch guilders, a total amount of Dfl. 13,214,800 for the Prorated 1997 Part I Programme of Work and Budget of the Commission, and **authorised** the Executive Secretary to incur expenditures in an amount not exceeding that total;
 - (d) **decided** that the appropriations specified in subparagraph 7.4(c) above be financed by contributions from all Member States in the amount of Dfl. 13,164,800 in accordance with the scale of assessments circulated to Member States prior to the Fifteenth Session of the Commission (PC-XV/A/4), as well as by estimated prorated interest income in the amount of Dfl. 50,000; and

(e) **decided to continue** the Special Account for the Procurement of Inspection and Laboratory Equipment for the duration of the life of the Commission.

On the payment of contributions to the Prorated 1997 Part I Budget of the Commission

7.5 The Commission **requested** Member States to pay their contributions to the Prorated 1997 Part I Programme of Work and Budget of the Commission in full within thirty days of the receipt of the communication from the Executive Secretary requesting the contribution.

On inter-programme transfers within the Prorated 1997 Part I Programme of Work and Budget of the Commission

- 7.6 The Commission **authorised** the Executive Secretary, in accordance with Financial Regulation 4.5, to make, if necessary, the following inter-programme transfers within the Prorated 1997 Part I Programme of Work and Budget of the Commission:
 - (a) transfers of funds between programmes for official travel in a total amount equal to 15% of the allocation for this budget category for the budgetary period; and
 - (b) transfers of general temporary assistance funds between programmes in a total amount equal to 15% of the allocation for this budget category for the budgetary period.

On the implementation of the 1996 Part II Programme of Work and Budget of the Commission

7.7 The Commission **requested** the Executive Secretary to consider each element of expenditure in the light of developments having financial and budgetary implications and to report as appropriate to the Commission.

On the implementation of the Prorated 1997 Part I Programme of Work and Budget of the Commission

7.8 The Commission **requested** the Executive Secretary to consider each element of expenditure in the light of developments having financial and budgetary implications and to report as appropriate to the Commission.

OPCW Headquarters Agreement and Other Agreements

- 7.9 The Commission:
 - (a) **provisionally approved** the Draft Agreement between the Organisation for the Prohibition of Chemical Weapons (OPCW) and the Kingdom of the Netherlands Concerning the Headquarters of the OPCW including the Separate Arrangement with respect to the Agreement between the Organisation for the Prohibition of Chemical Weapons and the Kingdom of the Netherlands Concerning the Headquarters of the OPCW (Annex to PC-XV/A/WP.10/Rev.1), and **decided** that this approval will become final if

- no objections from any delegation are received by the Secretariat by 10 January 1997 in The Hague; and
- (b) **requested** the Host Country to implement this Agreement, including a Separate Arrangement, on a provisional basis after the Convention enters into force on 29 April 1997, pending the approval by the Conference of the States Parties of the text of the Headquarters Agreement including a Separate Arrangement and the entry into force of the Agreement.

8. AGENDA ITEM SEVEN - Report of Working Group B

8.1 On 20 December 1996 the Chairman of Working Group B, Dr Radoslav Deyanov of Bulgaria, introduced the Report of Working Group B (PC-XV/B/16). The Commission **took the following action** in relation to matters arising out of the Report of Working Group B:

Chemical Weapons Issues 2

8.2 The Commission **decided** to delete the task "Finalise recommendations for guidelines for transitional verification arrangements, in accordance with Part IV(A), paragraph 51 of the Verification Annex (subparagraph 12(m) of the Paris Resolution)" from its list of tasks. This deletion was on the understanding that the above task has been fully addressed by Section III and Appendix 1 of the Chairman's Paper annexed to the Third Report of the Expert Group on Chemical Weapons Destruction Facilities (PC-VI/B/WP.14) and by Table 1 of the same Group's Interim Report (PC-V/B/WP.17).

Inspection Procedures

- 8.3 The Commission considered and:
 - (a) **approved** the contents of the administrative package for the biomedical module of the alleged use sample collection kit as contained in Annex 2 to PC-XV/B/WP.9;
 - (b) **approved** the results of the evaluation of the GC data as contained in Annex 1 to PC-XV/B/WP.9;
 - (c) **approved** the inclusion of analytical data in the OPCW Analytical Database for the test chemicals, as contained in the "Recommended Operating Procedure for On-Site Analysis by Gas Chromatography/Mass Spectrometry (GC/MS)" (PC-XIV/B/WP.5, Annex 5) on the understanding that the test samples will not contain scheduled chemicals and that, therefore, the use of the above data, during on-site analysis, will be restricted to GC/MS performance tests and that analytical procedures which prevent cross contamination of the test chemicals are applied, as appropriate;

- (d) **approved** the understanding reached by the Expert Group on Inspection Procedures that, in relation to proficiency tests following the first test, the conditions set out in subparagraphs 4.1(b)(i) to (viii) of PC-XV/B/WP.9 shall apply;
- (e) **instructed** the Secretariat to proceed with the notification of proficiency testing in accordance with the recommendation that the schedule information shall be communicated at least two months prior to the scheduled starting date directly to all laboratories which have previously participated in proficiency tests. This information shall also be simultaneously communicated to all Member States to facilitate the participation of new laboratories. The laboratory or the Member State must notify the Secretariat if the laboratory intends to participate in the test. This notification must be provided to the Secretariat within one month after the Secretariat's communication of the schedule information;
- of the two items of equipment "individual heat stress monitor" and "portable acetylcholinesterase activity monitor" as set out in Annex 3 to PC-XV/B/WP.9, and **added** these two items to the list of equipment approved by the Commission for its budgetary purposes (Annex to PC-VIII/A/WP.7), on the understanding that their future use on-site will be governed, inter alia, by the provisions of subparagraph 4.2 of the Draft OPCW Health and Safety Regulations.

8.4 The Commission **took note**:

- (a) of the agreement in the Expert Group on Inspection Procedures that the validation of the central OPCW Analytical Database should be addressed by the Secretariat;
- (b) that, whilst the NIPPS system meets many of the operational requirements and technical specifications, several key requirements are not met and that these aspects should be addressed by the Secretariat and the appropriate recommendations should be adopted by the appropriate bodies of the Commission;
- (c) that further evaluation of the GC/MS instruments should be performed by the Secretariat and, if available, with the assistance of Member States to address the aspects referred to in subparagraph 5(c) of PC-XV/B/WP.9;
- (d) that, in relation to the preliminary evaluation report of the First Official Proficiency Test, GC/MS(EI) by quadrupole and ion trap instruments should not be regarded as two different analytical techniques; and
- (e) of the view that inspector training on portable GC/MS instruments should be carried out on instruments of both manufacturers on the understanding that

there will be no financial consequences for the Commission and for the OPCW.

9. AGENDA ITEM EIGHT - Report of the Credentials Committee

- 9.1 The Commission **noted** the Report of the Credentials Committee (PC-XV/12), which was presented on 19 December 1996 by Mr Gianfranco Tracci of Italy, the newly-elected Chairman of the Committee, replacing Mr Gerardo Girardo Crocini of Italy.
- 9.2 The Chairman orally informed the Commission that, subsequent to the adoption of the Committee's Report, formal credentials were received for the Representatives of Belarus and El Salvador, and an official communication was received regarding the accreditation of the Representative of the United Republic of Tanzania. These will be recorded in the next Report of the Credentials Committee at the Sixteenth Session of the Commission.
- 9.3 Accordingly, at the time of the Fifteenth Session the following 109 Member States had Representatives to the Commission, accredited or provisionally participating in accordance with Rules 2, 3, and 5 of the Rules of Procedure of the Commission: Algeria, Argentina, Australia, Austria, Bahamas, Bahrain, Bangladesh, Belarus, Belgium, Bolivia, Brazil, Brunei Darussalam, Bulgaria, Burkina Faso, Cameroon, Canada, Cape Verde, Chad, Chile, China, Colombia, Congo, Costa Rica, Côte d'Ivoire, Croatia, Cuba, Cyprus, Czech Republic, Denmark, Ecuador, El Salvador, Estonia, Ethiopia, Fiji, Finland, France, Gabon, Germany, Ghana, Greece, Holy See, Honduras, Hungary, India, Indonesia, Iran (Islamic Republic of), Ireland, Israel, Italy, Japan, Kazakhstan, Kenya, Kuwait, Lesotho, Lithuania, Luxembourg, Malaysia, Mali, Malta, Mauritius, Mexico, Monaco, Mongolia, Morocco, Myanmar, Namibia, Nepal, Netherlands, New Zealand, Niger, Nigeria, Norway, Oman, Pakistan, Panama, Papua New Guinea, Paraguay, Peru, Philippines, Poland, Portugal, Republic of Korea, Romania, Russian Federation, Saudi Arabia, Senegal, Slovak Republic, Slovenia, South Africa, Spain, Sri Lanka, Swaziland, Sweden, Switzerland, Thailand, Togo, Tunisia, Turkey, Uganda, Ukraine, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland, United Republic of Tanzania, United States of America, Uruguay, Uzbekistan, Venezuela, Zambia and Zimbabwe.
- 9.4 The Commission **urged** all provisionally participating Member States to comply with Rule 2 of the Rules of Procedure as soon as possible so that all representatives of Member States are duly accredited at the final Session of the Commission.
- 9.5 The Commission **encouraged** Member States to submit the documents required for the appointment or replacement of Representatives not less than one week before the date fixed for the opening of the next Session.

10. AGENDA ITEM NINE - Report of the Committee on Relations with the Host Country

The Commission **noted** the Report of the Committee on Relations with the Host Country (PC-XV/HC/4), which was presented by the Chairman of the Committee, Ambassador Marin Buhoara of Romania. The Commission, recalling its earlier decision (PC-XIII/18, subparagraph 9.6), **noted in particular** the approval of the

Committee for the Sublease Agreement to be entered into between the Commission and the United Nations International Criminal Tribunal for the Former Yugoslavia (UN-ICTY) for the space available in the Aegon Building (see PC-XV/HC/3 and Corr.1) and the authority given to the Executive Secretary to sign the Sublease Agreement at the earliest convenience following the clarification and successful conclusion of a few outstanding issues with the UN-ICTY. On the recommendation of the Committee, the Commission **decided** that the Sublease Agreement be forwarded to the Conference of the States Parties as its First Session for confirmation.

11. AGENDA ITEM TEN - Election of the Chairman and other Officers of the Commission

- 11.1 In accordance with Rules 7 and 8 of the Rules of Procedure the Commission **elected** by acclamation Ambassador Gustavo Eduardo Figueroa of Argentina as Chairman for the period from 8 February 1997 to the end of the life of the Commission.
- 11.2 The Commission also **elected** the Representatives of Zimbabwe, Pakistan, Poland, Brazil, and the United States of America as Vice-Chairmen for the same period.

12. AGENDA ITEM ELEVEN - Appointments to the Credentials Committee

Upon the proposal of the Chairman of the Commission, the Republic of Korea was **appointed** to the Credentials Committee by the Commission, in accordance with Rule 4 of its Rules of Procedure, to the seat vacated by Nepal.

13. AGENDA ITEM TWELVE - Any other business

Intra-programme transfers

13.1 The Commission **noted** that the intra-programme transfers reported in PC-XV/3 were made in accordance with the requirements of Financial Regulation 4.5.

Plan of activities and schedule of meetings for the period January - April 1997

13.2 The Commission **approved** the "Plan of Activities and Schedule of Meetings of Subsidiary Bodies of the Commission for the Period January - April 1997" as contained in Annex 2 to this Report. Titles in parentheses are simply indicative of clusters of issues on which work will concentrate during that particular period, leaving to the Chairperson of the Expert Group some flexibility in arranging the work. The task shall be to prepare appropriate language either as the solution to the outstanding issues, for inclusion in the draft Final Report of the Commission, or by submitting agreed language to describe the situation in relation to those unresolved issues. The agreed language will be adopted by Expert Groups in formal meetings. The agreed language, after its adoption by the appropriate Working Group, shall be passed to the Committee on Preparations for the First Session of the Conference of the States Parties for inclusion in the draft Final Report of the Commission. The Combined Meeting of Working Groups A and B on 3 March 1997 will take a decision on arrangements for the remaining intersessional period. The meeting of the Finance

Group, if required, will be arranged in consultation with the Chairman and members of that Group with at least three weeks' advance notification of the meeting.

Renewal of appointment of Executive Secretary

13.3 In accordance with the decision adopted by the Commission at its First Plenary Session, as contained in subparagraph 11(b) of PREPCOM/I/4, and with the decisions adopted by the Commission at its Ninth and Twelfth Sessions, as contained in subparagraphs 10.2 of PC-IX/11 and 11.4 of PC-XII/17 respectively, the Commission **renewed** the appointment of Mr Ian R. Kenyon as Executive Secretary for the period from 11 February 1997 until one month after the person appointed to be Director-General of the Technical Secretariat of the Organisation for the Prohibition of Chemical Weapons has taken up post.

Trust Fund for Personnel of National Authorities

13.4 The Commission **took cognisance of** the Executive Secretary's Note on the Trust Fund for Personnel of National Authorities (PC-XV/4), which records all contributions received for this fund since 9 July 1996.

Forthcoming basic course for personnel of National Authorities

- 13.5 The Executive Secretary drew attention to the invitation already extended to Member States, in PC-XV/B/12, to propose candidates for a basic course for personnel of National Authorities to take place in Ypenburg, the Netherlands, from 10 28 February 1997.
- 13.6 The Executive Secretary was asked to state his policy regarding the provision of training. He stated as follows:

"This is indeed a very important question, and I want my own position to be absolutely clear. As far as I am concerned all members of the Technical Secretariat, currently the Provisional Technical Secretariat, and all inspector trainees and later the inspectors to become part of the Technical Secretariat are equal members currently of the Commission's Secretariat staff, and later of the Organisation for the Prohibition of Chemical Weapons, and should be treated the same.

Under the General Training Scheme, which is put together to enable us to train inspectors for recruitment to the new Organisation, it is, as far as I am concerned, fundamental that all trainees should receive fully appropriate training, regardless of whatever country they come from and regardless of what their specialities may be within the agreed specialities for inspectors.

It is my job to ensure that, by constructing the General Training Scheme, I can make sure that they do indeed receive that equal treatment. I believe that it is important that I have a scheme which enables me to do that. I believe I can construct a scheme which enables me to do that.

However, it is also my understanding that, within the Convention itself, the reality of the international situation is recognised. And every Member State has the right, when offered a list of potential inspectors on its territory, to say which it will accept and which it will not accept and is not obliged to give the reasons for those decisions. It seems to me that there is a direct parallel that, if a State which has generously offered training facilities is offered a list of trainees, it may, if it wishes, reserve the right to ask to have individual trainees replaced by others without necessarily stating the reasons.

It is my job to ensure that no trainee and no receiving State if at all possible is put in the embarrassing situation where that would actually happen. I believe that we have a good chance of being able to do that, given that we have a reasonable spread of places to send our trainees, and I am very grateful for the fact that we in fact have a very large spread of nationalities among our trainees, as it will be one of the strengths of the new Organisation, that it is able to chose its inspectors, already from its inception, from such a wide range of nationalities from all regions of the world.

It is my intention, Mr Chairman, to run a scheme which does not subject any trainee to discrimination and which ensures that they all have the right quality of training. And in my negotiations with the Member States which are offering training I have been bearing that as the fundamental principle in mind."

- 13.7 The Commission **reiterated** that the training activities carried out by the Commission are activities under the purview of the Commission. Trainees from all Member States are entitled to enjoy equal treatment with regard to their participation. This understanding shall be included in the guidelines for the Secretariat in its selection of training facilities, and the Secretariat **was requested** to keep the Commission informed of any development on this issue.
- 13.8 The Commission **requested** the Executive Secretary not to enter into any agreement with any Member State which creates a list of countries to whose nationals training would not be offered.
- 13.9 The Commission further **requested** the Executive Secretary to circulate copies of all agreements entered into for training facilities to Member States of the Commission, in accordance with the Draft OPCW Confidentiality Policy.

14. AGENDA ITEM THIRTEEN - Date and Agenda of the Sixteenth Session

Under this Article the Secretary-General of the United Nations, in his capacity as Depositary of the Convention, is mandated to convene the First Session of the Conference of the States Parties within 30 days of the entry into force of the Convention. Since the 65th instrument of ratification was deposited with me on 31 October 1996, in accordance with Article XXI of the Convention, it shall enter into force on 29 April 1997.

The First Session of the Conference of the States Parties will open in The Hague on 6 May 1997. The first four days of the Conference shall comprise a high level segment which will include a general debate in the plenary.

A note verbale with information regarding administrative and logistical arrangements for the Conference shall be issued at an appropriate time by the Executive Secretary of the Preparatory Commission for the Organisation for the Prohibition of Chemical Weapons in The Hague.

The First Session constitutes an historic milestone in our collective endeavour to banish the scourge of chemical weapons for all time. I therefore look forward to the participation of your Excellency's government in this important event.

As indicated in the invitation, the First Session of the Conference of the States Parties will open in The Hague on 6 May 1997. The first four days of the Conference shall comprise a high level segment which will include a general debate in the plenary. A list of speakers for the general debate shall be opened at the Provisional Technical Secretariat in The Hague between 1 March and 29 April 1997. His Excellency's government is invited to inscribe itself in the list of speakers during this period.

It is requested that the name of the head of delegation, as well as the names of other members who will form part of the delegation of His Excellency's government, are transmitted to the Provisional Technical Secretariat of the Preparatory Commission for the OPCW not later than 30 days prior to the start of the Conference.

With regard to the credentials of heads of delegation to the Conference, these shall be addressed to the Secretary General of the United Nations and shall be deposited with the Provisional Technical Secretariat of the Preparatory Commission at least one week before the date fixed for the opening of the Conference. The credentials shall be signed either by the Head of State or Government, the Minister for Foreign Affairs, or any other authority acting on their behalf.

If a signatory State deposits its instrument of ratification of the Convention prior to 29 April 1997, the date of entry into force of the Convention, its delegation shall participate in the Conference as a State Party. States whose instruments of ratification or accession are deposited subsequent to the entry into force of the Convention shall acquire the status of a State Party, in terms of participation, in the Conference, on the 30th day following the date of deposit of their instrument of ratification or accession, in accordance with paragraph 2, Article XXI of the Convention.

The scope of participation of signatory and non-signatory States will be determined by the Rules of Procedure of the Conference. These are currently being drafted by the Preparatory Commission for approval by the Conference at its First Session.

The Provisional Technical Secretariat of the Preparatory Commission for the OPCW in The Hague will soon issue an Information Handbook to inform participating delegations of the detailed logistical and administrative arrangements for the Conference.
