INVITATION TO A REGIONAL IMPLEMENTATION WORKSHOP IN DUBROVNIK, CROATIA, 10 - 12 April 2000

- 1. The Government of the Republic of Croatia and the Technical Secretariat invite representatives of Member States, signatory States and the chemical industry to attend a regional workshop on the implementation of the Chemical Weapons Convention, to be held in Dubrovnik, Croatia, from 10 12 April 2000.
- 2. The workshop will provide a framework within which government officials from Member States who are involved in implementation, and representatives of the chemical industry, can discuss their experiences in implementing the Chemical Weapons Convention. Nominations from signatory States on behalf of candidates who will participate at their own expense are also encouraged. The number of places available for candidates from signatory States may be limited, however.
- 3. The provisional programme of the workshop is attached as annex 1. The detailed programme will be sent to all registered participants in a second circular, which will be issued by the end of February.
- 4. The Secretariat will be able to sponsor a limited number of participants from National Authorities or other government agencies of Member States in the wider region, on a first come, first served basis. The sponsorship will cover the costs of international travel, transfers between Zagreb and Dubrovnik, as well as accommodation in Dubrovnik. Sponsored participants will be informed separately about the terms and conditions of OPCW sponsorship.
- 5. Interested participants from Member States as well as signatory States are invited to submit their registration to the Secretariat using the attached form (annex 2) no later than 18 February 2000, together with an indication of whether sponsorship will be required.
